Social Services programs for the 2022-23 contract year from Human Services Staff, Leslie Isenberg, Social Services Supervisor, Derek Murray, Social Services Program Administrator, Maribel Ulloa, Social Services Program Administrator, and Dee Saunders, Social Services Specialist.

Commissioners thanked staff and the collaborative partners for their hard work, asked clarifying questions and highlighted the agencies' successes, including housing 80 unhoused community members.

B. HIV ZERO YEAR 6 EVALUATION

The Human Services Commission received the HIV Zero Year 6 Evaluation Report, presented by Derek Murray, Social Services Program Administrator. Additionally, Steven Bieneman, Associate Director of Testing Programs at the AIDS Healthcare Foundation (AHF), provided details on the proposed fixed testing site called "The Pod". A mobile HIV/STI testing and treatment service operating on extended 16-hour shifts for increased accessibility and convenience.

Commissioners asked clarifying questions and showed support for the Pilot Program.

ACTION: Motion made by Commissioner Williams, seconded by Commissioner Davis, and approved by roll call vote to support the proposal going to the City Council of dedicating parking spaces to the new AHF testing pod.

C. WEST HOLLYWOOD HOMELESS INITIATIVE: UPDATE ON THE FIVE-YEAR PLAN TO ADDRESS HOMELESSNESS

The Human Services Commission received an update from Francisco Gomez, Strategic Initiatives Program Administrator, on the City of West Hollywood's Five-Year Plan to Address Homelessness in Our Community, changes in regional homeless services, and program outcomes from city-funded non-profit agency partners.

Commissioners thanked staff and collaborative partners for their hard work, the qualitative data provided, and highlighted the success of housing 80 unhoused community members.

Vice-Chair Adolphson commended staff for their work. In addition, she shared her commitment to represent the commission at the upcoming City Council meeting. She also highlighted a volunteering opportunity taking place at West Hollywood Elementary on Saturday, January 13th, 2024.

Chair Eyres expressed gratitude to the staff for their comprehensive reports and extended appreciation to the agencies for their work.
