CITY MANAGER'S REPORT:

City Manager David Wilson invited the community to the WEHO 40 Strategic Plan Open House on Saturday, March 2nd from 11:00 a.m. to 2:00 p.m. at Kings Road Park to provide input on the City's next strategic plan. Senior Administrative Analyst and GARE Lead Erin Hamant provided the annual update on the City's GARE initiative.

SUBJECT: The City Council will consider approving the sponsorship of a public forum to raise awareness about the presence of Hepatitis C (HCV) in the community and Los Angeles County, how to prevent new infections, provide information about the availability of extremely successful treatments, and remove barriers to such treatments. In addition, this item directs staff to work with the County's Department of Public Health (DPH) and other community stakeholders to develop an initiative to reduce transmission and link up HCV+ individuals to treatments.

ACTIONS: 1) Approved the sponsorship of a public forum to raise awareness about the presence of Hepatitis C in the community and Los Angeles County, as well as prevention and treatment of the disease; 2) Directed City staff to work with Los Angeles County's DPH and other community partners to ensure information and resources are available to West Hollywood residents; 3) Directed staff to work with the Office of Supervisor Lindsey P. Horvath, DPH, community partners, and other cities to develop a Hep C Zero initiative, countywide; 4) Authorized the use of the City name and logo on invitations, programs, and other collateral materials for the event; 5) Directed the Communications Department to utilize all appropriate communication tools to promote the event including, but not limited to, the City's website, a news release, and social media; 6) Waived parking fees at the 5-story parking lot for up to 2 hours for up to 50 attendees, at a total cost of \$400; and 7) Authorized the Director of Finance and Technology Services to allocate \$1,900 from Fiscal Year 2022-23 funds in the Special Council Programs account number 100-1-01-00-531001 for costs associated with this event for technical support (Waveguide), moderator fees, and marketing materials. Approved as part of the Consent Calendar.

2.N. (6.C.) SUPPORT OF THE MATTHEW SHEPARD NATIONAL STAMP CAMPAIGN [J. ERICKSON, Y. QUARKER, A. LOVANO, J. DEL TORO, M. MÁRQUEZ]:

SUBJECT: The City Council will consider supporting the Matthew Shepard National Stamp Campaign organized by the International Court System's Imperial Court Council and supported by the Matthew Shepard Foundation.

3. PUBLIC HEARINGS:

3.A. APPEAL OF THE PLANNING COMMISSION'S APPROVAL TO DEMOLISH TWO DWELLING UNITS ON THREE ABUTTING PARCELS CONSTRUCT A NEW SEVEN-STORY, 89-UNIT. AFFORDABLE MULTI-FAMILY RESIDENTIAL BUILDING AND A THREE-LEVEL SUBTERRANEAN PARKING GARAGE AT 910-916 WETHERLY DRIVE INCLUDING A FINDING THAT THE PROJECT IS FROM CEQA UNDER CLASS 32 **CATEGORICAL** EXEMPTION FOR IN-FILL DEVELOPMENT PROJECTS (14 CCR § 15332) AND AFFORDABLE HOUSING EXEMPTION (14 CCR § 15194) [N. MARICICH, J. ALKIRE, A. CASTILLO, R. RATH]:

SUBJECT: This item is an appeal of the Planning Commission's adoption of Resolution No. PC 23-1534, which found the project to be exempt from CEQA under Section 15532 (In-fill Development Projects) and Section 15194 (Affordable Housing) and approved the demolition of all structures on three contiguous parcels, a lot merge of the three parcels, and the construction of an approximately 78,425 square-foot, seven-story, 89-unit, 100% affordable multi-family residential building over three levels of subterranean parking garage. The Planning Commission's approval also included three modifications for the 10% reduction of both side yard setbacks and the rear yard setback. The approved project utilizes a density bonus and concessions, pursuant to West Hollywood Municipal Code § 19.22.050 and the State Density Bonus Law, including Government Code section 65915.

Mayor Erickson opened the Public Hearing.

The City Council provided their disclosures.

City Clerk Crowder indicated that the Public Hearing was noticed as required by law.

Planning Manager Jennifer Alkire introduced Director of Community Development Nick Maricich and Associate Planner Roger Rath. Mr. Rath provided background information as outlined in the staff report dated February 20, 2024.

Councilmember Heilman inquired if private developers could be granted concessions as it related to inclusionary housing provisions and if concessions were considered modifications. Mr. Rath and Ms. Alkire responded. Additionally, City Attorney Langer noted that the State bonus density law was recently amended to add more density bonuses. She added that the project in question was approved for modifications, and that the new state law allowed for a 5th concession available to 100% affordable housing units like this project, confirming the standard was to use one concession for one modification.

Vice Mayor Byers inquired if the two modifications approved by the Planning Commission were standard use flexibility in line with the City's building code parameters. Mr. Rath responded.

Councilmember Meister posed a series of questions to City staff and the City Attorney regarding the CEQA requirements prior to the approval of AB 1633, concessions for non-residential parking, mutual agreement concerning environmental review, fault line review process, shade and shadow study and impacts on the historic property, dewatering, rooftop deck operational hours, traffic study, parking concerns, safety concerns with accessibility for the Fire Department, housing selection process, and income qualification process. Mr. Rath and Ms. Alkire responded to the development-related inquiries. Project Development Administrator Alicen Bartle responded to the inquiries related to the low-income housing selection process. City Attorney Langer clarified that the City bases decisions in line with current law. She stated that the modification made to AB 1633 in relation to CEQA guidelines was that it now allowed the developer to provide evidence of a CEQA exemption to the City for its review and determination. She also expanded on density bonus based on case law by the court of appeals.

Mayor Erickson inquired about the income threshold for this project and if the City's Urban Design & Architecture Studio worked with the developer on the building's design. Urban Design & Architecture Studio Manager Ric Abramson and Project Development Administrator Alicen Bartle responded.

APPELLANT TEAM:

MARTHA ORNELLA, spoke in favor of the appeal delineating various reasons to approve the appeal and deny the project. She stated that the City did not go through a thorough review process in line with seismic, geological, CEQA, and EIR standards and stated that this was an unsafe structure.

ARTHUR BERNSTEIN, stated this project was not categorically exempt from CEQA because it will not provide 100% affordable housing and spoke in opposition to the selection process by the developers.

APPLICANT TEAM:

The team provided a presentation of their proposed project.

JEFF SEYMOUR (Applicant), MICHAEL CONTENTO (Architect), JESSE SLANSKY (West Hollywood Community Housing Corporation President/CEO), and RYAN LEADERMAN (Counsel) stated that they are in favor of the conditions set by Planning Commission and expressed their desire to collaborate with the City to ensure this project is successful.

Mayor Erickson closed the Public Hearing.

Councilmember Heilman thanked the speakers for their respectful demeanor during the Public Hearing and commented on the legal parameters on how they operate, noting that the City Council did not have a lot of discretion. He commented that the only area where the City Council has discretion is on the modifications, and they do not have an adverse impact. He spoke in support of staff's recommendation and in opposition of the appeal based on State law.

Councilmember Meister stated that there should have been further CEQA studies conducted, expressing concerns with the potential dangers of dewatering, subsidence, the seismic fault, and traffic. She questioned the validity of the concession to allow non-residential use of the subterranean

garage. She noted that granting the three discretionary modifications was unnecessary because the project's architect knew about the earthquake fault when they designed the project. She stated that it could have been a better project by moving the one residential unit, the laundry room and office onto the lower floors. She noted the 26% reduction of open space and how the rooftop could have been better utilized for that purpose. She commented that she supports the appeal in part.

Councilmember Shyne also thanked the speakers, commented on the restrictions the City Council has to consider the project, and stated that she would like for the selection process of applicants for the rental units to be West Hollywood residents or individuals who work in West Hollywood.

Vice Mayor Byers also stated that the setbacks would have minimal impacts, and CEQA exemptions were not sufficient.

Mayor Erickson thanked the speakers and spoke in support of staff's recommendation to deny the appeal. He also supports giving preference to West Hollywood residents and people who work in the City for the rental units.

Planning Manager Jennifer Alkire stated that the following language would be inserted into the resolution to clarify the selection process:

Condition 3.5 the operator shall give priority to individuals who live or work in the City of West Hollywood as feasible and in accordance with our housing laws.

ACTION: The City Council held a public hearing, considered all pertinent testimony, denied the appeal, and affirmed the Planning Commission's decision by adopting Resolution No. 24-011: "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DENYING AN APPEAL FILED BY ARTHUR BERNSTEIN, MARTHA ORELLANA, AND **JOSEPH** DICKSTEIN **AND AFFIRMING** THE **PLANNING** COMMISSION'S APPROVAL OF Α DEMOLITION PERMIT. DEVELOPMENT PERMIT, A LOT MERGER TO COMBINE THREE CONTIGUOUS PARCELS, AND THREE MODIFICATION REQUESTS TO DEMOLISH ALL STRUCTURES ON-SITE AND CONSTRUCT A NEW, SEVEN-STORY, 89-UNIT, 100% AFFORDABLE MULTI-FAMILY RESIDENTIAL BUILDING OVER THREE LEVELS OF SUBTERRANEAN PARKING, AND ISSUE APPLICABLE DENSITY BONUS CONCESSIONS ON THE PROPERTY LOCATED AT 910-916 WETHERLY DRIVE, WEST HOLLYWOOD, CALIFORNIA AND UPHOLDING THE DETERMINATION THAT THE PROJECT IS EXEMPT FROM CEQA UNDER A CLASS 32 CATEGORICAL EXEMPTION FOR IN-FILL DEVELOPMENT PROJECTS (14 CCR § 15332) AND AFFORDABLE HOUSING EXEMPTION (14 CCR

§ 15194)." Motion by Heilman, seconded by Shyne, and approved (4/1), noting the "no" vote of Councilmember Meister.

SUBJECT: The City Council will consider a Resolution approving the purchase of real property located at 148 N. Swall Drive in the City of West Hollywood.

Councilmember Meister mentioned the correspondence submitted by Victor Omelchenko and inquired about the purchase price of this property. She also requested that the property be used as green space.

Director of Public Works Steve Campbell shared that the City worked with an agent and the property is comparable, noting that the property is zoned for both residential and commercial development.

Councilmember Heilman spoke in agreement with Councilmember Meister's comment to utilize it as green space until it is developed.

Mr. Campbell stated that staff would bring an item for Council consideration to explore options for the lot.

6.B. HEPATITIS C: PUBLIC FORUM - HOW TO GET TO ZERO CASES OF HEPATITIS C [J. ERICKSON, Y. QUARKER, A. LOVANO, H. MOLINA, M. WATSON]:

SUBJECT: The City Council will consider approving the sponsorship of a public forum to raise awareness about the presence of Hepatitis C (HCV) in the community and Los Angeles County, how to prevent new infections, provide information about the availability of extremely successful treatments, and remove barriers to such treatments. In addition, this item directs staff to work with the County's Department of Public Health (DPH) and other community stakeholders to develop an initiative to reduce transmission and link up HCV+ individuals to treatments.
