- Would like to see grants or economic opportunities for marginalized community members (similar to those mentioned in the Social Justice Task Force recommendations) to generate self-sufficiency (co-ops, homeownership, doesn't have to be limited to one model etc.)
- How do Non-binary and Trans-folk get more involved in crafting or enacting legislation? This includes enforcement of policies (For example SB 396 training for employers to be up to date on how to hire trans, non-binary, or gender non-conforming people) California Department of Fair and Housing might be the agency responsible for enforcement.
- Would like the Legislative Priorities to incorporate the Social Justice Task Force recommendations as a guide to implement social justice related policy recommendations
- Interest in an examination into the housing and lottery system as it relates to conditions for funding.

E. REVIEW OF SOCIAL JUSTICE TASK FORCE RECOMMENDATIONS AND DISCUSS AND PROPOSE SCHEDULE FOR DIVISION/DEPARTMENT UPDATES AT FUTURE SOCIAL JUSTICE ADVISORY BOARD MEETINGS

Chair Wilson brought forth a motion to have more frequent Advisory Board meetings and meet more than once a quarter.



The Social Justice Advisory Board will receive an update on the development of the City of West Hollywood's Strategic Plan and provide feedback related to the preliminary themes.

1. History

In 1990, the City adopted its Vision 2000 Strategic Plan, which included the City's Mission Statement, Core Values, and Strategic Goals, and provided the blueprint of the City's programs, services, and resource allocations for the following decade. Building on the successes of Vision 2000, Vision 2020 was adopted in the early 2000s and focused on

key areas such as economic development, public safety, and sustainability for the next 20 years.

At its October 16, 2023 meeting, the City Council approved agreements for services with Gensler, Designing in Color, and Fairbank, Maslin, Maullin, Metz & Associates (FM3) to develop a new, inclusive Strategic Plan for the City's future. The City Council also directed staff to meet with the Social Justice Advisory Board to receive input regarding the Strategic Plan.

WeHo 40 is the City's forward-looking strategic planning process. Rooted in 40 years of municipal history, and looking ahead toward 2040, WeHo 40 has begun the process of engaging with residents, community members, and local businesses in setting priorities to create an inclusive and equitable roadmap for the City's future and build upon the successes of the City's past strategic plans.

2. Project Update

Since the City Council's approval, the project team has been developing the foundation for a robust community engagement process. The following actions have been completed by the project team:

- Launched the project webpage. Using the City's new communication platform, the WeHo 40 webpage serves as the primary digital engagement tool for sharing project news and updates (engage.weho.org/wehostrategicplan).
- Conducted four community focus groups. The project team conducted four two-hour-long focus groups to discuss resident assessments of the City's strengths and weaknesses. Three focus groups each consisted of 10 West Hollywood residents and were separated into geographic cohorts (Eastside: live east of Fairfax Ave.; City Center: live between La Cienega Blvd. and Fairfax Ave.; Westside: live west of La Cienega Blvd.). One focus group consisted of 9 West Hollywood residents who identify as LGBTQ+.
- Conducted eight project listening sessions. The project team conducted small-group interviews of community members and City staff to begin the discovery process of identifying public and agency-specific priorities, opportunities, and

challenges facing City communities.

- Formed the Action Team. A group of six West Hollywood community ambassadors were recruited to focus on growing the project's visibility, gathering input, and providing updates and information throughout the community. This team is required to attend three community events, six Action Team meetings, and promote the project digitally and in person.
- Formed the Core Coalition. A group comprised of community-based organizations and individuals was formed to informally guide the overall process of the project through completion.
- Conducted the first of two Community Surveys. The project team conducted a
 random, statistically significant 15-minute survey with a sample of 400 community
 members in English, Spanish, and Russian to measure resident sentiment on key
 City issues and priorities.

3. Preliminary Themes

The project team is requesting the Social Justice Advisory Board's feedback on the following preliminary themes. The preliminary themes have emerged from the discovery and existing conditions exploration work conducted to date, including the community focus groups, initial listening sessions, and first community survey, as well as discussion with community members during the formation and initial meetings of the Action Team and Core Coalition. As the project continues through the planning process, feedback from the Social Justice Advisory Board will be incorporated into the refinement of the preliminary project themes and descriptions.

- Attainable Housing: Addressing impacts of rising housing costs, lack of affordable housing, displacement, and related concerns across different communities.
- Mobility: Understanding and addressing changing needs related to transit and transportation, as well as the desire for and use of streetscape improvements, public realm enhancements, and pedestrian and non-motorized mobility infrastructure.

- **Safety & Wellbeing:** Understanding resident, employee, and visitor safety concerns, differences in perceptions and experiences of safety, and the services and policies needed to support and enhance community health and wellbeing.
- Inclusivity: Broadening the scope of considerations required for good governance
 with a focus on City-led actions and investments related to places and projects,
 services and programs, and policymaking, and their impacts on traditionally
 marginalized and/or underserved communities.
- **Economic Development:** Examining the impacts of the City's prior and current approach(es) to supporting economic growth, with a commitment to improving the City's economic environment while also focusing on supporting equitable outcomes and mitigating negative externalities.
- **Environmental Stewardship:** Supporting the City's commitments to climate action planning and sustainability and examining actions and impacts in the context of broader strategic priorities.
- Transparency & Engagement: Exploring methods and tools for advancing transparency and accountability in governance and decision-making, while engaging in productive, constructive community collaboration.
- Social Cohesion: Understanding the drivers of social cohesion specific to West Hollywood communities and how the City can be a more active contributor to community connection.

4. Project Schedule & Next Steps

The strategic planning process is scheduled to be completed by August 2024; specific tasks are outlined in the table below.



WHAT IS THE ACTION TEAM?

The Action Team's main responsibility is to grow the project's visibility within the community and be the first line of feedback. They are the eyes and ears on the street and will be gathering input as well as providing updates and information throughout the community.

WHAT IS THE CORE COALITION?

The Core Coalition will be made up of community-based organizations and individuals who will informally help guide the overall process of the project through feedback and community engagement. We want have as many perspectives represented and centered in the planning process of this project.

WEHO RESIDENTS PRIZE THE CITY'S HIGH QUALITY OF LIFE BUT ARE CONCERNED ABOUT ITS CURRENT TRAJECTORY

- Participants appreciated that West Hollywood is a diverse and welcoming community as well as its proximity to shopping and activities.
- Crime, homelessness, cost of living and housing, and the loss of local small businesses and community character were mentioned repeatedly across all groups as top concerns.


Some people felt that it was inappropriate to develop additional housing for lower-income people who do not live in the city now, while current residents struggle to afford the cost of rent... [and would like the City to take] action to contain housing costs for existing residents [rather than focus on] building of more housing.

When specifically probed, just a handful of participants felt that any groups are **ignored or underserved** by the City. Different groups were mentioned by one or two participants, including **persons experiencing homelessness** or those suffering from **mental illness**, **children**, **residents east of Fairfax**, **lower-income** people, and members of the **Russian community**.

CITY & COMMUNITY LEADERS SHARE THE SAME FOUNDATIONAL DESIRES BUT NOTE A LACK OF UNIFYING PRIORITIES

- City and community leaders often expressed similar **foundational desires** like high quality of life and livability, but major gaps in **perceptions** and awareness are a major challenge.
- Economic and socioeconomic realities like **high cost of living** contribute further **divergence in priorities** and **declining social cohesion**.


