**A. Santa Monica Boulevard Protected Bicycle Lanes Feasibility Study Update**

**Bob Cheung** presented an update on the Santa Monica Boulevard Protected Bicycle Lanes Feasibility Study.

**Commissioner Wentzel**

- Not in favor of harming transit for bike lanes.
- Inquired about possible bump indicators
- Requested clarification of the history route 66 pedestrian and streetcar traffic
- Confirming the study is not ruling out bike lanes on the east side of Santa Monica Boulevard.

**Commissioner Darvish**

- Questioned if the parallel streets to Santa Monica Boulevard were studied for possible additional bike lanes.

**Commissioner Eichman**

- Inquired on the process for the volume count on bicyclist and if scooters are included in count.

**Chair Kroll**

- Requested clarification on contracts with consultants.
- Inquired about raised bike lanes as possibility.
- Inquired about looking into data of removing bike lanes increases business commerce.

**Commissioner Harris**

- Asked for clarification on a presentation slide of a bike lane on north or south side and median work affects.
- Inquired about loading/unloading zones, ride share zones and current outdoor dining applications.
- Inquired if this construction will coincide with Metro construction alongside Santa Monica Boulevard and impacts.

## **B. Fountain Avenue Protected Bicycle Lanes Study Update**

**Bob Cheung** presented an update on the Fountain Avenue Protected Bicycle Lanes Study Update.

- Inquired on working with Los Angeles about reduction of parking since on the border between the two cities.
- Asked for clarification on road reduction on Fountain and if reversible will even be possible and how impacted the road congestion will be.

### **Commissioner Darvish**

- Spoke in favor of the study
- Inquired if research was done by looking at other cities with space limitations and raised platform for cars.

### **Commissioner Wentzel**

- Spoke in favor of the study and on the importance on lowering the speed on Fountain.
- Inquired if Fountain would be possible for the speed cameras.
- Inquired about adjustments being made during the study's pilot build.

### **Commissioner Harris**

- Spoke in favor of the study.
- Asked for clarification of phase one being the study's pilot and its elements.
- Asked for clarification on what standards the study's pilot is using to determine success or failure.
- Inquired on home and parking ratio along Fountain.

### **Chair Kroll**

- Spoke in favor and importance of the study.

### **Commissioner Bazley**

- Inquired about LA's vision for Fountain in terms of bike lanes and infrastructure.

### **PUBLIC COMMENTS:**

**Peter Spirer**, West Hollywood Bicycle Coalition, spoke in support of the study. Commented importance to know if cut through traffic will be reduced, the city should monitor traffic origin and destination during phase one of pilot. Information on what will be a quick build and permanent in phase one of pilot and that a presentation be made to the Disabilities Advisory Board for ADA compliancy with the sidewalks.


