8. <u>NEW BUSINESS</u>

A. FY24-26 BIENNIAL CAPITAL BUDGET RECOMMENDATIONS

SUBJECT: The Commission will receive an overview of the biennial budget process and consider the recommendations made by the Budget Standing Subcommittee for the FY24-26 biennial budget for Capital Improvement Projects.

Staff introduced the item and provided an overview of the budget process.

Chair Solomon asked for clarification on the timeline of when the Facilities Division recommendations will be submitted to the City Council Finance & Budget Subcommittee. Staff provided clarification.

Staff went over the Recreation items on the Budget Standing Subcommittee list of recommendations.

Commissioner Jackson asked for clarification on the Plummer Park Basketball Court & Pickleball item. Jackson asked about the costs associated with the Plummer Park and West Hollywood Park electronic message boards. Staff provided clarification on the items.

Commissioner Payton asked if the public's requests for more space at the Aquatics changing rooms were considered during the Budget Subcommittee's discussion. Staff is working with the City Architect team to determine what is feasible. Payton asked if there will be a collaboration with the Arts Commission for the West Hollywood Park gym mural. Staff shared that the project will be under the Recreation team.

Commissioner Mason commented that the Tennis Court fencing at Plummer Park should be prioritized. He spoke in favor of the city's courts being mixed use.

Vice Chair Karliss asked if utilities were mistakenly left out of the budgeted amount for the West Hollywood Park flex space. Staff replied that it was not a mistake. Karliss commented on the Plummer Park Basketball Court & Pickleball item and is in favor of keeping it a dual space. He asked for clarification on the Signs & Wayfinding item. Staff provided clarification. Karliss would like to see the Electronic Messaging Boards item brought back to the Commission for discussion once the budgeting is approved.

Chair Solomon inquired if there would be a need for a bathroom in the West Hollywood Park Flex Space. Staff provided a response. Solomon commented on the Plummer Park Basketball Court & Pickleball item and expressed concern with water accumulating on the court after it rains. He suggested putting fencing or DG around the area.

PUBLIC COMMENT:

Xen Tara, WEST HOLLYWOOD, commented on the prioritization of items. Xen spoke about options to improve safety at Plummer Park courts 6 & 7.

Commissioner Krishna spoke in favor of keeping things mixed use.

Commissioner Payton spoke in favor of keeping things mixed use.

Commissioner Jackson would like to prioritize Citywide Court Resurfacing, Plummer Park Tennis Court LED Lighting, Plummer Park Tennis Court Fencing, and Plummer Park Alternative Restrooms.

Commissioner Ragno would like to prioritize the Plummer Park Tennis Court LED Lighting and Citywide Court Resurfacing.

Commissioner Mason commented on the Citywide Court Resurfacing item. He spoke in favor of the Water Polo Netting item.

Staff commented that the Citywide Court Resurfacing item can be moved to the Division's capital maintenance budget request.

Vice Chair Karliss spoke in favor of the priority list that the Budget Standing Subcommittee put together. He will defer to the Commission's decision on whether to move the Citywide Court Resurfacing item.

Chair Solomon spoke in favor of the budget recommendation letter. He suggested indicating what the costs will be for Plummer Park and the costs for West Hollywood Park. Solomon spoke about the Plummer Park Alternative Restrooms item. He would like to keep the Court Resurfacing item on the list and add pickleball lines to make the courts dual use. Solomon spoke about increasing the amount being requested for the Plummer Park Basketball Court & Pickleball item.

The Commission discussed increasing the amount requested for the Plummer Park Basketball Court & Pickleball item and changing the name to Plummer Park Multipurpose Court.

The Commission discussed the Citywide Court Resurfacing item.

ACTION: Approve the Commission's budget recommendation letter with the following amendments to be presented to the City Council Finance & Budget Subcommittee & to the City Council: 1) Move Plummer Park Alternative restrooms as a standalone item in response to previous council direction to review alternative restrooms for Plummer Park; 2) Increase the funding for Plummer Park Basketball Court & Pickleball from \$80,000 to \$120,000; 3) Remove "if possible" from Plummer Park Basketball Court & Pickleball item; and 4) Add language to Citywide Court Resurfacing item to include "assessment for potential multipurpose uses."
