CITY MANAGER'S REPORT:

City Manager Wilson announced April as Earth Month and shared that the City will be promoting efforts to support its 2035 Carbon Neutrality goal and share information on Climate Action initiatives to elevate community awareness in City programs and policies related to sustainability. Additionally, he announced that the City launched the Green Business Certification Program to help businesses with their sustainability implementation measures and stated that the City was recently awarded \$200,000 from

Metro's Transit Oriented Communities Technical Assistance Program to help with the feasibility study to explore the establishment of a transit-oriented development bonus program.

- 6.C. EMISSION CONTROL DEVICES FOR COMMERCIAL OVENS [J. ERICKSON, Y. QUARKER, A. LOVANO, M. WATSON]:

 SUBJECT: The City Council will consider directing staff and the City Attorney's office to evaluate a potential new requirement to install

> emission control devices on commercial ovens. The evaluation will include an analysis of existing local and state laws, current regulatory requirements, and the extent to which emission control devices would control pollutants.

ACTION: This Item was moved to the Consent Calendar.

6.D. DEVELOPMENT OF A CITY POLICY REQUIRING SUSTAINABLE AND CLIMATE-FRIENDLY FOOD CHOICES FOR CITY PRODUCED EVENTS [C. BYERS, Y. QUARKER, A. LOVANO, H. MOLINA, M. WATSON]:

SUBJECT: The City Council will consider directing staff to draft a policy mandating all City produced events in which food/refreshments are provided serve plant-based food/refreshments by default, which would require allowing people to opt into food/refreshments with animal products.

Councilmember Meister requested that an educational component be added to this Item. She spoke in opposition to making plant-based options as a default and in support of a hybrid option.

Vice Mayor Byers stated this policy was not geared towards making plantbased food the only choice but rather a helpful nudge.

Councilmember Heilman spoke in support of the Item noting that the City would continue to offer catering options.

ACTIONS: 1) Directed staff to draft a City policy requiring that when City-produced events serve food/refreshments, the food/refreshments shall be plant-based by default, allowing people to opt into food/refreshments with animal products; and 2) Staff to report back to the City Council in sixty (60) days with draft policy and Resolution with the inclusion of an educational component. Motion by Vice Mayor Byers, seconded by Councilmember Heilman, and approved (5/0).

6.E. APPOINT THE MAYOR AS CITY'S REPRESENTATIVE TO ACCEPT THE HANDOFF OF THE TORCH FOR PRIDE HOUSE IN PARIS, FRANCE, AND APPROVAL OF INTERNATIONAL TRAVEL [J. ERICKSON, Y. QUARKER, A. LOVANO]:

SUBJECT: The City Council will consider appointing the Mayor as the City's representative to accept the handoff of the torch for Pride House and approve international travel for the Mayor to Paris, France.

Mayor Erickson provided an overview noting it was a request.

The following speakers came forward to speak:

ALAN STRASBURG, WEST HOLLYWOOD, spoke in opposition of this item. His public comment was spoken in French without translation.

SHAMEY CRAMER, WEST HOLLYWOOD, requested that this item be tabled to provide additional Pride information to better represent the City of West Hollywood's sports component.

NIK ROYBAL, WEST HOLLYWOOD, spoke regarding the optics of this trip, inquired why this City did not partner with City of LA's Paris trip, and requested the Mayor conduct daily vlogs from Paris.

DANNY HANG, WEST HOLLYWOOD, spoke in support of this item.

Councilmember Meister spoke in opposition to this Item noting these trips were not geared for Councilmembers but rather delegates and requested that the Visitor and Marketing Bureau be designated to attend this trip at their own expense.

Councilmember Shyne stated that the difference between Los Angeles and West Hollywood is that the City of West Hollywood is the LGBTQ+City who represents Pride and spoke in support of this Item. She requested that the delegation meet with the City's sports teams.

Councilmember Heilman provided additional information as to the request noting that the City of West Hollywood is the likely destination and location for a Pride House not just for the Olympics. He noted his support for this Item and requested that the City Manager research forming a committee for these types of requests in the future.

Vice Mayor Byers spoke in support of the Item and in appreciation for the Mayor's willingness to travel on the City's behalf.

Mayor Erickson spoke on the transparency of this Item and the significance of this trip.

ACTIONS: 1) Approved Mayor Erickson as the City's representative to accept the handoff of the torch for Pride House in Paris, France; and 2) Approved Mayor Erickson's international travel to Paris, France. Motion by Mayor Erickson, seconded by Vice Mayor Byers and approved (4/1), noting the "no" vote of Councilmember Meister.

6.F. SPONSORSHIP OF A SUSTAINABILITY TOWN HALL IN PARTNERSHIP WITH ATHENS SERVICES [C. BYERS, Y. QUARKER, A. LOVANO, J. DEL TORO]:

SUBJECT: The City Council will consider sponsoring a Sustainability Town Hall in partnership with Athens Services. The town hall will focus on zero waste and implementation of California's new law related to organic waste (Senate Bill 1383).

ACTION: This Item was moved to the Consent Calendar.

EXCLUDED CONSENT CALENDAR: None.

PUBLIC COMMENT:

TODD ELLIOT, WEST HOLLYWOOD, spoke in support of Item 6.E., and commented on the difficulties faced by developers to complete housing/affordable housing projects. He requested that the City ease punitive fines for developers.

COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Meister noted her "no" vote on Item 2.G., and requested that on Consent Calendar 2.I., the City consider using the office suite on 8305 Santa Monica Boulevard at Sweetzer Avenue for Public Safety Officers and requested clarification on the completion of the Melrose design portion concerning the District Streetscape Project. She reported her attendance at the Purim Celebration at Cola Me, the West Hollywood Women in Leadership Awards and reception and announced upcoming City events.

Councilmember Shyne reported her attendance at the St. Mary's International Women's Day event and requested that the City Manager contact Todd Elliot concerning comments to a delayed development.

Vice Mayor Byers reported her attendance at the Contract Cities General Board Meeting, the League of California Cities Transportation Communication and Public Works Committee Meeting, and the Los Angeles County Affordable Housing Solutions Agency Board Meeting. She thanked all speakers, wished everyone a happy Earth Month and thanked her colleagues for supporting items to continue the City's goal in reducing food waste.

Mayor Erickson thanked Eric and Ricky for their comments and efforts concerning emissions, requested staff review bollards on Lexington and Gardner to facilitate street cleaning. He reported his attendance at the Freedom of Fire screening, the WEHO Pride Subcommittee Meeting, the Drag Artist Roundtable, the Contract Cities March Board Meeting, the Community Services Policy Committee Meeting, presented a Proclamation for Save Soil Day, attended the Budget Subcommittee Meeting, American Diabetes Association LA Roast, the Legislative Briefing for Local Housing Champion, the Purim Celebration at Cola Me, presented a Proclamation to the honorees at Celebration Theatre Honors Gala, attended a reception with the Quebec Minister Martine Biron, the Clean Power Alliance Legislative and Regulatory Subcommittee Meeting, the West Hollywood Women in Leadership Award Reception, the LA County Local Advocacy Day with Contract Cities, the Denim Day Celebration, Coffee with the Mayor event, and presented Deborah Kallick with a commemoration on her retirement from Cedars Sinai Medical Center, and announced his future travel to Sacramento to advocate for AB 2402 on the City's behalf and commented on a letter sent to the Mayor of Los Angeles concerning helicopter noise.
