A. Sustainability Committee August 2010 Meeting Notes:

Update on the County of Los Angeles Conversion Technology Project

Pat Proano, Asst Depty Director, L. A. County Dept. of Public Works, Environmental Programs, assisted by Tobie Mitchell, Sr. Civil Eng Asst, provided an update on the County Conversion Technology Project. The County has the largest, most complex solid waste management system in the country. Proactive sustainable solutions are vital to the environmental challenge. Conversion technologies turn solid waste into useful products, e.g. green fuels and clean, renewable electricity [non-incineration processes].) Successful around the world, there are no commercial facilities in the U.S. at this time.

Phase I evaluated conversion technologies around the world, and identified local MRFs (material recovery facilities) and transfer stations as candidates. Phase II screened and ranked the findings to develop a short list of four technologies and four sites.

In April, 2010, the County Board of Supervisors unanimously approved a motion to advance the County's conversion efforts, approving memos of understanding and contracts for demonstration projects. Phase III will identify funding alternatives, resolve permitting issues and sort "fact from friction" (i.e., dispelling misconceptions about the technology) to implement demonstration projects. Phase IV would be the development of commercial projects to reduce County dependence on land-fills.

SB375, Sustainable Communities Strategy and climate Protection Act
LARC's preliminary recommendation is for the SCAG region to seek 13% reduction in regional green house gas emissions rather than the 5-6% recommended by SCAG.

Staff quickly summarized the memorandum describing the committee's proposed work plan, which is divided into action and informational items, but there was no time for review or discussion.

B. Homeless Committee August 2010 Meeting Notes:

The committee discussed the Cold Weather Shelter program which will begin again on December 1, 2010. There are many challenges that must be met with respect to pick-up and drop-off to maximize the use of the facilities. The brainstorming brought many issues into focus that will need to be further

addressed. The Winter Shelter Program item will be included on the October Homeless Committee Agenda.

The Committee recommended that the Board consider renaming the Committee "Homelessness and Social Services Issues Committee" to better reflect the Committee's work activities with respect to issues that impact homelessness.
