No person shall address the Board without first being recognized by the Presiding Officer.

Each person addressing the Board shall do so in an orderly manner and shall not make repetitious, slanderous or irrelevant remarks, or engage in any other disorderly conduct which disrupts, disturbs or otherwise impedes the orderly conduct of the Commission meetings. Any person who so disrupts

the meeting may, at the discretion of the Presiding Officer or a majority of the Board, be subject to ejection from that meeting.
