MINUTES

- 1. CALL TO ORDER: Vice Chair Tina Moore called the meeting to order at 7:02 p.m.
- 2. PLEDGE OF ALLEGIANCE: Commissioner Bass led the Pledge of Allegiance.
- 3. ROLL CALL: Rent Stabilization Commission Secretary Roger Vinalon Jr. took roll call.

PRESENT: Commissioner Adam G. Bass, Commissioner Josh Kurpies, Commissioner Frank D. Rorie Jr., Commissioner Agassi Topchian, and Vice Chair Tina Moore

ALSO PRESENT: Rent Stabilization Manager Cameron Kesinger, Rent Stabilization Supervisor Gloria Aviles, Legal Counsel John Natalizio, Governmental Affairs Liaison Hernan Molina, and Rent Stabilization Commission Secretary Roger Vinalon Jr.

4. APPROVAL OF AGENDA

ACTION: Approve the agenda of June 13, 2024 as amended. Motion by Commissioner Rorie to approve the June 13, 2024 agenda, seconded by Commissioner Bass and approved.

5. APPROVAL OF MINUTES

ACTION: Approve the minutes of May 23, 2024. Motion by Commissioner Topchian, seconded by Commissioner Rorie and approved, noting the abstentions by Commissioner Kurpies and Vice Chair Moore.

- 7. MANAGER REPORT: New Rent Stabilization Manager Cameron Kesinger thanked Rent Stabilization Supervisor Gloria Aviles for her service as Acting Manager over the prior six months, introduced himself, and reviewed the look-ahead calendar.

8. **NEW BUSINESS**

A. Presentation on the Justice for Renters Act

SUBJECT: The Rent Stabilization Commission will receive a presentation on the Justice for Renters Act outlining the City's legislative work and advocacy efforts.

Governmental Affairs Liaison Hernan Molina spoke on the Justice for Renters Act and its potential impacts on the Costa-Hawkins Act and rental market.

Commissioner Topchian inquired about the Act's impact on Assembly Bill 1482. Mr. Molina indicated that it would provide local jurisdictions with increased control of their rental rates.

Rent Stabilization Commission Meeting Minutes – June 13, 2024

Commissioner Bass inquired about Assembly Bill 2216. Mr. Molina explained that the bill would limit landlords from prohibiting common household pets in residential tenancies and mentioned that West Hollywood would support the bill.

Vice Chair Moore inquired about Assembly Bill 2584. Mr. Molina explained that it would limit companies to owning no more than 1,000 single-family homes.

ACTION: Receive and file.

VICTOR OMELCZENKO, WEST HOLLYWOOD spoke on the Los Angeles LGBTQ Center housing lottery for senior affordable units and proposed the City's inclusionary housing waitlist be reopened.

Chair Zekiah Wright joined the meeting at 7:33 p.m.

9. APPEAL:

A. D-4527CD3 1279 N. Harper Avenue #3

Legal Counsel to the Commission John Natalizio provided a case summary and analysis of the appeal as provided in the staff report.

LYNN LEMAY, WEST HOLLYWOOD presented her oral argument.

DANIEL MONGE presented his oral argument.

After Commission deliberation, a motion was made by Vice Chair Moore to adopt RSC Resolution 24-650 affirming the Hearing Examiner's Decision as to application No. D-4527CD3. The motion was seconded by Commissioner Topchian and passed with a vote of 6-0.

10. UNFINISHED BUSINESS

A. Resolution RSC 24-649 (D-4864)

SUBJECT: The Rent Stabilization Commission ordered staff to return with an updated Resolution RSC 24-649 to reverse-in-part and remand-in-part the Hearing Examiner's Decision regarding application No. D-4864.

ACTION: Motion by Commissioner Bass to approve Resolution RSC 24-649, seconded by Chair Wright and approved with a vote of 3-1, noting the abstentions by Commissioner Kurpies and Vice Chair Moore.

11. ITEMS FROM STAFF: Ms. Aviles expressed her appreciation for the Commission and the opportunity to serve as Acting Manager over the prior six months.

12. PUBLIC COMMENT

LYNN LEMAY, WEST HOLLYWOOD spoke on the evidence considered in the D-4527CD3 appeal.

VICTOR OMELCZENKO, WEST HOLLYWOOD spoke on Assemblymember Laura Friedman's comments regarding the Justice for Renters Act and proposed a briefing also be provided to the LGBTQ+ and Human Services Commissions.
