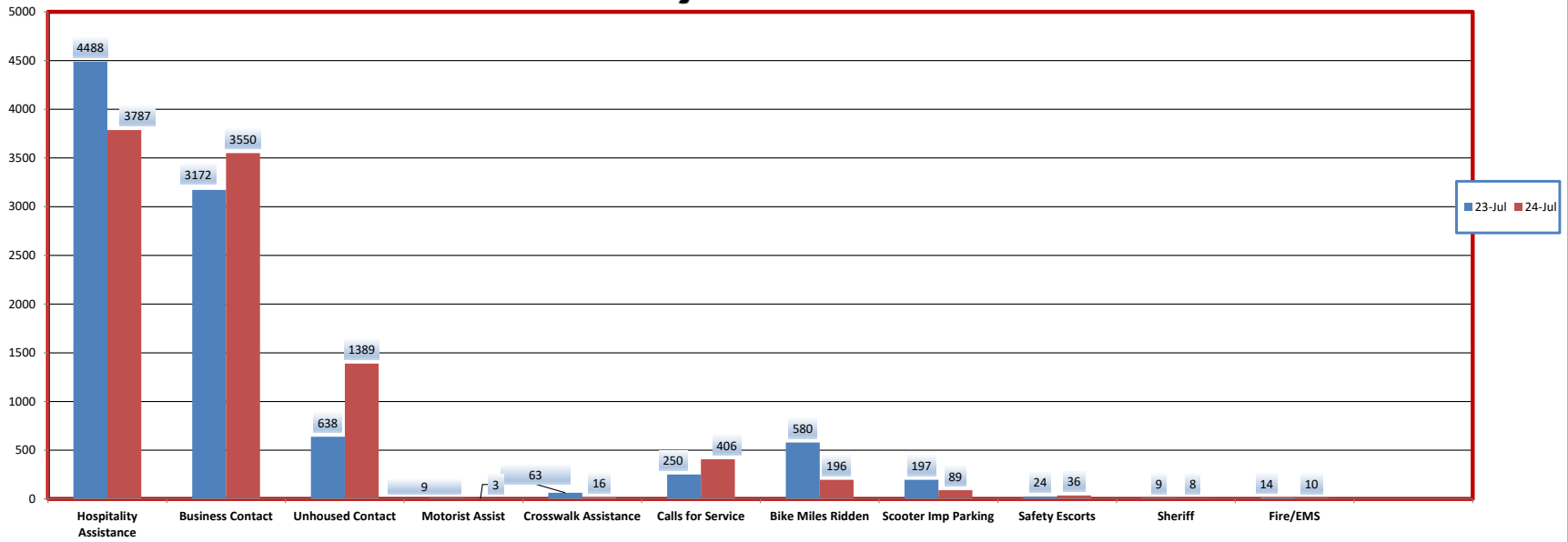
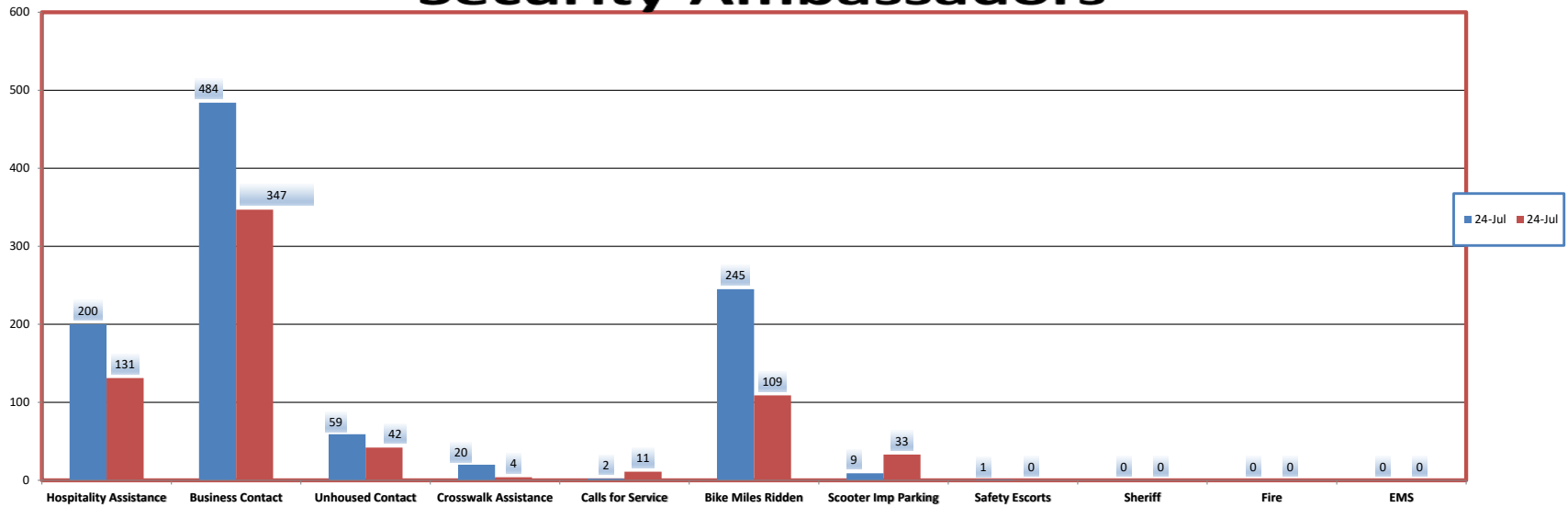

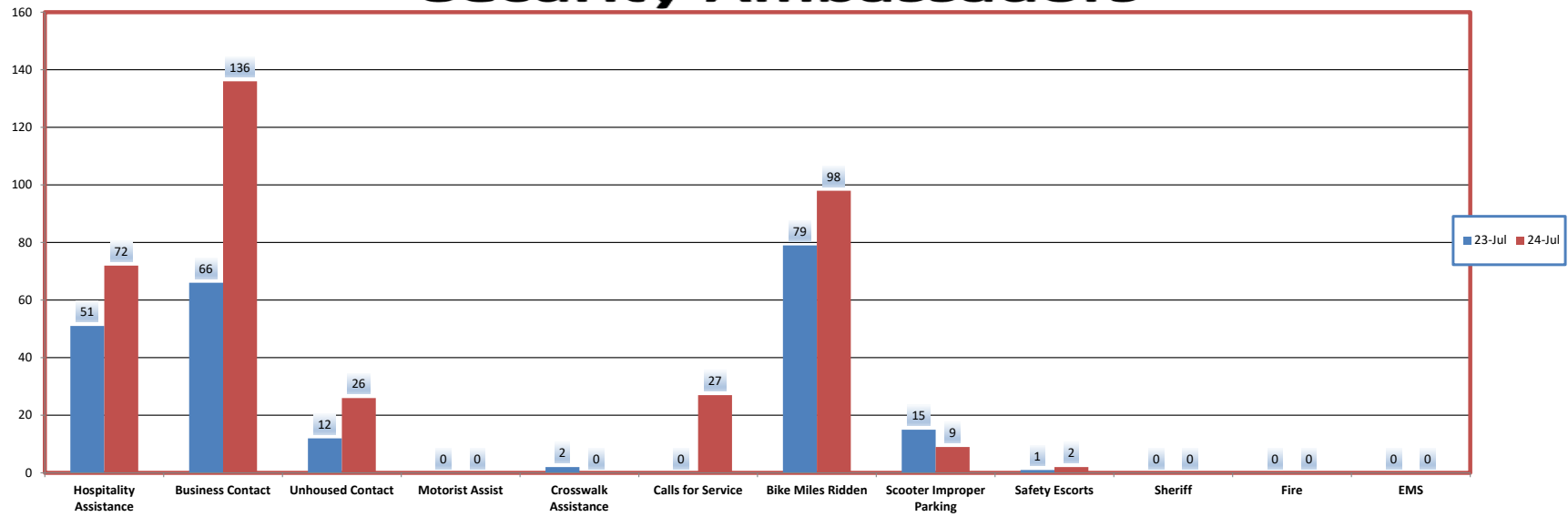
Santa Monica Blvd. - JULY '23 vs. JULY '24

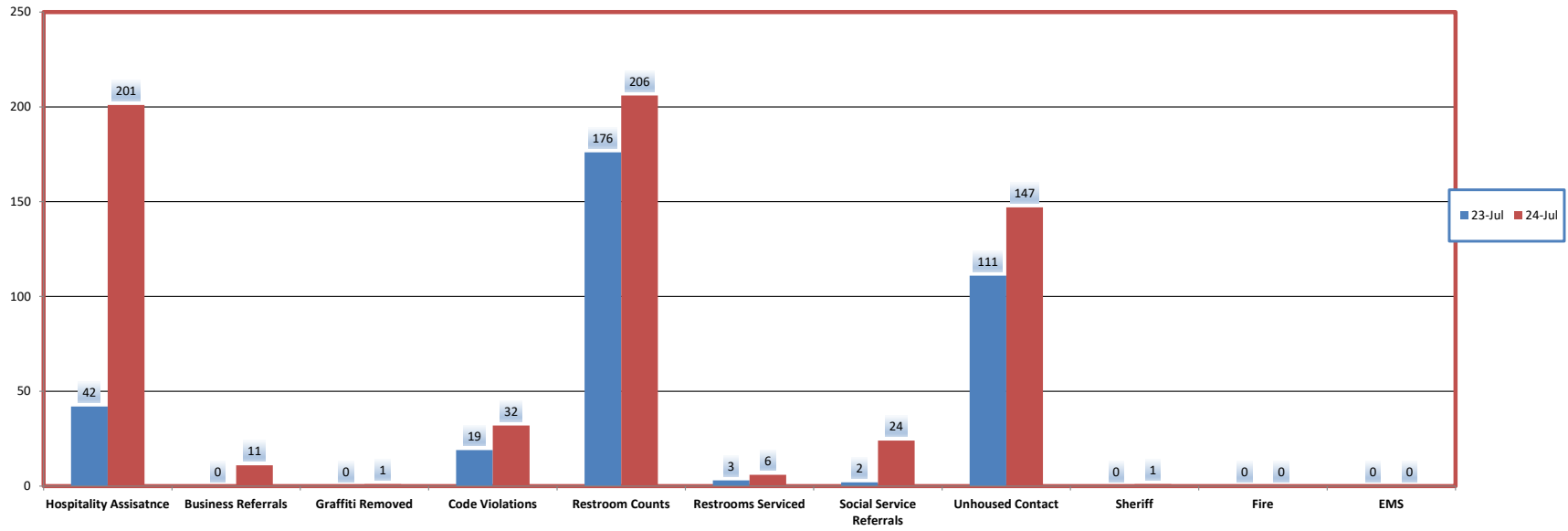

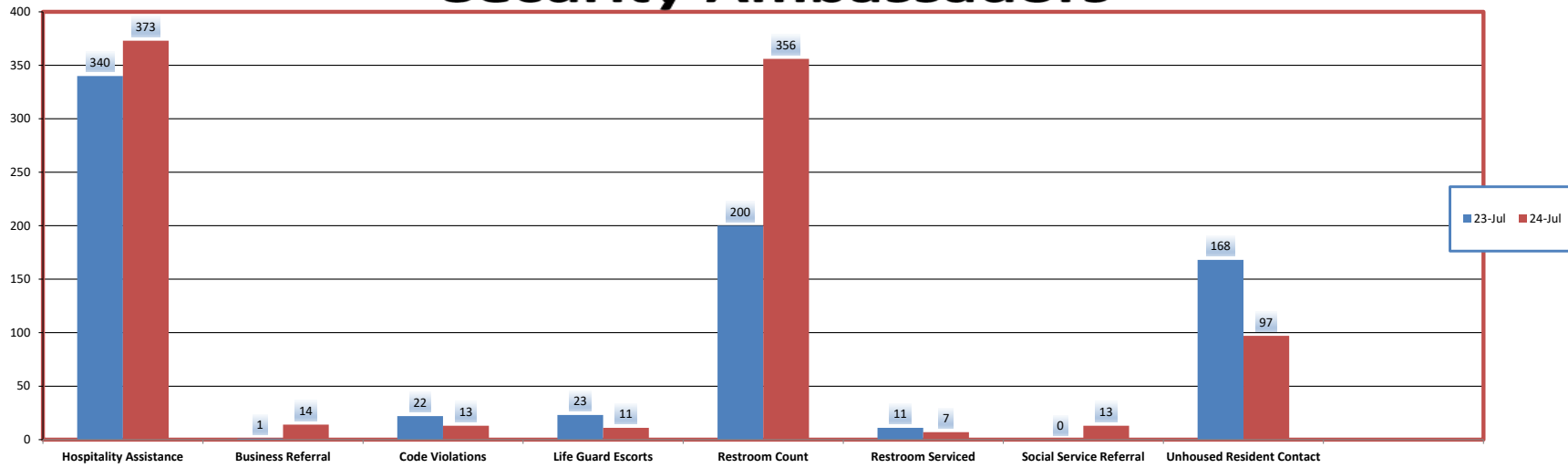

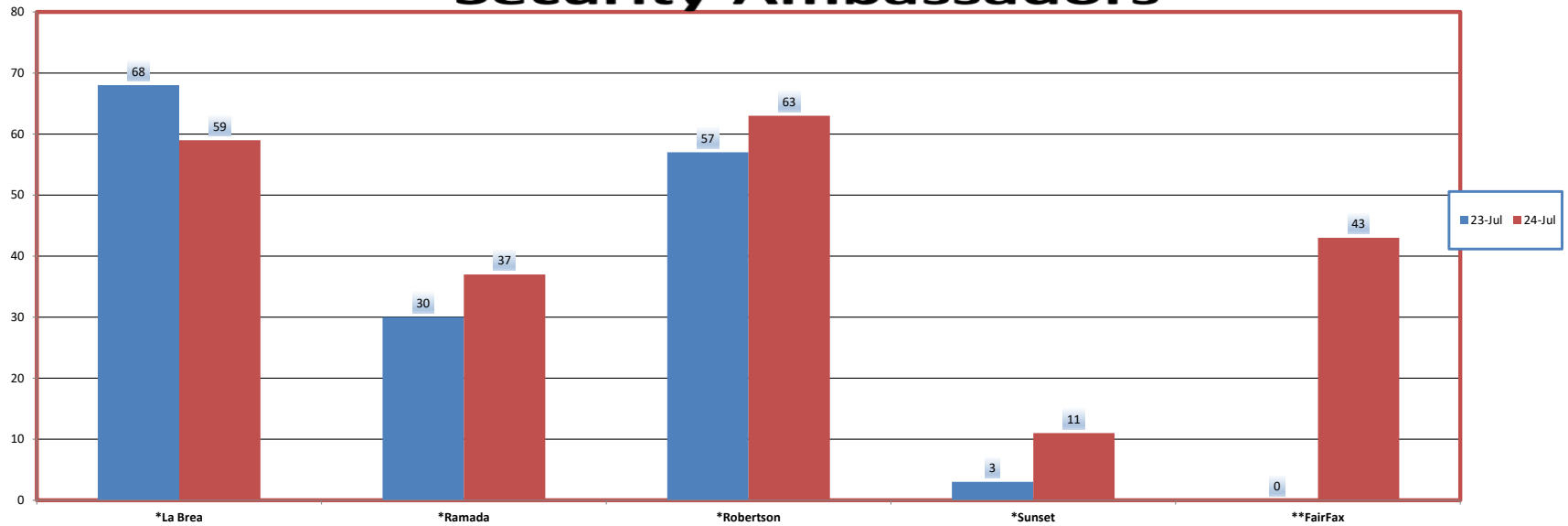

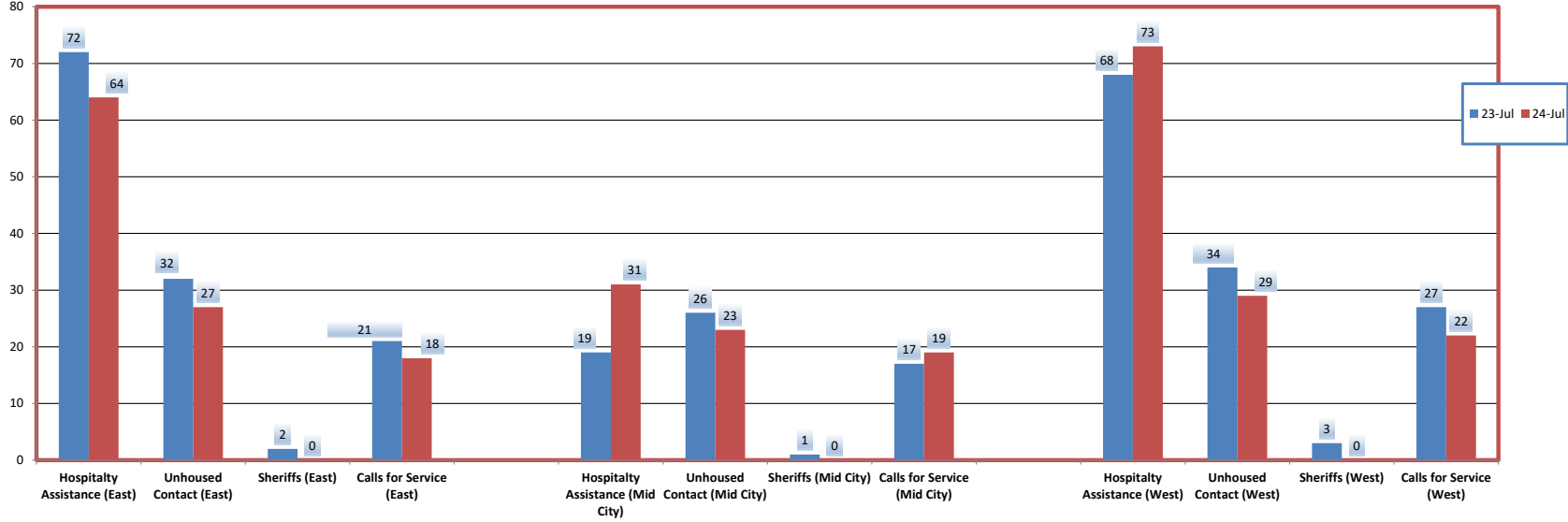

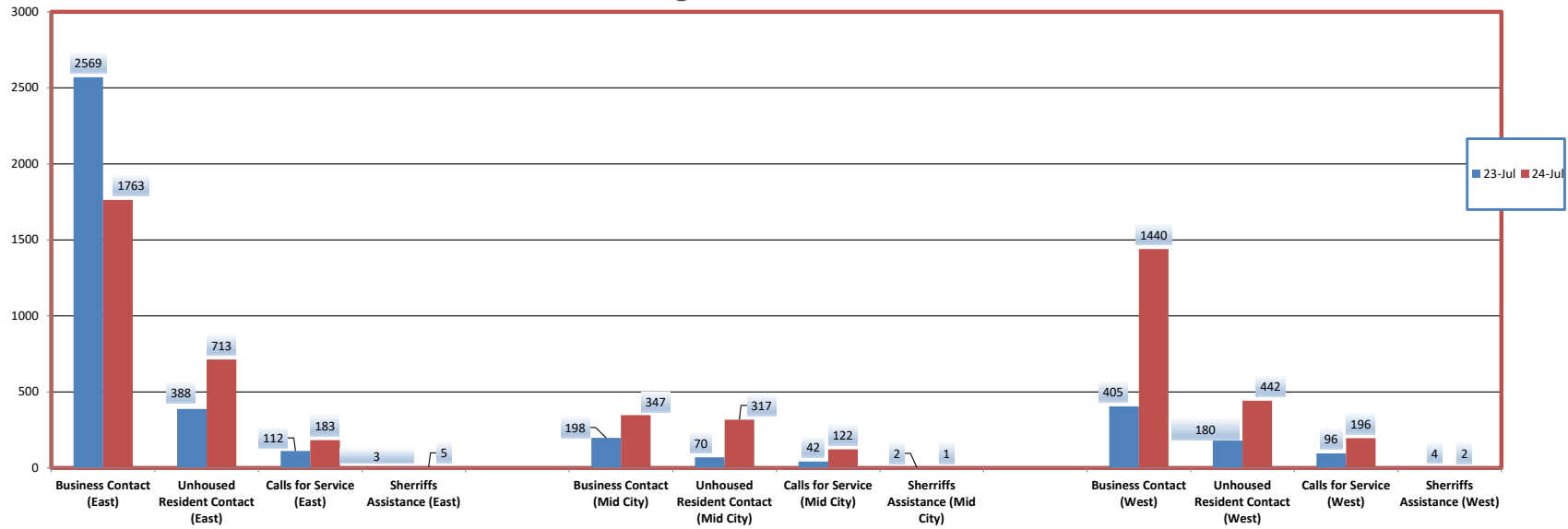
