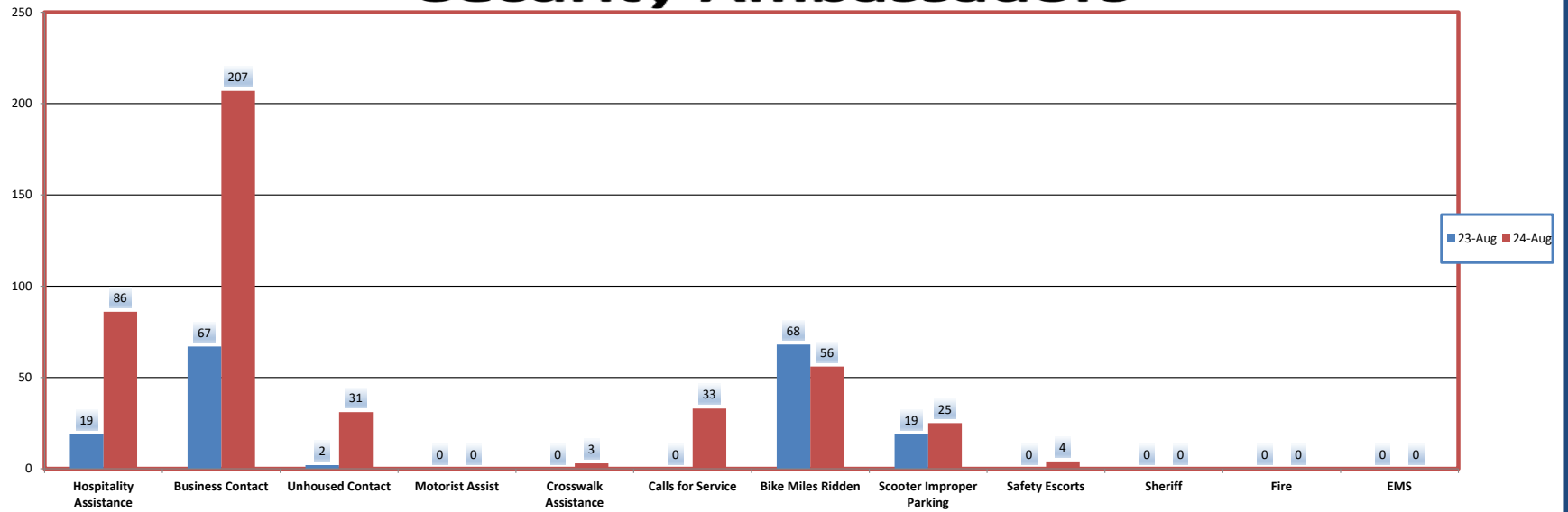
Santa Monica Blvd. - AUGUST '23 vs. AUGUST'24

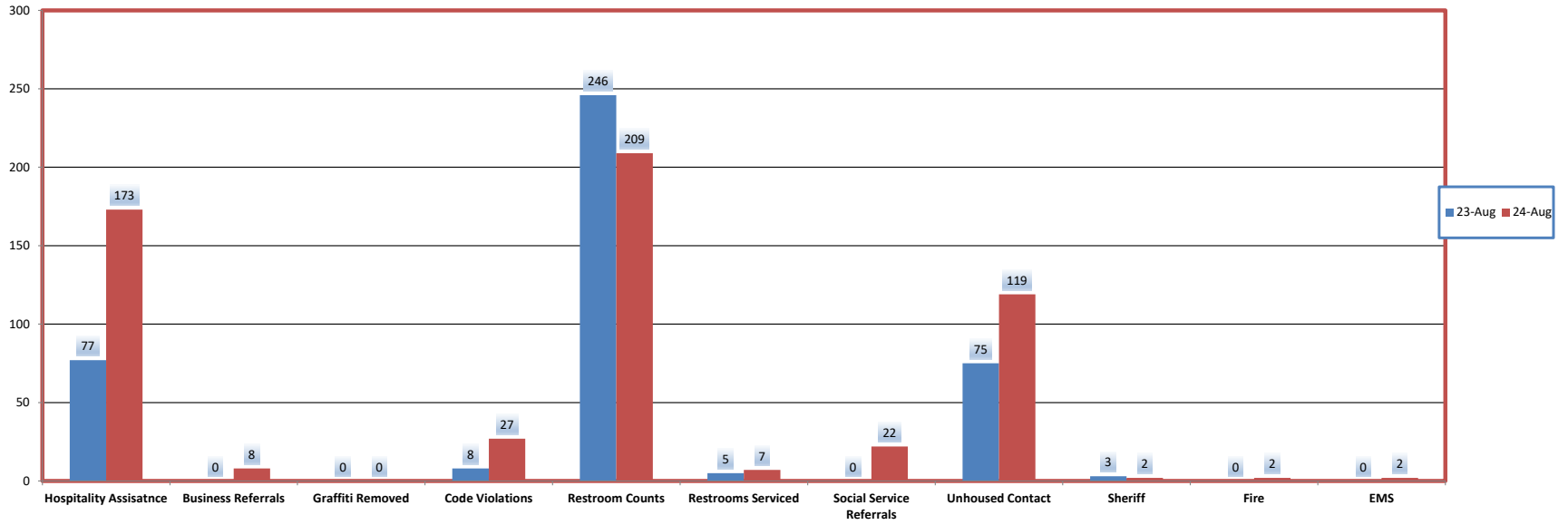

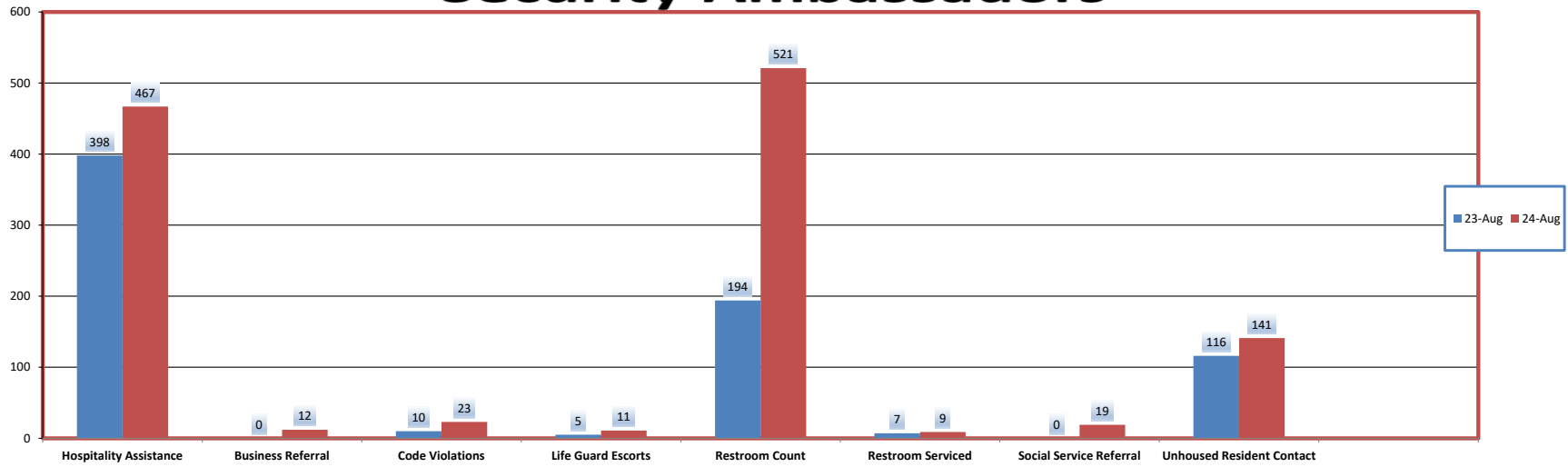

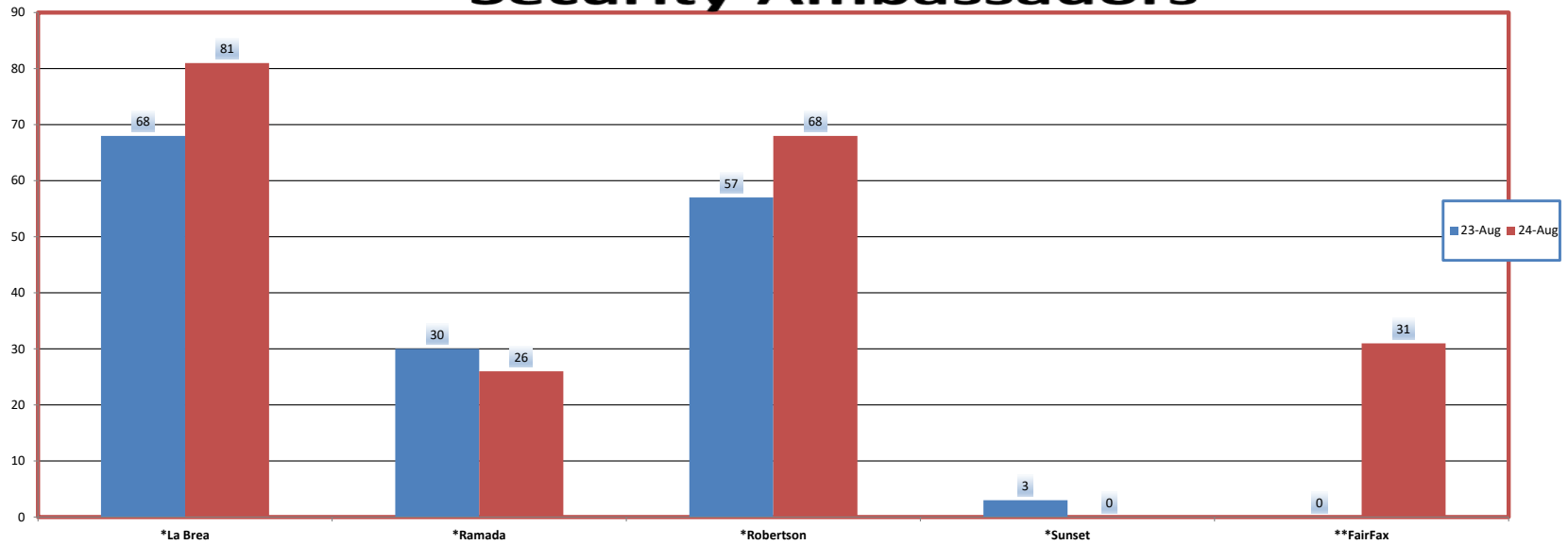

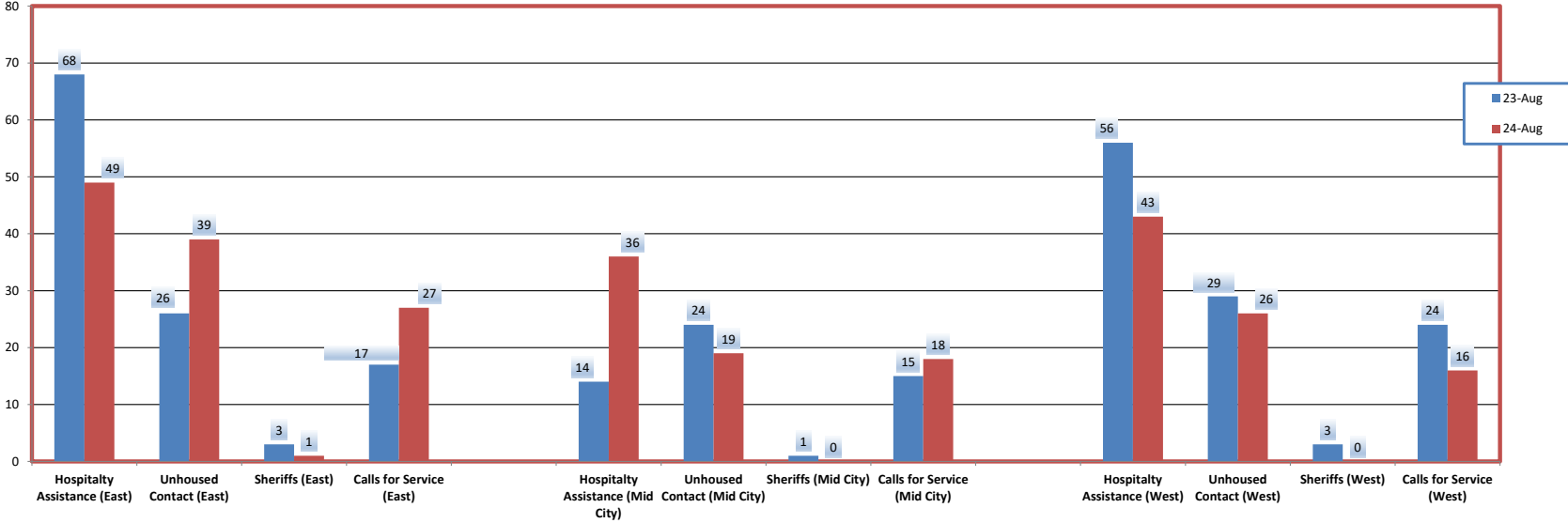
