10. UNFINISHED BUSINESS:

A. BICYCLE GIVEAWAY PILOT PROGRAM UPDATE:

Paige Portwood, Associate Planner, and Bob Cheung, Senior Transportation Planner provided the Transportation and Mobility Commission with an update on the Bicycle Giveaway Pilot Program.

The Commission inquired how a bike lending library would be implemented and how bike storage would be accommodated.

The Commission discussed looking into Bike Metro, Metro Best, LA County Bicycle Coalition for other possible program strategies.

The Commission discussed possibilities for contracted agencies versus a City operated program and the allocated budget for the current pilot program.

The Commission, Paige Portwood and Bob Cheung discussed suggested collaborations with Metro Best, LA County Bicycle Coalition, WeHo Bicycle Coalition, Walk 'n Rollers, Bicycle Kitchen for the program and bicycle safety and education.

The Commission requested clarification on how a rebate voucher and grant programs would work.

The Commission requested clarification on what will happen to the returned bicycles from the current pilot program once the program is concluded, and how liability is addressed.

9. **NEW BUSINESS:**

A. POTENTIAL CITY OF WEST HOLLYWOOD ENDORSEMENT OF THE STC4ALL COALITION:

*Commissioner Greene recused himself for the rest of the Transportation and Mobility Commission meeting.

David Fenn, Senior Planner, gave a brief summary to consider the request from the Sepulveda Transit Corridor for All (STC4All) advocacy coalition and make a recommendation to the City Council on whether the City of West Hollywood should join.

The Commission and David Fenn discussed the options of the different alternatives for the Sepulveda transit corridor, along with the membership of the coalition and those in potential opposition and implications related to the City's many existing asks of Metro and the possibility of waiting for the other more directly impacted jurisdictions to weigh in first

The Commission debated the possibilities of joining the Coalition versus not joining and sending a letter to Metro separately Concerns included staff availability for any potential additional coalition efforts beyond sending a letter.

The Coalition inquired if the Coalition will be supporting the City's preferred alternative for the Metro K Line Northern Extension. David Fenn clarified that this is unlikely given the breadth of their membership and the single-issue nature of the coalition.

The Commission agrees that the line should have a stop at UCLA and a direct connection to the Purple Line

11. ITEMS FROM STAFF:

Metro K Line Northern Extension EIR – David Fenn

- David Fenn informed the commission that Metro opened a 45 day public comment period for the K Line Northern Extension Draft EIR. David Fenn also noted the City's longstanding support for San Vicente/Fairfax alternative, empathized the importance of residents and stakeholders sending in public comments to Metro in support of this route as a decision will be made in the next several months. Finally, David Fenn noted that anyone interested can go to weho.org/metro for more information on how to provide public comments including sample comment emails and a public comment form.
- Commissioner Wentzel inquired about the possibility of Metro Bikeshare coming to the City and David Fenn clarified that the City Council had already requested Metro consider West Hollywood for future expansions of the program but that such expansions are onhold pending Metro's ongoing solicitation for a new Metro Bikeshare operator.
- David Fenn noted the September 5th deadline for public comments to be submitted to Metro.
- Chair Winick spoke on concerns about safety for the Metro and the need to emphasize that matter with the K Line extension. David Fenn noted some
