CALL TO ORDER: Mayor Erickson called the meeting to order at 6:00 p.m.

SUBJECT: The City Council will consider the award of an Exclusive Negotiation Agreement (ENA) to the Community Corporation of Santa Monica to develop a 100 percent affordable housing project at 1047 and 1057 N. Crescent Heights Boulevard.

ACTIONS: 1) Authorized the City Manager or designee to execute an Exclusive Negotiation Agreement (ENA), in substantially the form attached, with Community Corporation of Santa Monica to develop an affordable housing project located at 1047 and 1057 N. Crescent Heights Boulevard; and 2) Authorized the City Manager, or designee, to execute all documents incident to the Agreement. **Approved as part of the Consent Calendar.**

B.24 (F.3.) 2024 HALLOWEEN CARNAVAL EVENT PRODUCTION SERVICES AGREEMENT AWARD, STREET CLOSURES, AND FACILITY USE [Y. QUARKER, C. SMITH, M. REATH, J. HEREDIA]:

SUBJECT: The City Council will consider approving a three-year Agreement for Event Production Services with Authentic Agency related to the Halloween Carnaval events from 2024 through 2026. The Council will also consider approving street closures and facility uses associated with the 2024 Halloween Carnaval event as well as approving the waiver of Special Event Permit fees for City businesses during the event, which will be held on Thursday, October 31, 2024.

ACTIONS: 1) Authorized the City Manager to negotiate a three-year Agreement for Event Production Services with Authentic Agency for the annual Halloween Carnaval event in an amount not to exceed \$1,883,000 (not to exceed \$597,000 in 2024 with a 5% cost of living increase in years 2025 and 2026) and execute documents incidental to the Agreement; 2) Authorized the Director of Finance & Technology Services to allocate \$97,000 from unallocated reserves in the General Fund for event production services for the 2024 Halloween Carnaval; 3) Approved street closures and facility uses related to the 2024 event, as detailed in the body of this report; 4) Approved a loss of revenue of approximately \$6,500 related to meters along the footprint of the event and surrounding streets; 5) Approved a loss of revenue of approximately \$4,000 related to the exclusive use of the Five-Story Parking Structure for public safety vehicles and event production vehicles between 5:00 AM on Thursday, October 31, 2024, and 7:00 AM on Friday, November 1, 2024; 6) Approved the waiver of Special Event Permit fees and Encroachment fees for City businesses activating their businesses between October 31 and November 3 in celebration of Halloween (estimated at \$20,000 in waived fees); 7) Authorized up to \$12,500 to cover Los Angeles County Fire Department site plan review fees related to the waived Special Event Permits associated with City business activations between October 31 and November 3; 8) Authorized the City Manager to negotiate a onetime agreement for services with the Sunset Strip Business Improvement District in an amount not to exceed \$75,000 for a Haunted Halloween Trolley and authorize the Director of Finance & Technology Services to allocate \$75,000 from unallocated reserves in the General Fund for the Haunted Halloween Trolley. C.1. ZONE TEXT AMENDMENT TO UPDATE REPLACEMENT REQUIREMENTS OF ABOVE LOWER-INCOME PROTECTED UNITS IN NEW HOUSING PROJECTS AND INCORPORATE UNIT DEMOLITION PROTECTIONS IN COMPLIANCE WITH STATE LAW [N. MARICICH, F. CONTRERAS, AICP, M. MONTENEGRO, T. FARRIS]:

SUBJECT: The City Council will consider a Council-directed Zone Text Amendment (ZTA) to amend Sections 19.22.030 and 19.22.050 of Title 19 of the West Hollywood Municipal Code (WHMC) to require the replacement of demolished protected units that are or were formerly occupied by households or individuals of above lower-income (80% of higher Area Median Income) with units subject to rent stabilization (under Title 17 of the WHMC) in the proposed housing project. In addition, the City Council will consider including additional updates to the WHMC

related to unit demolition in alignment with state law. The proposed ZTA is not subject to the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the State CEQA Guidelines, provided that this activity is an election under state law that does not have the potential to result in an effect on the environment.

Mayor Erickson opened the Public Hearing.

There were no disclosures from the City Council.

Assistant City Clerk Morales noted that the Public Hearing was noticed as required by law.

Associate Planner Michelle Montenegro provided background information as outlined in the staff report dated September 16, 2024.

Councilmember Meister commented on correspondence received late in the day that indicated that the feasibility study didn't include new legislation when AB 1287 was adopted. Ms. Montenegro responded.

Councilmember Heilman inquired about the market rate for the rent stabilized units. Ms. Montenegro responded.

Vice Mayor Byers inquired about various studies that the Long Range Planning is conducting and if there are redundancies. Ms. Montenegro responded.

Mayor Erickson inquired if this is a time-sensitive ZTA. If it isn't time-sensitive, could staff consider AB 1287 and return with an updated ZTA at a future meeting. Ms. Montenegro responded.

Councilmember Heilman clarified for the record that this item was brought forward at the direction of the City Council due to the challenges with the City's current replacement model for rent stabilized units.

The following members of the public came forward to speak:

GEORGE NICKLE, WEST HOLLYWOOD, spoke in support of affordable housing.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke regarding the various types of housing that are needed. She provided various funding sources that could be used to support housing.

JAMIE FRANCIS, WEST HOLLYWOOD, spoke regarding the need for affordable housing in the City.

The following individual submitted a Citizen Position Slip in support of the Item:

The public testimony portion of the Public Hearing was closed.

Councilmember Heilman made a Motion to move the Item, and Mayor Erickson seconded the motion.

Councilmember Meister inquired how many developers have complained about our current Zone Text. Community Development Director Nick Maricich commented that there has been a decline in applications for housing projects. Ms. Montenegro commented that in the Development Roundtable developers stated that the City's Zone Text is a hindrance. Councilmember Meister noted that this Zone Text Amendment will not help increase the City's affordable housing stock. She requested that staff include a 1 for 1 affordable unit replacement and continue to study AB 1287.

Councilmember Shyne inquired about the additional Planning Commission recommendation. Ms. Montenegro responded.

Vice Mayor Byers spoke about the number of studies that we are working on. She supports the Item and the study of AB 1287 for additional modifications to the Zoning Ordinance, as needed.

Councilmember Heilman reiterated the Vice Mayor's comments. He commented that the goal is to maximize affordable housing and protect tenants. He spoke about the feasibility study and the issues that were raised in it.

Mayor Erickson agreed with Councilmember Heilman's comments and indicated his support for this Item.

City Clerk Crowder read the title of the Ordinance into the record for first reading.

ACTIONS: 1) Introduced on First Reading, by title only, Ordinance No. 24-26: "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ADOPTING AN AMENDMENT TO TITLE 19, THE ZONING ORDINANCE OF THE WEST HOLLYWOOD MUNICIPAL CODE, TO UPDATE REPLACEMENT REQUIREMENTS OF ABOVE LOWER-INCOME PROTECTED UNITS IN NEW HOUSING PROJECTS AND UPDATE PROVISIONS RELATED TO UNIT DEMOLITION IN

ALIGNMENT WITH STATE LAW"; 2) Considered a recommendation by the Planning Commission to direct staff to study allowing an additional local density bonus (beyond what state law permits) to accommodate the replacement of above lower-income units as deed restricted affordable units in perpetuity, instead of replacement as rent-stabilized units; and 3) Directed staff to conduct a study of AB 1287 and possible inclusion into the City's Zoning Ordinance. Rent Stabilization Manager Cameron Kesinger provided background information as outlined in the staff report dated September 16, 2024.

Councilmember Meister commented on language on page 1,079 "in cases where..." Mr. Kesinger responded noting that staff's recommendation provides more flexibility to the tenant.

JAMIE FRANCIS, WEST HOLLYWOOD, spoke regarding his need for affordable housing and the option to move to other affordable units.

VICTOR OMELCZENKO, WEST HOLLYWOOD, spoke regarding his rent stabilized unit and his recent inquiry to Mayor Erickson about this legislation. He also spoke about the procedures for how a tenant notifies the City if they need to move using this change to the RSO.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke regarding her challenges with the City enforcing the RSO.

Mayor Erickson requested that staff create a "how to", so that members of

the public understand how this new program works and the steps that they need to take if they need to use it.

City Clerk Crowder read the title of the ordinance into the record for First Reading.

Senior Planner Christine Shen provided background information as outlined in the staff report dated September 16, 2024.

Councilmember Meister inquired about the timeline, change in scope and renaming of the Fountain Avenue Streetscape Project. Director of Community Development Nick Maricich responded.

GENEVIEVE MORRILL, PRESIDENT/CEO OF WEST HOLLYWOOD CHAMBER OF COMMERCE, spoke regarding concerns that the Chamber has with the proposed bike lanes along Fountain Avenue.

TOD HALLMAN, WEST HOLLYWOOD, spoke regarding a letter that he drafted as Neighborhood Watch Captain for the eastside.

KEVIN BURTON, WEST HOLLYWOOD, spoke on behalf of the West Hollywood Bicycle Coalition in support of the Item.

LAURA BOCCALETTI, WEST HOLLYWOOD, spoke in opposition of the Item due to the bike lanes.

DAVID ECKERT, WEST HOLLYWOOD, spoke in opposition of the Item due to the bike lanes.

KIMBERLY COPELAND, WEST HOLLYWOOD, spoke regarding the senior housing that is near this location and the lack of parking already in this area. She also spoke about traffic safety and the lack of traffic calming that currently exists.

STEPHANIE HARKER, WEST HOLLYWOOD, spoke in opposition of the Item.

GEORGE NICKLE, WEST HOLLYWOOD, spoke in opposition of the Item.

DAVID LEWIS, WEST HOLLYWOOD, spoke in opposition of the Item.

NIK ROYBAL, WEST HOLLYWOOD, spoke regarding what we are taking away from the residents.

Mayor Erickson inquired about the comments regarding the Fire Department. Planning Manager Francisco Contreras responded. He inquired what the projected timeline is for the design plans to come before the City Council. Mr. Contreras responded. Director of Community Development Nick Maricich also provided additional feedback. Mayor Erickson also inquired about where all the misinformation is coming from. Mr. Maricich responded.

Councilmember Heilman asked if a bike lane on Fountain Avenue is required for the grant. He also asked about the Steering Committee. Mr. Contreras responded.

Councilmember Meister inquired about the make-up of the Steering Committee. She inquired about the process. She further went through items in the application and asked staff questions. She enumerated the reasons that she does not support this Item. She recommended that staff only except the grant funds for the other items i.e. paratransit, electric vehicles, etc. and decline the funding for bike lanes.

City Manager David Wilson responded to some of Councilmember Meister's comments. He noted that protected bike lanes were included in the expanded Streetscape Project.

Councilmember Shyne shared the previous Council direction to staff. She spoke about the timeline for the project. She reiterated that protected bike lanes were always part of the direction.

Mr. Maricich clarified for the record the number of residents who live along Fountain or near Fountain that are part of the Steering Committee.

Councilmember Heilman spoke about the various issues before the Council. He shared his concerns with staff's handling of the Fountain Avenue Streetscape Project, including the Steering Committee and the grant application. He opposes accepting the funds for the bike lanes, but he supports the other grant funding.

Vice Mayor Byers spoke about the need for a bike lane network in the City. She noted that the City Council is trying to include different modes of transportation for everyone. She shared that the Pedestrian and Bicycle Mobility Plan has been in place for over a decade.

Mayor Erickson noted that the Pedestrian and Bicycle Mobility Plan has been in place for many years. He spoke about the potential liability issues with Fountain Avenue. He shared that the plans are not complete for this project.

Councilmember Heilman requested that staff reach out to the Fire Department immediately to get their feedback on how the proposed changes on Fountain may affect emergency response. He also mentioned the loss of parking and no solutions being offered.

ACTIONS: 1) Adopted Resolution No. 24-092: "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AUTHORIZING RECEIPT OF, CALIFORNIA AIR RESOURCE BOARD'S SUSTAINABLE TRANSPORTATION AND EQUITY PROJECT GRANT IN AN AMOUNT OF UP TO \$8,214,840"; 2) Authorized the City Manager, or designee, to execute a Grant Agreement and all necessary contracts, payment requests, and amendments with the California Air Resources Board to secure and facilitate the use and expenditure of grant funds in the amount of \$8,214,840; 3) Directed staff to add three additional members to the Fountain Avenue Streetscape Steering Committee for Phase 2 (sidewalks) of the study; and 4) Directed staff to reach out to the Los Angeles County Fire Department to discuss the proposed plans for Fountain Avenue. Motion by Vice Mayor Byers, seconded by Councilmember Shyne, and approved (3/2), noting the "no" votes of Councilmembers Heilman and Meister.

Project Architect Michael Barker provided background information as outlined in the staff report dated September 16, 2024.

Councilmember Heilman inquired which type of surface do we use at West Hollywood Park. Field and Facilities Services Manager Helen Collins responded that we use turf.

Mayor Erickson inquired about any claims that have been filed with the City regarding turf. Staff responded that there haven't been any claims filed. He also inquired about the cost to change out the turf. Ms. Collins responded.

VICTOR OMELCZENKO, WEST HOLLYWOOD, spoke regarding what he has learned about artificial turf. He further commented that we should keep wood chips at Hart Park.

TERRY SAUCIER, TARZANA, spoke regarding the environmental impacts of artificial turf.

BOB CLASTER, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

PETER GABRIEL, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

SAMANTHA, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

VALERIA, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

DAVID SARKISIAN, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf at Hart Park.

DAVID YOCUM, WEST HOLLYWOOD, spoke regarding the reduced size of the dog park.

STEPHANIE HARKER, WEST HOLLYWOOD, spoke in opposition to the use of artificial turf.

Councilmember Heilman supports staff's recommendation.

Councilmember Meister inquired if we could approve the Agreement for Services without deciding on the ground cover tonight. Ms. Collins indicated that we could proceed.

Councilmember Shyne asked if staff can provide information on the different types of woodchips and the pros and cons. She also inquired about community outreach. Mr. Abramson responded.

Vice Mayor Byers asked what the City of Los Angeles has indicated. Ms. Collins responded. She is interested in a natural product. She supports moving forward with the Agreement for Services.

Mayor Erickson supports moving forward with the Agreement for Services and another City Council discussion regarding the ground cover at a future meeting.

ACTIONS: 1) Approved an Agreement for Services with Stoss, Inc. to provide professional design and engineering services for the Hart Park Improvements Project in the amount of \$359,295 and include a 22% contingency for related services in the amount of \$80,705 for a total not-to-exceed amount of \$440,000; 2) Authorized the City Manager or designee to execute all documents incident to the Agreement; and 3) Directed staff to return to a future meeting to discuss the ground cover options for the off-leash dog park area (wood chips, decomposed granite, artificial turf, pea pebbles). **Motion by Councilmember Meister, seconded by Mayor Erickson, and approved (5/0).**

E.3. WEHO PRIDE 2024 EVENT DEBRIEF AND 2025 PLANNING [Y. QUARKER, C. SMITH, M. REATH, K. MCCORMACK]:

SUBJECT: The City Council will receive a post-event report regarding WeHo Pride 2024 and provide feedback related to the event. The City Council will also consider approving various items related to production and programming elements for WeHo Pride 2025.

EDD H., WEST HOLLYWOOD, spoke regarding the WeHo Pride Weekend coinciding with Memorial Day weekend.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke regarding her experience at last year's WeHo Pride parade.

The following individual submitted a Citizen Position Slip in opposition to staff's recommendation:

Rick Watts, West Hollywood

Councilmember Shyne thanked and congratulated staff on their work on WeHo Pride. She inquired about the contract with JJLA. She inquired about the L-Project's contract for the Women's Freedom Festival and increasing their contract by \$100K. She commented that the Dyke March needs to be improved. Events Supervisor Megan Reath commented that the L-Project's Agreement for Services is not on tonight's agenda, and that staff is awaiting their funding request.

Councilmember Heilman mentioned the comment from Edd regarding the weekend. He asked if staff has looked at the dates and discussed with JJLA.

Mayor Erickson commented that the Pride Subcommittee discussed the dates and noted that World Pride occurs the second weekend in June 2025 in Washington D.C. He spoke about the security concerns that were raised in the staff report. He inquired if we considered extending JJLA's contract beyond 2025. He supports a discussion about Women's Freedom Festival and shared concerns that he noted at last year's Pride.

Vice Mayor Byers supports extending JJLA's contract beyond what is being presented. She commented that Harvey Milk Day is considered WeHo's Pride kickoff.

Mayor Erickson noted that there is consensus to extend JJLA's contract.

ACTIONS: 1) Received a post-event report regarding WeHo Pride 2024 and provided feedback related to the event; 2) Approved a WeHo Pride 2025 event from Friday, May 30, 2025 to Sunday, June 1, 2025 with the same core elements and footprint as WeHo Pride 2024; 3) Authorized the City Manager or his designee to negotiate co-sponsorship agreements related to their participation in WeHo Pride 2025 with JJLA for the OUTLOUD Music Festival and with the L-Project for the Women's Freedom Festival and Dyke March, and directed staff to return to a future City Council meeting for approval; 4) Approved the waiver of Special Event Permit fees and Encroachment Permit fees, in an amount estimated at \$14,000 for City businesses hosting events on May 30, May 31, and June 1, 2025, in celebration of WeHo Pride; 5) Authorized up to \$12,500 for basic Los Angeles County Fire Department site plan review fees related to Pride weekend activations at City businesses, which is included in the Community Safety Budget; 6) Approved street closures and facilities usages as outlined in this report, as they relate to WeHo Pride 2025, including the potential loss of revenue of approximately \$50,000 as it relates to the City's parking lots, garages, and meters: 7) Waived residential permit parking restrictions citywide from Fridav. May 30, 2025, at 4:00 P.M. through Monday, June 2, 2025, at 7:00 A.M.; 8) Authorized the City Manager or his designee to negotiate City of West Hollywood participation in other 2025 Pride events; 9) Authorized the City Manager or his designee to negotiate an Amendment to the Production Services Agreement with JJLA, to extend the agreement through December 31, 2027, to encompass production of WeHo Pride events in 2026 and 2027 and directed staff to return to a future City Council meeting for approval; 10) Directed staff to explore an economic impact study related to the City's Major Events in calendar year 2025; and 11) Directed staff to explore the opportunity to extend the Production Services Agreement with JJLA as well as the Agreement for Services with the L-Project beyond what is being recommended in this item. Motion by Mayor Erickson, seconded by Vice Mayor Byers, and approved (5/0).

SUBJECT: The City Council will consider the award of an Exclusive Negotiation Agreement (ENA) to the Community Corporation of Santa Monica to develop a 100 percent affordable housing project at 1047 and 1057 N. Crescent Heights Boulevard.

F.2. REQUEST FOR FINANCING COMMITMENT LETTER AND AUTHORIZATION TO ISSUE LOAN FROM THE AFFORDABLE HOUSING TRUST FUND IN THE AMOUNT OF \$5,145,000 FOR ACQUISITION FINANCING AT 1238 AND 1244 N. LARRABEE DRIVE [S. CAMPBELL, B. LEAGUE, A. BARTLE]:

SUBJECT: The City Council will consider issuing a commitment letter and loan from the Affordable Housing Trust Fund to Linc Housing Corporation, a non-profit housing developer and operator, in the amount of \$5,145,000 for acquisition financing at 1238 and 1244 N. Larrabee Drive.

VICTOR OMELCZENKO, WEST HOLLYWOOD, spoke regarding how Linc, LLC was chosen.

CRYSTAL VILLALPANDO, LOS ANGELES, spoke on behalf of Linc Housing to request Council's support of the Item.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke regarding the purchase price.

JAMIE FRANCIS, WEST HOLLYWOOD, spoke regarding affordable housing.

Councilmember Meister requested that additional language be added in Section 5 of the Commitment Letter.

ACTIONS: 1) Authorized the City Manager or designee to execute a commitment letter in substantially the form attached, pledging \$5,145,000 for acquisition financing for the development of between 45 and 50 affordable housing units at 1238 and 1244 N. Larrabee Drive and authorize the City Manager, or designee, to execute all documents incident to the Agreement; 2) Authorized the Director of Finance and Technology Services to allocate \$5,145,000 in the Affordable Housing Trust fund to account 216-3-05-62-537015 for the purposes of funding the loan; 3) Authorized the Director of Finance and Technology Services to make annual transfers from the General Fund to the Affordable Housing Trust Fund. based on expended amounts for approved funding commitments for affordable housing developments, if actual expenditures in Affordable Housing Trust Fund exceed the fund balance; and 4) Added language to Section 5 of the Commitment Letter: Borrower shall confer with the City of West Hollywood's Urban Design + Architecture and Urban Design Studio ("UDAS") on architect selection and shall incorporate recommendations from UDAS on design criteria for the Project. At the beginning of the project, the Borrower shall meet with the City's Urban Design, City Architect, and Planning staff to familiarize themselves with local goals and policies, including but not limited to housing, climate, resilience, etc. Then the Borrower shall review early site development and conceptual design options with the same staff before finalizing a single, final design proposal for the Property. Motion by Councilmember Meister, seconded by Councilmember Heilman, and approved (5/0).

F.3. 2024 HALLOWEEN CARNAVAL EVENT PRODUCTION SERVICES AGREEMENT AWARD, STREET CLOSURES, AND FACILITY USE [Y. QUARKER, C. SMITH, M. REATH, J. HEREDIA]:

SUBJECT: The City Council will consider approving a three-year Agreement for Event Production Services with Authentic Agency related to the Halloween Carnaval events from 2024 through 2026. The Council will also consider approving street closures and facility uses associated with the 2024 Halloween Carnaval event as well as approving the waiver of Special Event Permit fees for City businesses during the event, which will be held on Thursday, October 31, 2024.

ACTIONS: This Item was moved to the Consent Calendar.

F.4. SIGNAGE ON PUBLIC SCHOOL PROPERTIES IN WEST HOLLYWOOD [J. HEILMAN, Y. QUARKER, A. LOVANO, J. DEL TORO]:

SUBJECT: This item directs staff to develop a pilot program which will permit modern digital signage on public school properties in West Hollywood. The signage would be permitted to display school-related announcements as well as limited offsite advertising pursuant to a development agreement, with revenue being utilized exclusively for the school.

Councilmember Heilman provided background information as outlined in the staff report dated September 16, 2024.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, spoke regarding whether this was necessary or not.

Councilmember Meister provided the reasons that she cannot support the Item.

Councilmember Shyne commented that this is a forward-thinking proposal.

ACTIONS: 1) Directed staff to work with Los Angeles Unified School District to develop a pilot program which will permit modern digital signage at West Hollywood Elementary School; 2) Directed staff to draft amendments to the zoning code to permit such signage; 3) Directed staff to issue a Request for Proposals (RFP), in conjunction with LAUSD, for a modernized signage program with limited offsite advertising being permitted; and 4) Directed staff to develop a template for a development agreement with revenue from the development agreement being used exclusively to support programs and improvements at West Hollywood Elementary School. Motion by Councilmember Heilman, seconded by Councilmember Shyne, and approved (4/1), noting the "no" vote of Councilmember Meister.
