**5.A. OFF-LEASH DOG USE AT PLUMMER PARK [S. BAXTER, S.CAMPBELL, H. COLLINS]:**

*The City Council will consider off-leash dog use at Plummer Park.*

Sam Baxter, Director of Human Services, and Steve Campbell, Facilities and Landscape Manager, provided background information as outlined in the staff report dated October 4, 2010.

ROB BERGSTEIN, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park.



GINNY RAMKIN, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park.

ROB STEVENS, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park. He spoke in support of Option A in the staff report, to place the dog park in Area #3.

RIC RICKLES, WEST HOLLYWOOD, spoke in opposition to an off-leash dog park at Plummer Park.

JOHN HAZELTON, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park. He spoke in support of locating the dog park in either Area #3 or Area #1.

JAY HARVEY, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park.

MARYANN SZYSKOWSKI, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park.

MICHAEL CALAS, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park.

JIM CHUD, WEST HOLLYWOOD, spoke in support of an off-leash dog park at Plummer Park. He spoke in support of Option A in the staff report, to place the dog park in Area #3.

Councilmember Prang requested clarification regarding the proximity of two of the proposed off-leash dog park sites in relation to residential buildings. He spoke regarding the need for services for residents who are pet guardians. He expressed concerns regarding the impacts on neighboring residents, and spoke in support of more outreach to the surrounding residential buildings if Area #3 is chosen. He spoke in support of strong regulations for any off-leash dog park. He spoke in support of a ban on dogs that are not spayed or neutered at the off-leash dog park. He spoke in support of investigating the possibility of limiting hours of the off-leash dog parks to mitigate impacts on neighboring residents.

Mayor Pro Tempore Duran spoke regarding the urban density of West Hollywood and spoke in support of working with City staff to help mitigate sound issues associated with an off-leash dog park at Plummer Park. He spoke regarding the possibility of creating separate off-leash dog areas for smaller and larger dogs. He expressed concerns regarding the size of Area #1 for an off-leash dog park. He spoke in support of a skate board area for Area #2. He spoke in support of Area #3, Option A, in the staff report for the location of the off-leash dog park.

Councilmember Land spoke in support of an off-leash dog park at Plummer Park. She spoke in support of a fenced-off area for the off-leash dog park. She spoke regarding the difficulties of creating separate spaces for smaller and larger dogs due to space limitations. She spoke regarding the need to do community outreach to residential neighbors.

Councilmember Horvath spoke in support of an off-leash dog park at Plummer Park. She expressed concerns regarding locating the park too close to neighboring residential buildings. She spoke in support of Area #3, Option A, in the staff report.

Mayor Heilman requested clarification regarding the size of Area #1 in the staff report. He expressed concerns regarding Area #3 and its proximity to residential buildings. He spoke in support of the location of Area #1 and in support of investigating the possibility of expanding the area.

**ACTION:** Provide staff with direction regarding off-leash dog use at Plummer Park and direct staff to return to Council with 1) additional information and options for Area #1, with a possible expansion of the area; 2) additional information and options for Area #3; and 3) additional information on mitigating impacts to neighboring residents for both locations. **Carried by Consensus of the Council.**
