Vice Chair Karliss commented on the Café Space adjacent to Council Chambers. He spoke against the current use of the space by Block by Block and commented that the venue could be better utilized by a food or coffee vendor.

Commissioner Jackson inquired about the usage of the locker room and the visibility issue in the men's restroom. Staff provided a response.

Commissioner Ragno commented about the request for hooks to be installed in the locker rooms.

Commissioner Payton inquired about the lap swim schedule. Staff provided an

update.

Commissioner Mason commented on the lap swim schedule concerns. He likes the new trash cans on Melrose Ave. He is happy to see his former students now involved in the City's Recreation programs. Mason expressed interest in having security presence near Kings Road Park. Staff will relay this information to Public Safety.

Commissioner Jackson asked about the trees that were illegally cut in the City. Staff provided information about the incident. Jackson attended Music in the Park event. Lastly, she asked about the Ad Hoc Committee meetings. Staff shared that they will begin to meet in September and October.

Commissioner Krishna visited the community gardens. She asked if staff is monitoring usage and asked about reopening the wait list. Additionally, she commented on the lighting in the community garden. Staff replied to the inquiries.

Commissioner Payton thanked staff and congratulated Vice Chair Karliss. She shared that the Fountain Avenue Streetscape Steering Committee is making progress. She inquired about the usage of the cooling centers at Plummer Park. Staff provided a response.

Commissioner Ragno thanked staff and shared about a fire that occurred in an abandoned building on Fairfax Ave.

Vice Chair Karliss commended Andrew Solomon. Karliss shared about his attendance at the Pride parade and thanked Facilities staff for their efforts. He visited the community garden and made positive remarks about the planter beds. Karliss asked for an update on the West Hollywood Park and Dog Park shades and the Weaver's Walk. Staff provided an update on both items.
