- REQUEST:** The Planning Commission will hold a public hearing to consider a proposed zone text amendment to streamline the approval of Electric Vehicle (EV) charging infrastructure to ensure full compliance with Assembly Bill 970 (AB 970) and designate EV Charging Sites and EV Services Stations as a primary use in designated commercial zones.
