David DeGrazia, Senior Planner, provided background information as outlined in the staff report dated December 6, 2010.

Mayor Heilman opened the public hearing and no speakers came forward.

Mayor Heilman closed the public hearing.

ACTION: Hold a public hearing, consider all pertinent testimony and introduce on first reading Ordinance No. 10-861, "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, APPROVING ZONE TEXT AMENDMENT 2010-002 CLARIFYING GREEN BUILDING STANDARDS, SOLAR ACCESS AND SOLAR EQUIPMENT STANDARDS, AFFORDABLE HOUSING INCENTIVES, IRRIGATION AND WATER CONSERVATION STANDARDS, AND PERMIT TIME LIMITS AND EXTENSIONS CITY WIDE." (EXHIBIT A) Motion by Councilmember Land, seconded by Mayor Pro Tempore Duran and unanimously approved.

3.C. COMPREHENSIVE GENERAL PLAN UPDATE, CLIMATE ACTION PLAN, AND ENVIRONMENTAL IMPACT REPORT [A. MCINTOSH, J. KEHO, B. SIEGL, C. CORRAO]:

The City Council will hold a continued public hearing regarding the Draft West Hollywood General Plan 2035; Draft Climate Action Plan; and Final Environmental Impact Report, Mitigation Monitoring and Reporting Program, and a Statement of Overriding Considerations.

City Clerk West stated that the Item was noticed as required by law.

Bianca Siegl, Associate Planner, provided background information as outlined in the staff report dated December 6, 2010.

Mayor Heilman opened the public hearing and the following speakers came forward:

KATHERINE BARRESE, WEST HOLLYWOOD, spoke regarding the proximity of a proposed project on Melrose Avenue to her residence.

BILL CROWLEY, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

LAUREN MEISTER, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

RUTH CISLOWSKI, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

ARMEN OVSEPIAN, WEST HOLLYWOOD, spoke in support of the proposed height increases on Melrose Avenue in the General Plan revision.

ALI KARIMPOUR, MARINA DEL REY, spoke in support of the proposed height increases on Melrose Avenue in the General Plan revision.

VICTOR MARTIN, GLENDALE, spoke in support of the proposed height increases on Melrose Avenue in the General Plan revision.

KIMBERLY WINICK, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

DARREN GOLD, LOS ANGELES, spoke in support of the proposed height increases on Melrose Avenue in the General Plan revision.

LAWRENCE W. CHAMBLEE, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

CARL CRONIN, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

RICHARD GIESBRET, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

CHRIS BONBRIGHT, BEVERLY HILLS, spoke regarding his position on the General Plan Advisory Committee. He spoke in support of the proposed land use changes in the General Plan revision.

IRA HANDELMAN, LOS ANGELES, spoke in support of the proposed land use changes in the General Plan revision.

RICHARD DAVIDOFF, LOS ANGELES, spoke in support of the proposed height increases on Melrose Avenue in the General Plan revision.

STEVE MARTIN, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in opposition to the proposed height increases on Melrose Avenue in the General Plan revision.

Mayor Heilman requested clarification from staff regarding the height limits of the residential areas north and south of Melrose Avenue.

Councilmember Land requested clarification from staff regarding a proposed project at the Doheny Triangle and whether it would be impacted by the proposed General Plan revision. She requested clarification from staff regarding a proposed option to prohibit housing in the CN2 zone along Melrose Avenue. She requested clarification regarding the Planning Commission recommendation regarding height limits on Melrose Avenue.

Councilmember Horvath requested clarification from staff regarding the possible maximum heights along Melrose Avenue in the proposed General Plan.

Mayor Heilman, Councilmember Horvath, Councilmember Prang, Mayor Pro Tempore Duran, and Councilmember Land spoke in support of prohibiting housing in the CN2 zone along Melrose Avenue. Councilmember Land spoke in support of trying to find opportunities to allow for live-work spaces along Melrose Avenue.

Mayor Pro Tempore Duran spoke regarding the changes along Melrose Avenue over the years. He spoke regarding development challenges in the Melrose Area, and spoke in support of allowing appropriate heights for showrooms in the area. He spoke in support of the CN2 designation for Melrose Avenue, with the prohibition of housing in the CN2 zone.

Councilmember Horvath spoke in support of including design requirements, including set-backs, in commercial projects to protect residential properties that are immediately adjacent.

Councilmember Prang spoke in support of creating a specific plan for the Melrose Area, rather than an across the board height allowance of 35'.

Mayor Heilman spoke regarding the possibility of retaining the current height limit of 25' with exceptions for increases for particular businesses.

Councilmember Land spoke in support of containing the height limits in the Melrose Area and limit the number of bonuses allowed for development projects.

The City Council spoke in support of prohibiting housing in the CC1 zone on the north side of Melrose Avenue adjacent to the West Hollywood Park.

Mayor Heilman and Councilmember Land spoke in support of allowing additional height up to 35' in the CC1 zone on the north side of Melrose Avenue adjacent to the West Hollywood Park.

Councilmember Horvath spoke in support of allowing additional height up to 35' in the CC1 zone on the north side of Melrose Avenue adjacent to the West Hollywood Park with exceptions for increases for particular businesses.

Councilmember Prang and Mayor Pro Tempore Duran spoke in support of allowing additional height up to 35' in the CC1 zone on the north side of Melrose Avenue adjacent to the West Hollywood Park, but spoke in opposition to any bonuses beyond 35'.

Mayor Heilman, Councilmember Land, Councilmember Horvath spoke in opposition to a 60' height limit across the entire parcel at the corner of

Santa Monica Boulevard and Melrose Avenue, but spoke in support of mixed-use development at the location.

Councilmember Land spoke regarding the parcel at the corner of Santa Monica Boulevard and Melrose Avenue, and in support of creating a gateway to the City at the location.

Councilmember Prang spoke in support of a maximum of 60' height, including bonuses at the parcel at the corner of Santa Monica Boulevard and Melrose Avenue.

ACTION: 1) Staff recommends that City Council hold a discussion of specific issues and information presented in the Land Use and Urban Form chapter of the Draft General Plan and provide direction to staff regarding these policies; 2) defer any discussion regarding signage issues to a meeting in January, 2011; and 3) Continue the public hearing to a date certain of December 20, 2010. **Carried by Consensus of the Council.**

4. UNFINISHED BUSINESS:

4.A. ADVANCEMENT OF THE ART AND ARTIST SELECTION PROCESS FOR THE CIVIC ART COMPONENT OF THE 25th ANNIVERSARY CAPITAL PROJECT - WEST HOLLYWOOD PARK AND NEW LIBRARY [J. HUFFER, A. CAMPBELL]:

The City Council will review recommendations of the Art Process Team and Arts and Cultural Affairs Commission for the selection of artists to design, fabricate and install public art works for the new West Hollywood Library.

Andrew Campbell, Cultural Affairs Administrator, provided background information as outlined in the staff report dated December 6, 2010.

JON BAILEY, WEST HOLLYWOOD, spoke in support of the Item.

BEVERLY DENENBERG, WEST HOLLYWOOD, spoke in support of the Item.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in opposition to the selection of artists for the West Hollywood Park and New Library.

Mayor Pro Tempore Duran thanked staff and the Arts Team for their work on the Item. He spoke in support of continuing to look for creative selections for art work for public projects. He requested staff to include information to Council regarding the longevity of outdoor murals when they return with the final location for the artwork by Shepard Fairey. He spoke in support of the Item.

Councilmember Horvath spoke in support of increasing the funding for the art work by Shepard Fairey to match the funding for David Wiseman.

Councilmember Prang spoke in support of the Item. He spoke regarding public comment surrounding the selection of artist Shepard Fairey, and spoke in support of the selection of Mr. Fairey.

Councilmember Land thanked staff and the Arts Team for their work on the Item. She spoke in support of the art work selection from artist David Wiseman. She spoke in support of having additional discussion regarding the location and design of the artwork by Shepard Fairey.

Mayor Heilman spoke in support of additional discussion regarding the design of the artwork by Shepard Fairey and the need for the artwork to stand the test of time. He thanked staff and the Arts Team for their work on the Item.

ACTION: 1) Approve David Wiseman as public artist to design, fabricate and install a public art work in the interior stairway and airspace above the interior stairway of the new West Hollywood Library in an amount not to exceed \$240,000 including fees and reimbursables; 2) Approve Shepard Fairey as public artist to design, fabricate and install a public art work at a location to be determined in an amount not to exceed \$100,000 including fees and reimbursables; 3) Direct staff to work with Shepard Fairey, the art consultant, the project design team and the Arts and Cultural Affairs Commission to initiate concepts and locations for the art and return to Council for review and approval of location; and 4) Authorize City Manager to negotiate, sign and execute the agreements for services for the two artists, and any documents or forms necessary for the successful implementation of this process and approve any minor modifications. Motion by Councilmember Land, seconded by Mayor Heilman and unanimously approved.

5. NEW BUSINESS:

5.A EVALUATION STUDY OF CITY-SUBSIDIZED TRANSPORTATION PROGRAMS [J. HEILMAN, F. SOLOMON, L. HORVATH, I. PINE, S. BAXTER, D. DENNIS, D. GIUGNI]:

The City Council will authorize staff to conduct an evaluation study of the City's subsidized transportation programs for Seniors and people living with disabilities.

ACTION: This Item was moved to the Consent Calendar as Item 2.0.

5.B. CO-SPONSORSHIP OF THE LAYERS OF LOVE HOLIDAY EVENT [L. HORVATH, I. PINE, J. PRANG, M. HAIBACH]:

The City Council will consider co-sponsoring the December 19, 2010, Layers of Love holiday gift-giving event.

Mayor Pro Tempore Duran spoke regarding the small number of children in Los Angeles County living with HIV and AIDS, and requested clarification regarding whether the charity is providing services only to children who are infected with HIV and AIDS, or whether it is open to children whose lives are impacted by HIV and AIDS.

Mayor Heilman spoke in support of requesting staff to investigate the charitable organization to determine more clearly what charity work they are doing.

ACTION: 1) Approve co-sponsorship of the Layers of Love Holiday Gift-Giving event to be held at Plummer Park's Great Hall on Sunday, December 19, 2010; 2) Waive venue fees; and 3) Authorize event organizers to utilize City's name and logo on printed materials advertising the event and ask Public Information Office to assist with community outreach; and 4) direct staff to more carefully investigate the charitable organization. **Motion by Councilmember Land, seconded by Councilmember Horvath and approved with Mayor Pro Tempore Duran ABSTAINING.**

EXCLUDED CONSENT CALENDAR:

2.L. PUBLIC SAFETY EDUCATION CAMPAIGN AND UPDATE ON PUBLIC SAFETY DEPLOYMENT [L. HORVATH, I. PINE, J. PRANG, M. HAIBACH]:

The City Council will receive an update on public safety holiday deployment provided by Captain Kelley Fraser and reinforce the public safety education campaign.

Kristin Cook, Public Safety Manager, and Lieutenant Honig from the West Hollywood Sheriff's Department provided background information as outlined in the staff report dated December 6, 2010.

JEANNE DOBRIN, WEST HOLLYWOOD, thanked the West Hollywood Sheriff's Department for their work to keep the City safe. She spoke regarding after-hours businesses in the City.

DARIN WEEKS, WEST HOLLYWOOD, spoke regarding a recent article in the Weho Daily regarding a possible surge in robberies in the City of West Hollywood.

ACTION: 1) Direct staff to continue to work with local businesses, residents, and neighboring jurisdictions to promote crime prevention and neighborhood livability; 2) Continue to educate the community through

Neighborhood Watch and the Public Safety Commission's "Live, Work, Play, Be Safe" campaign on robbery prevention and theft prevention; and 3) Give additional direction to staff as necessary. **Carried by Consensus of the Council.**

2.M. RESTRICTIONS ON SUPERSIZE LIMOUSINES [L. HORVATH, I. PINE, J. PRANG, M. HAIBACH]:

The City Council will consider directing Transportation Staff to work with Public Safety, Parking Services and the Office of the City Attorney to investigate restrictions on supersize limousines.

Mayor Heilman spoke regarding traffic and parking issues associated with supersize limousines, but spoke regarding the need to handle the Item sensitively to continue to promote events where people arrive in normal size limousines in the City. He spoke in support of lobbying the state to create legislation to ban supersize limousines statewide.

ACTION: 1) Direct Transportation Staff to work with Public Safety, Parking Services and the Office of the City Attorney to investigate restrictions against supersize limousines; and 2) Report findings and potential solutions to Council. Motion by Councilmember Land, seconded by Councilmember Prang and approved with Mayor Pro Tempore Duran voting NO.

PUBLIC COMMENT:

MICHAEL SIDLER, WEST HOLLYWOOD, spoke regarding her attendance and public comment at a City Council meeting in August of 2010.

ELYSE SHORE, WEST HOLLYWOOD, spoke regarding civil rights issues and a recent incident with the West Hollywood Sheriff's Department.

6. LEGISLATIVE: None.

COUNCILMEMBER COMMENTS:

Councilmember Horvath spoke regarding her upcoming visit to Columbus, Ohio and her visit to the Columbus, Ohio City Council to congratulate them on their recent approval of Domestic Partner benefits.
