Commissioner DeLuccio congratulated incoming Chair Yeber and Vice-Chair Guardarrama. He spoke of the recent passing of Steven Kanner, architect.

Commissioner Buckner congratulated incoming Chair Yeber and Vice-Chair Guardarrama. She spoke regarding rotation, which would give everyone the opportunity to serve in a leadership capacity for the Planning Commission.

Chair Yeber commended outgoing Chair DeLuccio for his service over the past year and thanked everyone for their support for the coming year.

#### 10. PUBLIC HEARINGS.

# A. 8575 Melrose Avenue (J. Gerard Design Studio Peace Gallery). Creative Sign Permit 2007-007:

Michael Barney, Assistant Planner, provided a visual presentation and background information as presented in the staff report dated Thursday, July 15, 2010.

He stated the proposal is a request for a unique sign, a type of sign that requires Planning Commission approval as a Creative Sign because it is otherwise not permitted by the Zoning Code, and because the requested sign exceeds the sign area permitted by the Zoning Code.

He detailed the current artwork, stating there are currently two roof signs, one awning sign, one wall sign, one window sign, one bulkhead sign, one sidewalk sign, and one entrance wall sign. The additional components of the sign request all incorporate a unique and creative composition of architectural detail.

Staff believes this proposal meets the necessary criteria for a creative sign because of the artfulness, sophistication and striking character of the signs. The signage is an aesthetic improvement.

It is conditioned so that no future signs may be placed in the public rightof-way and conditioned so that the retail store will be prohibited from using the roof-mounted sign frames for anything other than on-site advertising.

Staff recommends approval.

Commissioner Hamaker requested clarification regarding the approval timeframe.

Chair Yeber requested clarification regarding the number of signs. He questioned the total square footage of all the combined signage.

Michael Barney, Assistant Planner, stated all signs comprise approximately 800 square feet.

Commissioner DeLuccio questioned the signage on the sidewalk.

Commissioner Buckner had concerns with future signage and questioned the conditions of control if signage may not seem appropriate.

Commissioner Buckner disclosed for the record she made a drive-by site visit.

Commissioner Altschul disclosed for the record he made a drive-by site visit.

Commissioner DeLuccio disclosed for the record he made a drive-by site visit.

DAVID LASKY, WEST HOLLYWOOD, continued the applicants report, He spoke in support of the requested signage application.

JEANNE DOBRIN, WEST HOLLYWOOD, has concerns regarding this item. She spoke regarding the square footage and the aesthetics of the signage.

JULIA GERARD, WEST HOLLYWOOD, presented the applicants rebuttal. She spoke regarding the aesthetics of the signage and confirmed there would be no other advertising. She requested approval.

Chair Yeber had concerns with the square footage and the timelines of the application process. He stated he does not believe the amount of signage at this location fits into the urban design quality along that stretch of Melrose Avenue.

# B. 9000 Sunset Boulevard (Sunset Strip Music Festival). General Plan Consistency 2010-002:

Antonio Castillo, Associate Planner, provided a visual presentation and background information as presented in the staff report dated Thursday, July 15, 2010.

He presented a detailed history of the request and stated the proposal is a request to determine the General Plan Consistency for a city-initiated application to place a temporary special event sign as part of the Sunset Strip Music Festival (SSMF) on the east face of the existing parking structure.

Clarification was provided by staff regarding tall wall signage and banners. Also clarified and discussed were signage material, size, design and lighting issues.
