3.A. SUNSET OLIVE MIXED USE PROJECT AND ENVIRONMENTAL IMPACT REPORT, (DEVELOPMENT PERMIT 01-01, DEMOLITION PERMIT 01-01, CONDITIONAL USE PERMIT 01-01, GENERAL PLAN AMENDMENT 01-03 AND ZONING MAP AMENDMENT 01-01):

On May 3, 2005, the Planning Commission on a 4-2 vote (Hamaker and Guardarrama voting no, Bartolo absent) recommended denial of the mixed-use project proposed by Gold Mountain. The applicant has submitted a request to continue the item to a date uncertain.

RECOMMENDATION: Continue the public hearing to a date uncertain. Notice will be provided for the rescheduled item.

4. UNFINISHED BUSINESS:

4.A. PROPOSED ORDINANCE AMENDING SECTION 3.04.090 AND VARIOUS SECTIONS RELATED TO THE PENALTY FOR VIOLATING SECTION 11.36.010 OF THE WEST HOLLYWOOD MUNICIPAL CODE AND RESOLUTION RESCINDING RESOLUTION NO. 01-2561 AND ESTABLISHING A \$25,000 REWARD FOR EVIDENCE LEADING TO THE ARREST AND CONVICTION OF PERSONS WHO ILLEGALLY TRIM, REMOVE OR INJURE STREET TREES IN COMMERCIALLY ZONED DISTRICTS:

The City Council will consider an ordinance amending Section 3.04.090, West Hollywood Special Award Fund, and various sections related to the penalty for violating Section 11.36.010, Planting, Trimming, Removing or Injuring Trees and Other Plants – Permit Required, of the West Hollywood Municipal Code and adopting a resolution establishing a \$25,000 reward to any person who provides evidence that leads to the arrest and conviction of persons who illegally trim, remove or injure street trees in commercially zoned districts.

RECOMMENDATIONS: 1) Introduce on first reading Ordinance No. 05 - ______, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING SECTION 3.04.090 OF THE WEST HOLLYWOOD MUNICIPAL CODE AND VARIOUS SECTIONS RELATED TO THE

PENALTY FOR VIOLATING SECTION 11.36.010 OF THE WEST HOLLYWOOD MUNICIPAL CODE"; 2) Adopt Resolution No. 05-_____, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, RESCINDING RESOLUTION NO. 01-2561 AND ESTABLISHING A \$25,000 REWARD TO ANY PERSON WHO PROVIDES EVIDENCE THAT LEADS TO THE ARREST AND CONVICTION OF PERSONS WHO ILLEGALLY TRIM, REMOVE OR INJURE STREET TREES IN A COMMERCIALLY ZONED DISTRICT"; and 3) Authorize the City Manager to promulgate procedural rules and regulations governing receipt of the reward.

4.B. WEST HOLLYWOOD LIBRARY SCHEMATIC DESIGN:

The City Council will review and consider approving the West Hollywood Library Schematic Design and authorizing the design team to proceed with the project's Design Development Phase. The City Council will also consider proceeding with the design of a five level parking garage adjacent to the Library.

RECOMMENDATIONS: 1) Approve the Schematic Design and Cost Estimates of the West Hollywood Library; 2) Approve Add Alternates of LEED Silver Rating and Cable Television Area Build-out; 3) Approve the programming and design of the San Vicente level public meeting room; 4) Receive information on the 2006 Library Bond Act Initiative; 5) Review and consider proceeding with a five-level parking garage; and 6) Authorize the commencement of the project's Design Development Phase.

4.C. HYBRID VEHICLE LEASE/OWNERSHIP INCENTIVE/REWARDS PROGRAM:

The City Council will consider a pilot program offering incentives/rewards for the purchase or lease of hybrid vehicles.

RECOMMENDATIONS: 1) Adopt a pilot program to provide one or more incentives/rewards for West Hollywood residents to lease or purchase hybrid vehicles; and 2) Direct Transportation staff to return to Council with a full description of pilot program before implementation.

4.D. A RESOLUTION TO REQUIRE THE ANNUAL ROTATION OF BOARD AND COMMISSION CHAIRS AND VICE-CHAIRS:

The City Council will consider adopting a resolution to require the annual rotation of Board and Commission Chairs and Vice-Chairs.

RECOMMENDATIONS: 1) Adopt Resolution No. 05-_____, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD TO REQUIRE THE ANNUAL ROTATION OF BOARD AND COMMISSION CHAIRS AND VICE-CHAIRS"; and 2) Direct the City Attorney to amend Board and Commission by-laws as proposed.

5. NEW BUSINESS:

5.A. REPORT ON ENFORCEMENT AGAINST EXCESSIVE MOTORCYCLE NOISE:

The City Council will consider a strategy to address excessive motorcycle noise. Included are the Public Safety Division's proposed action plan, legal analysis regarding restraints on enacting local ordinances by the California Vehicle Code, and a summary of actions taken by other municipalities to address excessive noise.

RECOMMENDATION: Review and approve staff's work plan to address and actively enforce the State Vehicle Code and appropriately educate the public regarding excessive noise.

5.B. ESTABLISHMENT OF A NEIGHBORHOOD WATCH TRAINING ACADEMY:

The City Council will consider the establishment of a Neighborhood Watch Training Academy Program to assist neighborhood watch groups to effectively represent their neighborhoods and communicate effectively with City and City Staff.

RECOMMENDATION: Direct the Public Safety Commission to develop a program to effectively train neighborhood watch captains and participants in an annual Neighborhood Watch Academy Program.
