# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES TUESDAY, SEPTEMBER 6, 2005

#### **COUNCILMEMBER COMMENTS:**

Councilmember Guarriello spoke regarding Hurricane Katrina relief efforts and stated that now is the time to ensure the basic needs of the victims rather than assign blame.

Councilmember Prang spoke regarding public safety issues raised by public speaker Sibyl Zaden. He spoke regarding a fund-raising event at Hamburger Mary's. He requested staff be directed to investigate increasing resources for the urban art program. He commended his domestic partner in obtaining a teaching job with LAUSD. He spoke on relief efforts for Hurricane Katrina and the tragic response by FEMA.

Mayor Pro Tempore Heilman spoke regarding local business and resident efforts to organize relief for Hurricane Katrina. He spoke regarding local disaster preparedness and encouraged individuals to plan for their immediate needs in a disaster, i.e. water, food, medication.

Mayor Land praised the response of the West Hollywood community and urged citizens to examine their own emergency preparedness plans. She requested that the City Manager address the City's efforts for emergency preparedness.
