# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, MARCH 6, 2006 WEST HOLLYWOOD PARK AUDITORIUM

**CALL TO ORDER:** The meeting was called to order at 6:41 P.M.

### REPORT OF CLOSED SESSION AGENDA:

City Attorney Jenkins stated that the Closed Session convened at 6:00 P.M. He stated that there was one (1) public speaker. He stated that the Closed Session adjourned at 6:35 P.M. with no reportable action taken.

Mayor Land requested the meeting be adjourned in memory of Raymond Norton, a long-time West Hollywood resident, and in memory of Robert Sandoval, one of the first openly gay judges and ex-City Prosecutor.

Councilmember Prang also requested the meeting be adjourned in memory of Raymond Norton and Robert Sandoval; and requested the meeting be adjourned in memory of Joel Dorius, an openly gay educator, and in memory of Kyle Ballard, a Pasadena police officer who was killed in the line of duty.

Mayor Land presented cake to Councilmember Guarriello in honor of his birthday.

Mayor Land presented a proclamation in honor of Women's History Month and unveiled the Women's History Month banners in honor of Betty Friedan, Coretta Scott King, and Susan Sarandon.

ANDY HARLAND, WEST HOLLYWOOD, thanked the City Council for adjourning a previous meeting in memory of his father, and thanked the Council for their recent proclamation to St. Thomas Church in the City.

PAT DIXON, WEST HOLLYWOOD, spoke regarding safety concerns on Laurel Avenue near Carlton Manor.

RICHARD EASTMAN, WEST HOLLYWOOD, spoke regarding medical marijuana issues in the City and the former Medical Marijuana Task Force.

#### **COUNCILMEMBER COMMENTS:**

Councilmember Prang spoke regarding Item 2.I. and stated that an organization in the City has indicated plans to bring forward a similar initiative in an upcoming West Hollywood election. He spoke regarding the City's intention to continue to ensure proper enforcement of marijuana laws to protect citizens. He spoke regarding a streetlight malfunction on the corner of Sweetzer and Norton. He spoke regarding recent complaints about the lack of towing enforcement near the DeLongpre area in the City. He spoke regarding Carlton Manor and the need for the City to investigate safety concerns raised during public comment. He spoke regarding a crosswalk lighting at Crescent Heights and Norton that is not working properly.

Councilmember Guarriello thanked everyone for wishing him a happy birthday. He spoke regarding the need to find more affordable housing for seniors and the implementation of mixed-use housing to accomplish this goal. He spoke regarding a streetlight malfunction on Gardner Avenue and asked the City Manager to investigate.

Mayor Pro Tempore Heilman thanked City staff for their efforts in organizing the Academy Awards events in the City. He spoke regarding a recent complaint from a resident concerning a telephone failure at the Sheriff's Station and asked Public Safety staff to return to Council with an update on the situation. He spoke regarding safety concerns near Carlton Manor and asked staff to investigate possible solutions.

Mayor Land thanked City Staff for their efforts in organizing the Academy Awards events in the City. She spoke regarding the importance of repairing broken streetlights in the City, urged residents to inform City staff when they see a streetlight malfunction, and requested the City Manager to return to Council with a report about the process of having streetlights repaired. She requested staff to return to Council with a schedule and route outlining the parking enforcement process in the City. She spoke regarding safety concerns raised during public comment near Carlton Manor. She spoke regarding the City's compliance with the American Disabilities Act. She announced that West Hollywood is one of three cities to receive an American Disabilities Award. She spoke regarding a recent ban on abortion that was passed by the State of South Dakota. She requested the City Manager to give a report on a recent crime on Hayworth Avenue.

### **CITY MANAGER'S REPORT:**

City Manager Arevalo spoke regarding a recent abduction that occurred on Hayworth Avenue. He stated that the Los Angeles Sheriff's Special Crimes Unit is working with

the Los Angeles Police Department to investigate the crime. He stated that anyone with any information regarding the crime should contact the West Hollywood Sheriff's Department. He also stated that the Public Safety Department is currently working with the victim's family. He thanked City Staff and the community for hosting the Academy Awards events in the City. He stated that his office would work on having the streetlight malfunctions repaired in the City.

LYNN HOOPINGARNER, WEST HOLLYWOOD, spoke in opposition to the Item.

RICHARD GIESBRET, WEST HOLLYWOOD, spoke in opposition to the Item.

JAY JASPER, WEST HOLLYWOOD, spoke in opposition to the Item.

DAN SIEGEL, WEST HOLLYWOOD, spoke in opposition to the Item.

KEITH MENOHER, WEST HOLLYWOOD, spoke in opposition to the Item.

BRIAN ROSKAM, LOS ANGELES, spoke in opposition to the Item.

GUY STARKMAN, ENCINO, the property owner, spoke in support of the Item.

LAUREN MEISTER, WEST HOLLYWOOD, the appellant, provided rebuttal.

Mayor Land closed the public hearing.

Councilmember Prang spoke regarding the owner's past efforts to work with the City to resolve issues at Guy's Bar and Jerri's Famous Deli. However, he spoke in support of the appeal due to noise concerns and the loss of on-site parking spaces.

Mayor Pro Tempore Heilman spoke regarding a recent visit to the site and a recent meeting with the appellant. He spoke regarding concerns about noise issues in the neighborhood and concerns regarding the loss of onsite parking. He thanked the owner for past efforts to address and resolve concerns at Guy's Bar and Jerri's Famous Deli, but spoke in support of the appeal.

Councilmember Guarriello spoke regarding noise concerns with an outdoor patio in the rear of the building. He also spoke regarding concerns about the loss of on-site parking spaces. He spoke in support of the appeal.

Mayor Land spoke regarding a recent site visit and spoke regarding concerns about noise and loss of on-site parking. She spoke in support of the appeal.
