

**CITY COUNCIL
MINUTES
MONDAY, MARCH 15, 2004
WEST HOLLYWOOD PARK**

CALL TO ORDER: The meeting was called to order at 6:35 PM.

PLEDGE OF ALLEGIANCE: Rachel White led the pledge.

ROLL CALL: PRESENT: Councilmember Guarriello, Heilman, Land, Mayor Pro Tempore Duran and Mayor Prang.

ABSENT: NONE.

ALSO PRESENT: City Manager Paul Arevalo, City Attorney Michael Jenkins, City Clerk Tom West and Assistant City Clerk Gwen Peirce.

REPORT OF CLOSED SESSION AGENDA:

City Attorney Jenkins stated that the Closed Session convened at 6:00 PM. He stated that one item of initiation of litigation was added. He stated that there was one reportable action, which was that the City filed and served a civil lawsuit seeking damages against individuals who mutilated City trees on Sunset Boulevard. He stated that the Closed Session adjourned at 6:30 PM.

Councilmember Heilman requested that Item 6.A. be moved to the Consent Calendar as Item 2.U.

Councilmember Guarriello noted his No vote on Item 2.I.

Mayor Pro Tempore Duran requested that the meeting be adjourned in the memory of the mother of Chris Worland, City Hall employee.

Councilmember Heilman requested that the meeting be adjourned in the memory of Roy Werbel, father of Lee Werbel.

Councilmember Land requested that the meeting be adjourned in the memory of Marty Witkin, father of Janet Witkin.

Mayor Prang requested that the meeting be adjourned in the memory of Mina, the mother of Sofia Komskaya, Tichi Kassel, the wife of Arthur Kassel, and the Spanish citizens who were killed in the recent bombing in Madrid.

STAN LOTHBRIDGE, WEST HOLLYWOOD, spoke in opposition to the proposed project at 1343 N. Laurel Avenue, and stated that the project is not consistent with Vision 2020.

LIZ BAKUISKI, WEST HOLLYWOOD, spoke in opposition to the proposed project at 1343 N. Laurel Avenue.

RICHARD SMITH, WEST HOLLYWOOD, spoke in support of motorists following traffic laws, specifically speed limits.

TOM CARLOCK, LOS ANGELES, representative of Adelphia Cable, spoke regarding the changes that have been implemented at Adelphia over the past year.

PEARSON BROWN, LOS ANGELES, spoke regarding problems she encountered while dealing with the Rent Stabilization Department.

TOM HILTE, WEST HOLLYWOOD, spoke in support of the proposed project at 1343 N. Laurel.

COUNCILMEMBER COMMENTS:

Councilmember Guarriello requested that the inspections at Palm View be investigated.

Councilmember Land spoke regarding the upcoming Women's March in Washington and encouraged participation.

Councilmember Heilman spoke with concern regarding the recent inspections at Palm View and requested more information from staff on those inspections. He expressed his appreciation to the staff and volunteers that made the Book Fair a success, and mentioned the upcoming Book Fair. He requested further information from the Rent Stabilization Department regarding the issue that was expressed during public comment. He also spoke regarding the Town Hall Forum on Same Sex Marriage and expressed his interest in including the Lesbian & Gay Advisory Board on that Forum. He provided an update of the recent League of California Cities meeting. He also

spoke regarding an initiative that California cities are putting on the November ballot to prevent the State from taking money from cities.

Mayor Pro Tempore Duran spoke regarding his attendance at the upcoming League of California Cities subcommittee meeting on revenue and taxes. He requested that staff provide further information on the inspections at the Palm View Apartments. He stated that no final decisions have been made on the proposed project at 1343 N. Laurel Avenue.

Mayor Prang spoke regarding the lack of funds of the federal government's Section 8 voucher program. He also spoke regarding misinformation that has been generated regarding same sex marriages, and provided an update on what the City has accomplished during this debate.

City Manager Arevalo stated that he will work with staff to provide an update on Palm View Apartments. He announced a \$1 million grant that the City was awarded for the development of affordable housing.


