CITY COUNCIL MINUTES MONDAY, JANUARY 5, 2004 WEST HOLLYWOOD PARK

CALL TO ORDER: The meeting was called to order at 6:35 PM.

PLEDGE OF ALLEGIANCE: Gloria Goldsmith led the pledge.

City Attorney Jenkins stated that Closed Session convened at 6:00 PM. He stated that two items of threats of potential litigation were added to the agenda. He stated that the Closed Session recessed with no reportable action taken. He stated that a previous Closed Session had authorized an action on the lawsuit, Wildan vs. City of West Hollywood.

Mayor Prang introduced Author Ryan Gierach, who presented the City Council and the Friends of the Library copies of his book, *Images of America – West Hollywood*.

1. PUBLIC COMMENT:

RIC RICKLES, WEST HOLLYWOOD, spoke in support of Item 2.N., the agreement with the West Hollywood Orchestra.

HILARY SELVIN, LOS ANGELES, spoke in support of Item 2.J., the Streamlining Task Force.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of installing a taxi stand in front of Mickey's on Santa Monica Boulevard.

RICK REIDY, LOS ANGELES, spoke on behalf of Jerry Qonsul of Checker Cab to apologize for his behavior at the December 1, 2003 City Council meeting. He spoke in opposition to a decision made the meeting because of errors made in the staff report provided. He requested that Council agendize an Item addressing these issues.

RICHARD SMITH, WEST HOLLYWOOD, spoke regarding the touching Veteran's Memorial event. He also spoke regarding drivers who block intersections.

CATHERINE HAHN, WEST HOLLYWOOD, spoke regarding the illegal cutting of trees on Sunset Boulevard.

RYAN GIERACH, WEST HOLLYWOOD, announced a segment on Life & Times on Tuesday night regarding the his book on West Hollywood.

COUNCILMEMBER COMMENTS:

Councilmember Guarriello spoke regarding his "Don't Drink & Drive" napkin campaign over the holidays and the importance of designated drivers.

Councilmember Land announced a West Hollywood delegation for "March for Women's Life" that will be taking place in April. She requested that the City Manager speak regarding the next steps on the illegal tree trimming. She also requested that an item be agendized at the end of this year to re-visit the "grace period" for parking permits.

Mayor Prang announced a town hall meeting co-hosted by Jackie Goldberg and a property tax seminar for domestic partners being hosted by John Chiang on February 10th.

CITY MANAGER'S REPORT:

City Manager Arevalo spoke regarding the illegal tree trimming on Sunset Boulevard and stated that he spoke with Captain Long regarding the photographs and information

provided by a constituent and will pursue legal action. He announced that his Assistant, Bryan Cook is leaving the City for another opportunity.

FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk West stated that the fiscal impact for the Consent Calendar is \$0 in expenditures and \$26,583 in potential revenue.

4. UNFINISHED BUSINESS:

4.A. DRAFT PLAN BY WEST HOLLYWOOD COMMUNITY HOUSING CORPORATION TO IMPLEMENT RECOMMENDATIONS OF PALM VIEW AND HARPER COMMUNITY NEEDS ASSESSMENT:

Jeffrey Skorneck, Housing Manager, provided background information as outlined in the staff report dated January 5, 2004.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of the work of the West Hollywood Community Housing Corporation and Palm View Apartments.

BEN JOSEPH, WEST LOS ANGELES, read a letter from Marcia Smith, who spoke in opposition to the West Hollywood Community Housing Corporation.

DAVID NASH, WEST HOLLYWOOD, spoke in support of staff looking at the portion of the report which emphasizes social services providers.

DAVID JOSEPH, WEST HOLLYWOOD, spoke in support of the Needs Assessment, but expressed his concern over certain changes being done by the West Hollywood Community Housing that are not consistent with the recommendations of the needs assessment, specifically changes in office hours.

PRISCILLA LEVINE, LOS ANGELES, Actors Fund, spoke regarding residents of Palm View who are clients of the Actors Fund are provided social services case management, as well as numerous other benefits. She stated that the Actors Fund has been work in close collaboration with the West Hollywood Community Housing Corporation.

FRED ARREGUI, WEST HOLLYWOOD, spoke in support of the West Hollywood Community Housing Corporation.

DAVID SMITH, WEST HOLLYWOOD, spoke regarding the Council supporting the tenants of Palm View rather than the West Hollywood Community Housing Corporation. He spoke regarding moving the current resident manager to another building.

TROY BOLSTAD, WEST HOLLYWOOD, spoke in support of having a RSC available but not necessarily on-site.

THOMAS MANN, WEST HOLLYWOOD, President of West Hollywood Community Housing Corporation spoke regarding the work that has been done in the Needs Assessment process. He emphasized that it is a collaborative effort. He announced an upcoming Town Hall meeting.

SETH ENGBER, WEST HOLLYWOOD, spoke in support of the work of the West Hollywood Community Housing Corporation at Palm View Apartments.

TODD ELLIOTT, spoke regarding the work that has been done in the Needs Assessment process. He emphasized that importance of including the residents' input and constantly reviewing the report.

Councilmember Land spoke in support of the report being a constantly evolving document. She expressed her concern over the sense of distrust between some of the residents and the management at Palm View. She spoke in support of forming a Resident Advisory Board at Palm View. She spoke regarding the importance of the management working with the Resident Advisory Board on issues where there are disagreements and the importance of looking at the Resident Advisory Board as a training ground for future West Hollywood Community Housing Corporation Board members. She spoke regarding the importance of allowing residents their privacy when they request it.

Councilmember Guarriello spoke in opposition to the Needs Assessment and waiting until April for implementation. He expressed his concern over the management of the West Hollywood Community Housing Corporation.

Mayor Pro Tempore Duran stated that the people living in Palm View and Harper Apartments are in varying stages of HIV/AIDS, so a blanket approach would not be effective. He expressed concern over designating a specific social services provider due to different people's needs. He spoke regarding the balance between medical privacy and residents who are suffering from dementia. He spoke in support of the West Hollywood Community Housing Corporation and the City alerting medical/social service providers of those needing assistance. He also spoke regarding finding different ways of evaluating success, such as quality of life issues rather than measuring deaths that occur. He stated that this document is a work in progress, and spoke in support of leaving the provision of services to the social services providers rather than the West Hollywood Community Housing Corporation and the City Council.

Councilmember Heilman spoke in support of staff's recommendation of receiving the report. He spoke in support of Palm View and the West Hollywood Community Housing Corporation's work. He spoke regarding Palm View being an independent living model and varying individual needs and expectations of the tenants.

Mayor Prang spoke in support of the report and spoke in support of bringing in Resident Services Coordinator into the City's Social Services grant funding.

ACTION: 1) Receive and file the draft report of the West Hollywood Community Housing Corporation entitled "Going One Step Further: A Plan by West Hollywood Community Housing Corporation to Implement the Recommendations of Needs Assessment — City of West Hollywood Housing for People with HIV and AIDS;" and 2) Direct WHCHC to submit an update on implementation of this Plan by April 2004. Moved by Councilmember Heilman, seconded by Councilmember Land and unanimously approved.

Councilmember Heilman expressed concern over the process of awarding the grants. He spoke in support of a peer review process. He spoke in support of reducing the funding for the MAK Center and awarding more money to the performing arts groups.

Councilmember Land spoke in support of the Arts and Cultural Affairs Commission discussing the funding process at their upcoming retreat. She also requested that the Arts and Cultural Affairs Commission also discuss the overall strategic goal of granting funds. She spoke in opposition to awarding more money to certain groups without reviewing the proposals.

Mayor Pro Tempore Duran spoke in support of fully funding the schools and finding further funds to award grants to other groups.

Mayor Prang spoke in support of the Arts & Cultural Affairs Commission's recommendation. He expressed concern over allocating more money in light of the current budget problems.

ACTION: 1) Approve the recommendations of the Arts and Cultural Affairs Commission to award 2003-2004 Arts Grants to the following organizations: Gay Men's Chorus (\$2,900); Israel Film Festival/Israfest (\$1,000); MAK Center (\$7,500); Mladi Chamber Orchestra (\$2,000); Sundays Live (\$500); United Arts Academy (\$2,500); Vox Femina Los Angeles (\$2,900); West Hollywood Chorale (\$2,900) and Women Playwrights Outreach Project (\$800); 2) Approve the recommendations of the Arts and Cultural Affairs Commission to award 2003-2004 Arts Awareness Grants to Friends of Rosewood (\$1,000) and West Hollywood Elementary School (\$1,000).
