# CITY COUNCIL MINUTES TUESDAY, SEPTEMBER 2, 2003 WEST HOLLYWOOD PARK AUDITORIUM

CALL TO ORDER: The meeting was called to order at 6:31 PM.

PLEDGE OF ALLEGIANCE: Arich Berghammer led the pledge.

### REPORT OF CLOSED SESSION AGENDA:

### APPROVAL OF AGENDA:

Councilmember Guarriello requested that Item 2.F. be moved to Excluded Consent.

Staff requested that Item 4.A. be moved to be heard directly following the Community Development Commission Agenda.

Mayor Prang requested that the meeting be adjourned in the memory of Harriet McElroy Luckman.

ACTION: Moved by Mayor Pro Tempore Duran and seconded by Councilmember Land and unanimously carried to approve the September 2, 2003 agenda as amended.

JAMES FUHRMAN, WEST HOLLYWOOD, spoke in opposition to the Council's decision regarding Regency Billboard appeal and spoke regarding campaign contributions.

ANDREW SOUSA, WEST HOLLYWOOD, spoke regarding the Global AIDS crisis.

WARREN MILLER, WEST HOLLYWOOD, spoke in opposition to condominium development.

TOM DEMILLE, WEST HOLLYWOOD, spoke regarding National and State political issues.

DONALD DELUCCIO, WEST HOLLYWOOD, spoke regarding the Democrat of the Year award that was presented to Barbara Boxer by the West Hollywood Democratic Club. He also spoke regarding the Governor's recall election and spoke regarding an upcoming public forum regarding the recall election.

NORMAN CHRAMOFF, WEST HOLLYWOOD, spoke regarding free testing for prostate cancer. He also spoke in opposition to Proposition 54. He also announced that the Stonewall Democratic Club is opening a special office for the Anti-Recall effort.

JW MOORE IV, WEST HOLLYWOOD, spoke in support of Item 2.I., opposition to Proposition 54. He also spoke regarding another hate incident involving Trev Broudy. He also spoke in support of Item 4.A., the issuance of bonds for the Redevelopment Agency.

### **COUNCILMEMBER COMMENTS:**

Councilmember Guarriello commended the Sheriff's Captain and the COPS Team for their great work on Sunset Boulevard.

Councilmember Land spoke regarding an upcoming town hall meeting regarding Proposition 54.

Councilmember Heilman announced an upcoming Human Rights Speakers Event, "Voices from the Front Lines," regarding the AIDS crisis in Africa. He also announced the upcoming West Hollywood Book Fair on September 21, 2003. He also announced the Westside Economic Collaborative that is going to be hosted by the West Hollywood Chamber of Commerce. He also spoke regarding the sausage carts and directed that

the City Manager follow-up with the speaker who spoke regarding the carts and research the City's efforts of enforcement with the carts. He also spoke regarding development of condos and directed staff to discuss the development of condominiums during General Plan discussion.

Mayor Pro Tempore Duran requested that the City Manager investigate the Gateway Church at Santa Monica Boulevard near La Brea because of the debris caused by the homeless meal program and requested that the City Manager bring back a report on its clean up to Council. He also requested that the City Manager look into the jewelry stands on Santa Monica Boulevard and whether or not they are in compliance. He also spoke regarding developing new development and development of affordable housing. He also spoke regarding the defendants in the Trev Broudy case who plead guilty in a plea bargain agreement. He also spoke regarding an upcoming town hall meeting regarding the State bill regarding domestic partnership benefits. He also spoke in support of the West Hollywood Chamber of Commerce.

Mayor Prang spoke in opposition to the hot dog carts due to public health hazards and problems with regulating the public health standards. He thanked and commended Ina Bliss, who recently resigned from the Rent Stabilization Commission. He spoke regarding a Domestic Partnership benefits legislation that was adopted by Los Angeles County. He also acknowledged the Sheriff's Department for their work on issuing tickets to bicyclists on sidewalks. He also requested that as the homeless are being addressed at the Gateway Church that PATH assists in their needs. He also announced an upcoming fundraising event for Trev Broudy.

Anil Gandhy, Director of Finance, provided background information as outlined in the staff report dated September 2, 2003.

ACTION: 1) Adopt Resolution No. 03-2952, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING BY THE WEST HOLLYWOOD ISSUANCE COMMUNITY DEVELOPMENT COMMISSION OF NOT TO EXCEED \$12,500,000 AGGREGATE PRINCIPAL AMOUNT OF WEST HOLLYWOOD COMMUNITY DEVELOPMENT COMMISSION **EAST** SIDE REDEVELOPMENT PROJECT 2003 TAX ALLOCATION BONDS. AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO;" and 2) Authorize the Director of Finance to execute bond documents necessary to issue the bonds, provided that the bond size does not exceed \$12.5 million, the interest rate does not exceed 7% per annum. the bond discount does not exceed 1.25% of the bond principal, and the bond term does not exceed 30 years. ### 5. NEW BUSINESS:

# 5.A. 2003-2004 SERVICE AGREEMENT WITH THE WEST HOLLYWOOD COMMUNITY HOUSING CORPORATION AND PLAN TO ADDRESS RECOMMENDATIONS OF NEEDS ASSESSMENT IN 2003-2004 WORK PROGRAM:

Jeff Skorneck, Housing Manager, provided background information as outlined in the staff report dated September 2, 2003.

PAUL ZIMMERMAN, LOS ANGELES, Executive Director of the West Hollywood Community Housing Corporation, spoke in support of the agreement.

THOMAS HALSTEAD, WEST HOLLYWOOD, spoke in support of staff's recommendation and requested that residents at Palmview and Harper be involved in the planning and implementation process.

BARBARA HAMAKER, WEST HOLLYWOOD, spoke in support of the agreement.

TODD ELLIOT, WEST HOLLYWOOD, spoke regarding positive changes occurring on the Community Housing Board and an upcoming retreat. He spoke in support of staff's recommendation.

DAVID NASH, WEST HOLLYWOOD, spoke regarding issues involving the board of the West Hollywood Community Housing Corporation.

TOM DEMILLE, WEST HOLLYWOOD, spoke regarding problems with the West Hollywood Community Housing Corporation Board.

BEN JOSEPH, LOS ANGELES, presented a speech by his father who lives in the Palmview Apartments regarding problems with the West Hollywood Community Housing Corporation Board.

THOMAS MANN, WEST HOLLYWOOD, President of the West Hollywood Community Housing Corporation, spoke in support of the agreement.

GERALD BOYCE, WEST HOLLYWOOD, spoke in support of the agreement, but had concerns about implementation.

Councilmember Heilman spoke in support of increasing communication efforts between the WHCHC and the residents. He also expressed concern regarding coordination with residents and service providers. He spoke in support of the Board conducting their own fundraising and requested that it would be added to the Scope of Service.

Mayor Pro Tempore Duran spoke regarding the history of long-term hospice care vs. independent living for people living with HIV/AIDS and spoke regarding the importance of such facilities. He spoke about the possibility of having an orientation program for new residents, such as a "Buddy" Program. He also spoke in support of staff meeting with the Actors' Fund to review the model. He also spoke in support of an annual review of the City's model to ensure that the latest technology and information is reflected.

Councilmember Land spoke in support of periodic review of the model. She also spoke in support of the WHCHC Board working on "capacity building." She also requested that an implementation report return to Council in three months.

Councilmember Guarriello spoke in support of the implementation of the report. He expressed concern about the early office hours of the resident manager of Palmview Apartments.

Mayor Prang spoke in support the agreement and plan moving forward with Council's recommendations. He spoke regarding the special needs the residents of Palmview Apartments.

ACTION: 1) Approve a service agreement with the WHCHC in the amount of \$225,000 to provide operational support for the Corporation, with the additional provision that WHCHC will prepare a plan as part of its 2003-2004 work program to address recommendations contained in the Palm View and Harper Community Apartments Needs Assessment; and 2) Authorize the City Manager to execute the agreement. Motion by Mayor Pro Tempore Duran, seconded by Mayor Prang and unanimously carried with additional direction to add that board development and fundraising be included in the contract and add that staff return in 3 months to report on implementation of the recommendations of the Housing Report.

ACTION: Introduce on first reading Ordinance No. 03-663, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD REGARDING CITY COMMISSIONS AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion by Councilmember Heilman, seconded by Councilmember Guarriello and unanimously carried.

### **COUNCILMEMBER COMMENTS:**

Mayor Pro Tempore Duran expressed concern that one meeting in October could be cumbersome and suggested rescheduling the first meeting in October if it was necessary. He also requested that the City Manager provide a report to Council regarding the LaJolla-Havenhurst Parking Lot.
