David Wilson, Development Specialist, provided background information as outlined in a staff report dated February 3, 2003.

Mayor Guarriello opened the public hearing and the following speaker came forward:

J.W. MOORE, IV, WEST HOLLYWOOD, spoke in support of the funding for the Sanfair Bus Stop Garden.

Mayor Guarriello closed the public hearing.

ACTION: 1) Approve the use of \$75,000 in unallocated FY 2002-2003 CDBG funds for construction of the SanFair Bus Stop Garden & Pocket Park Project; 2) Authorize the City Manager to execute a contract with the Los Angeles County Community Development Commission for use of the funds; and 3) Authorize the Director of Finance and Technology to increase budgeted revenues and expenditures in the CDBG Fund (281-6050-9652) by \$75,000 (281-0000-5102 and 281-6050-9652); in the Grant Fund revenue and expenditure accounts by \$62,000 (204-000-xxxx and 204-6050-9652); to increase expenditures in the Public Art and Beautification by \$15,000 (account 220-6050-9652; and increase the Redevelopment Agency Fund expenditures by \$10,000 (360-6050-0652).   - 5.A. PROPOSED ORDINANCE MANDATING LANDLORDS TO INSTALL INTERCOM SYSTEMS ON ALL GATED RESIDENTIAL RENTAL PROPERTIES:

Mayor Guarriello gave background information as outlined in the staff report dated February 3, 2003.

Councilmember Heilman stated that he supports the item, but would like the Rent Stabilization Department and Public Safety staff to take time to research this item and bring back their recommendations. Councilmember Duran stated that before the Item is passed, it should be analyzed by the Rent Stabilization Department and Commission.

ACTION: Direct the City Attorney to draft an ordinance mandating landlords to install intercoms on gated residential rental properties. Moved by Councilmember Duran, seconded by Councilmember Prang and unanimously carried with additional direction to direct the Item to the Rent Stabilization Department and the Rent Stabilization Commission for further study and public comment.

#### 2.I. "ART ON THE OUTSIDE":

Alison Maxwell, Economic Development Director, provided background information as outlined in the staff report dated February 3, 2003.

Councilmember Heilman expressed his concern with the Hedges and Edges project and that there was no coherent theme between the artwork. He requested that in the future that the art items be connected by a similar theme. He also stated his concern that all items that the Fine Arts Commission also be approved by Council. He also spoke regarding displaying existing artwork as opposed to commissioning artwork.

Councilmember Duran stated that he would not agree that the Council have final approval of artwork.

ACTION: Receive report and ratify the Fine Arts Commission decision to continue with the development of the "Art on the Outside" program as described in this staff report. Moved by Councilmember Prang, seconded by Mayor Guarriello and unanimously carried with additional direction that future staff reports outline each art concept program for approval by the City Council.

## 2.O. A PROPOSAL TO CREATE "SAFE HAVEN HOTLINE" BUMPER STICKERS FOR ALL CITY VEHICLES:

Donna Saur, Council Deputy to Mayor Guarriello, provided background information as outlined in the staff report dated February 3, 2003.

Mayor Pro Tempore Martin expressed his concern that there are too many stickers on the City vehicles.

Councilmember Heilman stated that the staff should have a policy of how stickers are placed on City vehicles.

ACTION: Direct staff to print and place the Safe Haven Hotline bumper stickers on all city vehicles and if permissible, include our West Hollywood Sheriff's Department's patrol cars. Motion by Councilmember Heilman, seconded by Mayor Guarriello and unanimously carried with additional direction to Sam Baxter, Facilities and Landscape Manager, to create a policy for placement and/or removal of public service announcements (bumper stickers) on City vehicles.

PAUL DE ANGELIS, WEST HOLLYWOOD, spoke regarding noise complaints about UP.
