CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, MAY 20, 2002 WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Guarriello called the meeting to order at 7:10 P.M.

PLEDGE OF ALLEGIANCE: John Chase led the pledge.

ROLL CALL:

PRESENT: Councilmember Duran, Heilman, Prang, Mayor Pro Tempore

Martin and Mayor Guarriello.

ABSENT: None.

ALSO PRESENT: City Attorney Mike Jenkins, City Manager Paul Arevalo, City

Clerk Russell and Assistant City Clerk Taylor.

REPORT OF CLOSED SESSION AGENDA:

City Attorney Jenkins stated that the closed session convened at 6:00 P.M. Council added two items to the Closed Session Agenda: one item of Initiated Litigation; and one item of Pending Litigation, Beverly Boulevard vs. City of West Hollywood. The meeting adjourned at 7:05 P.M. with no reportable action.

APPROVAL OF AGENDA:

Mayor Pro Tempore Martin requested that the recommendation to Item 2.F. be expanded to include a budget and timeline for sponsorship.

Councilmember Heilman requested that Item 2.S. be moved to Excluded Consent and he noted his Abstention on Item 2.I. He also requested that the meeting be adjourned in memory of Ann Swimmer.

Councilmember Prang noted his Abstention on Item 2.1. and his No vote on Item 2.T.

ACTION: Moved by Councilmember Heilman and seconded by Mayor Guarriello to approve the May 20, 2002 agenda as amended. Motion carried unanimously.

PRESENTATIONS:

Councilmember Heilman presented a commendation to Rabbi Lisa Edwards of the Beth Chayim Chadashim for its 30th Anniversary.

Mayor Guarriello presented a proclamation to Sharon Perlstein and Joan English proclaiming May 19th through 25th as Public Works Week.

Mayor Guarriello presented a special award to Sharon Perlstein for excellence in transportation.

PUBLIC COMMENT:

LAURA FRAKES, LOS ANGELES, spoke in support of Item 2.F.

KEN SHERMAN, WEST HOLLYWOOD, spoke in support of Item 2.F. He also stated that the Book Fair would bring writers together to share their experiences with the residents of West Hollywood.

RITA NORTON, WEST HOLLYWOOD, spoke in support of Item 2.F.

COLEEN HOLLIS, WEST HOLLYWOOD, spoke in support of staff's recommendation on Item 2.Q.

GILBERT BAKER, WEST HOLLYWOOD, thanked Council for their commitment to display rainbow flags along Santa Monica Boulevard.

DAVID NASH, WEST HOLLYWOOD, spoke in support of Item 4.A.

TOM DEMILLE, WEST HOLLYWOOD, spoke regarding the continued use of the West Hollywood Independent for public noticing.

RICK ANDREWS, WEST HOLLYWOOD, spoke regarding the design change at the intersection of Westbourne Drive and Santa Monica Boulevard.

ANDY HARLAND, WEST HOLLYWOOD, spoke in support of Item 4.A.

MARCY DILLINGER, WEST HOLLYWOOD, stated that there is continued traffic gridlock on Sunset Boulevard and Horn Avenue.

JAMES FUHRMAN, WEST HOLLYWOOD, spoke regarding the cancellations of City Council meetings through the summer months. He also spoke regarding expenses that occurred at the City's sponsored Oscar Party.

RIC RICKLES, WEST HOLLYWOOD, spoke in support of Items 2.F., 2.G., 2.K. and in opposition to staff's recommendation on Item 2.T.

COUNCILMEMBER COMMENTS:

Councilmember Prang thanked the Human Services Department staff on the successful AIDS ride. He also spoke against the change in membership requirements of the Russian Advisory Board. He directed the City Manager to provide a report on the foliage at the Santa Monica Boulevard and Westbourne Drive intersection.

Councilmember Duran spoke regarding the Russian Advisory Board membership requirements. He also addressed concerns regarding the displaying of rainbow flags along Santa Monica Boulevard and the traffic circulation on Westbourne Drive and Santa Monica Boulevard.

Mayor Pro Tempore Martin directed the Community Development Department to set up a meeting between representatives of the Arglye Hotel and the White House on De Longpre to address various issues. He also requested staff to provide a report to Council on the cost of the Russian art exhibit at Plummer Park.

Councilmember Heilman directed staff to look into a fallen traffic sign at Santa Monica Boulevard and La Cienega on the eastside. He also directed staff to survey the medians and crosswalks along Santa Monica Boulevard for foliage obstructing visibility and he directed staff to bring back to Council the cost of the book fair and major sponsor list.

Mayor Guarriello announced two events on Memorial Day, West Hollywood Park Barbecue and the 9th Annual Richard Settle Remembrance Memorial. He also spoke regarding how the City will be posting public notices on the City Channels and the City's website. He requested that the City Manager provide an update on the proposed parking structures.

CITY MANAGER'S REPORT:

City Manager Arevalo spoke regarding the City's upcoming budget and stated that the budget would be presented to Council at the first meeting in June. He also addressed the banner situation and stated that he directed staff to place banners strategically along Santa Monica Boulevard

FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk Russell stated that the fiscal impact on the Consent Calendar as amended for Monday, May 20, 2002 is \$542,748 in expenditures and \$530.748 in potential revenue.

Approved as part of the Consent Calendar with Councilmember Prang voting NO.

SPECIAL SUMMIT WITH LOS ANGELES UNIFIED SCHOOL DISTRICT: ACTION: 1) Direct staff to schedule a summit meeting with representatives of Los Angeles Unified School District; 2) Invite LAUSD Board member who will be representing the West Hollywood area after redistricting is complete with key LAUSD staff including the principals of the schools serving West Hollywood; and 3) Develop an agenda for the meeting in conjunction with LAUSD staff which includes the following topics: a) joint improvements and use of LAUSD facilities in and around West Hollywood; b) expanding and standardizing after-school programs at local schools; c) expanding, enhancing and standardizing other

3. PUBLIC HEARINGS:

3.A. APPEAL OF PLANNING COMMISSION DENIAL OF A REQUEST TO MODIFY CONDITIONAL USE PERMIT 2001-16; TO ALLOW A TALL WALL SIGN AT 8590 SUNSET BOULEVARD (WEST ELEVATION):

RECOMMENDATION: Accept the applicant / appellant request to continue this item until June 17, 2002.

ACTION: Moved by Councilmember Heilman and seconded by Mayor Guarriello to approve staff's recommendation and directed staff to re-notice this item. Motion carried unanimously.

3.B. REVIEW OF DAYTIME PARKING REGULATIONS IN PREFERENTIAL PARKING DISTRICTS 1 AND 3:

City Clerk Russell stated that this item was posted at City Hall, Plummer Park, Sheriff's Station, and West Hollywood Library on May 6, 2002.

Don Korotsky, Associate Transportation Planner, provided background information as outlined in the staff report dated May 20, 2002.

In response to Councilmember Duran, Mr. Korotsky stated that the C permits are exclusively employee parking.

Mayor Guarriello opened the Public Hearing and the following speakers came forward:

ALEXANDER STELSKINSKI, BEVERLY HILLS, requested that Council table the item for 30 days to have both the residents and business owners work out their differences.

STACY HUNT, LOS ANGELES, requested a meeting between the residents and businesses owners concerning the parking issue.

HILLARY SELVIN, LOS ANGELES, spoke in support of staff's recommendation.

LAUREN MIESTER, WEST HOLLYWOOD, spoke regarding several conditions, which were presented by West Hollywood West Association concerning District 1.

JANET COLE, WEST HOLLYWOOD, spoke regarding the lack of parking on Rangley Drive and stated that parking should be allowed on both sides of the street in her neighborhood.

DOUG BERNARD, WEST HOLLYWOOD, spoke regarding the need for balance between residential and commercial parking. He also spoke in opposition to staff's recommendation.

GIANPIERO DOEBLER, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

ROBERTO GOROSTIETA, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

STEVE KELLAM, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

DENNIS CLARK, WEST HOLLYWOOD, spoke regarding the four types of parking on Bonner Drive.

DAN SIEGLE, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

RICHARD GIESBRET, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

ERNEST BREIG, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

ROSE MARIE ZAFFINA, WEST HOLLYWOO, spoke in opposition to staff's recommendation.

RICHARD BLONS, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

TERRY LEFTGOFF, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

ROD MCDONALD, WEST HOLLYWOOD, thanked Council for addressing the parking issues and spoke in support of staff's recommendation for District 3.

JEAN MATHISON, WEST HOLLYWOOD, spoke in support of staff's recommendation for District 3.

DONALD DELUCCIO, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

Mayor Guarriello closed the public hearing.

Councilmember Duran stated that both Districts 1 and 3 have some of the same problems but are distinct in nature. He stated that staff's recommendation concerning District 3 should move forward. He also stated that the staff's recommendation concerning District 1 should be readdressed and the process should be worked out between the residents and business owners.

Mayor Pro Tempore Martin suggested separating the Districts and approving District 3. He stated that he felt that many of the issues could be worked out. He also suggested that staff investigate charging more for commercial permits.

Councilmember Prang stated the he is pleased with the direction staff has moved in addressing parking issues. He also stated that District 1 residents and business owners need to work out a solution, which is agreeable to both sides.

Councilmember Heilman stated that commercial parking in the West Hollywood West area is not a determinant to the community. He also stated that the residents and business owners need to work together to find an agreeable solution.

Mayor Guarriello stated that parking has always been an issue within the City. He also stated that both residents and business owners in District 1 need to be willing to compromise a little to provide a possible solution to the parking situation.

Mayor Pro Tempore Martin suggested that the parking impacts should be spread throughout the entire District 1 not just on one or two streets.

RECOMMENDATION: 1) Direct staff to draft an ordinance, revising the daytime parking restrictions in Preferential Parking District 1 pending a motion by the City Council to adopt the recommendation and/or alternatives, provided in the report; 2) Direct staff to draft an ordinance, revising the daytime parking restrictions in Preferential Parking District 3 pending a motion by the City Council to adopt the recommendations and/or alternatives, provided in the staff report; 3) Direct staff to work with the Transportation Commission to develop an ordinance which would establish a new pricing structure, set limits on the number of commercial parking permits sold in each district, and create policy incentives that would discourage the proliferation of commercial parking permits on

streets most heavily impacted; and 4) Direct staff to work with the Transportation Commission to develop an ordinance to allow the use of commercial parking permits at underutilized meters in Preferential Parking District 1.

ACTION: Moved by Mayor Pro Tempore Martin and seconded by Councilmember Heilman to approve staff's recommendation concerning parking District 3 and referred District 1 back to staff to meet with the residents and business owners to develop recommendations agreeable to both sides and directed staff to publicly notice all residents of District 1 and place the item on the July 15, 2002 agenda for Council action. Motion carried unanimously.

3.C. GENERAL PLAN AMENDMENT 02-01 HOUSING ELEMENT:

City Clerk Russell stated that this item was posted at City Hall, Plummer Park, Sheriff's Station, and West Hollywood Library on May 2, 2002.

Tim Foy, Senior Planner, provided background information as outlined in the staff report dated May 20, 2002.

Mayor Guarriello opened the Public Hearing and the following speaker came forward:

TOM DEMILLE, WEST HOLLYWOOD, spoke regarding the need for affordable housing for seniors and those living with a disability.

Mayor Guarriello closed the public hearing.

RECOMMENDATION: Adopt Resolution No. 02-2697, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ADOPTING THE HOUSING ELEMENT OF THE GENERAL PLAN."

ACTION: Moved by Mayor Guarriello and seconded by Councilmember Duran to approve staff's recommendation. Motion carried unanimously.

4. UNFINISHED BUSINESS:

4.A. HOLLOWAY PARK AND VETERANS MEMORIAL PROJECT:

Sam Baxter, Facilities and Landscape Manager, provided background information as outlined in the staff report dated May 20, 2002.

In response to Mayor Pro Tempore Martin, Mr. Baxter explained that \$500,000 dollars has been designated for the project from the Santa Monica Boulevard Redevelopment Project Fund.

In response to Councilmember Duran, Mr. Baxter explained that option 4 would have additional costs and future components to the project would increase its overall cost.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of staff's alternative number 5.

STAN LOTHRIDGE, WEST HOLLYWOOD, spoke in opposition to the Veterans Memorial project.

ROSLYN KRAUSE, WEST HOLLYWOOD, spoke in opposition to the Veterans Memorial project.

DOUGLAS CAMPBELL, SANTA BARBARA, spoke in support of the project.

G.G. VERONE, LOS ANGELES, spoke in opposition to the Veterans Memorial project.

JEAN MATHISON, WEST HOLLYWOOD, spoke in opposition to the Veterans Memorial project.

Councilmember Heilman stated that the Council needs to reject the bid that was received. He also stated that a possible hybrid between option 3 and 5 could be an alternative to the project.

Councilmember Prang stated that option 5 would be an immediate way to provide greenspace in the community.

Mayor Pro Tempore Martin stated that the Council should approve option 5 and refer the item back to the Public Facilities Commission to readdress the project's over all design.

Councilmember Duran stated that the City should honor its veterans but trying to find a balance is the most difficult part. He stated that option 3 would be the best alternative for the community.

RECOMMENDATION: Discuss options and provide direction to staff regarding construction of the Holloway Park and Veterans Memorial Project.

ACTION: Moved by Councilmember Prang and seconded by Councilmember Duran to reject the bid and directed staff to create a hybrid project incorporating elements from option 3 and option 5 as outlined in the staff report and schedule the item on the June 17, 2002 City Council agenda. Motion carried with Mayor Pro Tempore Martin voting NO.

5.A. COMMISSION AND ADVISORY BOARD APPOINTMENTS AND REAPPOINTMENTS:

Tony Russell, City Clerk, provided background information as outlined in the staff report dated May 20, 2002.

Disability Advisory Board (one at-large appointment); 3). Public Facilities Commission (one direct appointment Councilmember Prang); and 4). Women's Advisory Board (one at-large appointment).
