PROPOSED RESOLUTION THAT WOULD MAKE BOTH THE RAINBOW LOGO AND THE BLUE AND WHITE LOGO ACCEPTABLE FORMS OF THE CITY'S OFFICIAL LOGO:

Donna Saur, Deputy to Mayor Pro Tem Guarriello and Sheriff Don Mueller, provided background information as outlined in the staff report dated May 7, 2001.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of keeping the rainbow logo.

IVY BOTTINI, WEST HOLLYWOOD, spoke in support of diversity and the rainbow logo as the official logo of the City.

MORRIS KIGHT, WEST HOLLYWOOD, spoke in support of the rainbow logo.

City Manager Arevalo stated that the Sheriff's Department is proud to use whatever logo is approved by the City Council.

Mayor Heilman questioned why the Public Safety Commission was involved in the review rather than the Fine Arts Commission.

City Manager Arevalo stated that originally the item was brought by a Councilmember specifically requesting that the City Council give direction for the rainbow logo to be put on the Sheriff vehicles. The Sheriff's department had to order new decals. He further stated that Mayor Heilman was correct and that there are better avenues to approach if the consideration is to change the logo.

Councilmember Prang commented that the resolution does not deal with Sheriff's vehicles.

Mayor Pro Tem Guarriello commented that the logo chosen will be on all the City vehicles, including the Sheriff vehicles.

Councilmember Martin commented on the history of the Sheriff's Department in the City of West Hollywood and the history of the introduction of the rainbow logo by the former City Manager, Charlie McKinney. He further stated his support for the rainbow logo.

Mayor Heilman stated his support for one logo, not two. He commented that it doesn't make sense to have staff faced with the decisions to chose

which logo for stationary, city vehicles etc. Substantively, with respect to the rainbow logo it is apparent that the rainbow is a symbol of "Gay Pride" but not appropriate for a City logo since there is a growing population of Jews, Russians and a growing Hispanic population. The rainbow flag elevates one group over all of the others and it sends the incorrect message when the City is reflective of diversity.

Councilmember Duran commented that he understood the different issues being presented and he knew Gilbert Baker who designed the rainbow flag, which was a symbol of diversity. He suggested that the logo is the map of the City and that it could be colored and represent many different cultures and maintain the integrity of the logo.

Councilmember Prang commented that the way that the logo is recorded with the Secretary of State does not indicate a specific color, it states that the color of the logo is typically a dark background with white squares.

ACTION: Adopt Resolution No. 01-2502, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD MAKING BOTH THE RAINBOW LOGO AND BLUE AND WHITE LOGO ACCEPTABLE FORMS OF THE CITY'S OFFICIAL LOGO." Motion Councilmember Prang, seconded by Councilmember Martin and carried, noting the NO vote of Mayor Heilman and the Abstention of Councilmember Duran.

4.A. PROFESSIONAL SERVICE CONTRACT WITH DOWNTOWN RESOURCES TO DEVELOP A BUSINESS IMPROVEMENT DISTRICT (BID) FOR SUNSET BOULEVARD:

Alison Maxwell, Development Specialist III, provided background information as outlined in the staff report dated May 7, 2001.

HILLARY SELVIN, LOS ANGELES, Executive Director of the West Hollywood Chamber of Commerce, spoke in support of this item.

KEVIN MCCARNEY, BURBANK, spoke in support of the project and the item.

Councilmember Prang commented that the program is a resident based program and have the business community come together to mitigate the concerns that have had the largest impact on the residents.

Councilmember Martin directed the City Manager to return with a game plan to work on trash issues, noise issues and public safety issues prior to the bid being put in place. Councilmember Guarriello commented on the clubs being the most problematic.

ACTION: 1) Authorize the City Manager to execute an Agreement for Services with Downtown Resources for a sum not to exceed \$59,800, and authorize the City Manager or his designee to approve amendments to the Agreement as needed up to 10% of the contract total; and, 2) Receive a short verbal presentation by Downtown Resources. Motion Councilmember Duran, seconded by Councilmember Martin and unanimously carried.

4.B. SUBLEASE FOR FIRE STATION #7 WITH LOS ANGELES COUNTY FIRE DISTRICT:

Paul Arevalo, City Manager provided background information as outlined in the staff report dated May 7, 2001.

ACTION: 1) Approve the revised Sublease dated February 1, 1998 with the Los Angeles County Fire District for Fire Station #7 and authorize the Mayor to execute all related documents; 2) Authorize the Interim Director of Finance to appropriate \$540,000 of accrued capital interest from reserve for Capital Projects to account 340-1012-9250; and, 3) Authorize staff to initiate the development plan of old fire station #7 in accordance with the terms specified in the agreement. Motion Councilmember Martin, seconded by Mayor Pro Tem Guarriello and carried, noting the Abstention of Councilmember Duran.

4.C. DIRECT APPOINTMENT TO BUSINESS LICENSE COMMISSION BY MAYOR PRO TEMPORE GUARRIELLO:

ACTION: Mayor Pro Tempore Guarriello appointed James Kazakos to the Business License Commission.

THE CITY COUNCIL RECESSED AT 8:55 P.M. THE CITY COUNCIL RECONVENED AT 9:15 P.M.

5. NEW BUSINESS:

5.A. APPEAL BY LEONARD AND CO. OF PLANNING COMMISSION'S DECISION TO DENY BILLBOARD PERMIT NO. 2000-38 AT 8853 SUNSET BOULEVARD:

Jack McGee, Contract Planner, provided background information as outlined in the staff report dated May 7, 2001.

Monica D. Witt, of Jeffer, Mangels, Butler & Marmaro LLP, representing Leonard and Company, the Appellant, argued that the staff erred and argued as to why the sign met the intent of the Sunset Specific Plan as a billboard. She also offered on behalf of her client banners for the City in upcoming City events.

Councilmember Duran Using a building as a creative billboard

Mayor Heilman asked why didn't the applicant apply for a permit before putting the sign on the wall.

Monica Witt said that this sign did not require a permit and she argued that this kind of a sign did not require a permit.

RON McIVER, WEST HOLLYWOOD, stated his support for the American Cancer Society, and supported the sign.

LISA CHISHOLM LOS ANGELES, stated her support for the American Cancer Society and she commented that the sign would help the community in general.

Rebuttal, Monica Witt stated that the sign was put up without the permit but it did not need the permit, and that the sign met the expressed purpose of the plan and if the Council determined that the sign was providing a benefit to the City, Leonard and Company would like to give back signs to the community and the American Cancer Society.

Councilmember Duran stated that it is clearly a sign, with offsite advertising and as such under the Sunset Specific Plan it fails to meet the minimum qualification of 5000 square feet for this kind of advertisement.

Councilmember Martin stated that it qualifies as a sign and it draws your eye to the building instead of the empty lot.

Mayor Pro Tem Guarriello commented that he denies the appeal.

Mayor Heilman commented that the Sunset Specific Plan prohibits signs unless they are specifically approved and the general policy of the City is to prohibit offsite advertising.

ACTION: 1) Deny the appeal; and, 2) Adopt Resolution No. 01-2503,"A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DENYING THE APPEAL OF LEONARD AND COMPANY AND UPHOLDING THE PLANNING COMMISSION'S DECISION TO DENY BILLBOARD PERMIT (BB) 2000-38 FOR THE PLACEMENT OF A BILLBOARD AT 8853 SUNSET BOULEVARD, WEST HOLLYWOOD CALIFORNIA."

Motion Mayor Pro Tem Guarriello, seconded by Councilmember Prang and unanimously carried.

5.B. RE-ALLOCATION OF A PORTION OF THE CITY'S 1999/2000 LOCAL LAW ENFORCEMENT BLOCK GRANT FUNDS FOR USE BY THE SHERIFF'S SUNSET DEPLOYMENT TASK FORCE:

ACTION: Authorize the expenditure not to exceed \$60,000 from the fiscal 1999/2000 Local Law Enforcement Block Grant (LLEBG) program grant allocation for use by the West Hollywood Sheriff's Station on the Sheriff's Sunset Boulevard Deployment Task Force. Motion Councilmember Duran, seconded by Councilmember Martin and carried, noting the Abstention of Councilmember Prang.

5.C. SUNSET MILLENNIUM ASSOCIATES STANDARD BILLBOARD PERMITS 99-01 AND 99-02 ON THE MIDDLE PARCEL:

Mayor Heilman recused himself from the discussion, and left the dias.

Ray Reynolds, Project Director, provided background information as outlined in the staff report dated, May 7, 2001.

Attorney Cindy Starrett, of Latham and Watkins, and Mark Seffin, the developer reported on the lease agreements of the retail portion and stated that the sixth floor is almost completely leased. The parking for the middle parcel is being constructed on the west parcel

ROSEMARY MINSKI, WEST HOLLYWOOD, spoke in support of the item.

THELMA JACKSON, WEST HOLLYWOOD, spoke in support of the item.

MICHAEL EPSTEIN, SANTA MONICA, policing agent for the project, spoke in support of the item.

JAMES LITZ, WEST HOLLYWOOD, Vice President of Government Affairs for the West Hollywood Chamber of Commerce, spoke in support of the item.

Councilmember Duran questioned approving the billboards for the middle parcel prior to erecting the middle parcel building.

Cindy Sterrit stated that the approval is required to seek the financing needed to complete the middle parcel and generate revenue.

Councilmember Martin stated concerns regarding the City's benefits in approving the billboards

Development agreement payment plus if the billboards could remain for 10 years that in that event the City would still receive the on the sixth

anniversary of erecting the billboards. Assured the City that a bond would be posted.

Councilmember Prang stated that the work so far is commencement of construction and stated concerns that they might be there longer than the agreement and want to move the project as quickly as possible cautioned and admonished bringing the project back over and over again.

Mayor Pro Tem Guarriello spoke in support of the item.

City Attorney Jenkins suggested that the Council either use the time period the rights are vested in the property or the time period the tentative map is vested is still alive and not a set number of years. Tied to the vesting of the development agreement or the vesting map Mike stated the vesting map as a choice Vesting map for the tentative parcel.

Martin voted for the maximum amount of time.

Councilmember Duran stated his concern in making an exception whereas this developer is allowed to pull permits to erect billboards and perhaps not break ground for three years. He noted his NO vote.

ACTION: 1) Except as is provided for below, the billboards shall remain in place throughout demolition of existing improvements on the Middle Parcel and construction of the SMA project in accordance with Development Agreement No. 99-01 and the project approvals referenced therein; 2) The billboards may remain in place on the site for the time period during which Vesting Tentative Tract Map 99-01 remains in force. If SMA has not substantially completed the project on the Middle Parcel as described in Development Agreement No. 99-01 and the project approvals referenced therein by the time its rights to complete the project under Vesting Tentative Tract Map No. 99-01 have expired, then the City has the right to require SMA to remove the billboards; 3) Should SMA fail or refuse to remove the billboards immediately upon receipt of a direction from the City to do so as provided in paragraph 2 above, then the City shall have the right to enter upon the property and remove the billboards at SMA's sole cost and expense. The cost of removal shall constitute a debt due and owing the City; 4) The billboard building permits are conditioned on the posting of a bond in the amount of \$250,000, in a form acceptable to the City Attorney, the proceeds of which shall be available to the City upon demand to reimburse the City for any costs of removal of such billboards in the event such removal is required by the City pursuant to these Conditions, and SMA fails or refuses to remove them; 5) The issuance of the billboard building permits are conditioned on the waiver of rights regarding advertising under state law, including without limitation the Outdoor Advertising Act, which might otherwise prevent the City from

removing such billboards without compensation; and, 6) As consideration to the City in the event these billboards remain on the site without substantial completion of the Middle Parcel project by the sixth anniversary of erecting the billboards, SMA will assure that the Public Benefit Payment of \$1,733,000 required by the Development Agreement will be paid on or before such sixth anniversary date. Security to guarantee such payment will be provided in the form of a bond or other alternative security satisfactory to the City Attorney.

Motion by Councilmember, seconded by Mayor Pro Tem Guarriello and carried on a Roll Call Vote.

AYES: Martin, Prang, Guarriello.

NOES: Duran.

ABSTENTION: Heilman.

EXCLUDED CONSENT CALENDAR:

2.V. SUNSET BOULEVARD AND HARPER AVENUE - REQUEST FOR PEDESTRIAN TRAFFIC SIGNAL CONTROL:

Mayor Heilman stated concerns that the when the pedestrian crosswalk was approved it staff stated that it was safe to do so.

Director English stated that after inspecting and surveying the traffic on Sunset Boulevard it was determined that the volume of pedestrians crossing the street was prohibiting cars from moving forward and causing some unanticipated traffic congestion.

ACTION: 1) Adopt Resolution No. 01-2504, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DESIGNATING THE MID-BLOCK LOCATION OF SUNSET BOULEVARD EAST OF HARPER AVENUE AS A PEDESTRIAN TRAFFIC SIGNAL CONTROL LOCATION AND DIRECTING STAFF TO ERECT APPROPRIATE TRAFFIC CONTROL DEVICES AND MARKINGS"; 2) Authorize the City Manager to execute a supplemental agreement for Purchase Order 2001-0248 (Katz, Okitsu and Associates) to increase the not to exceed amount \$10,000, to a total amount of \$95,000 for the purpose of signal and intersection design and implementation work; and, 3) Authorize the Interim Finance Director to transfer \$10,000 from CIP account number 100-8030-9425 to account #100-8040-8501. Motion Councilmember Martin, seconded by Mayor Pro Tem Guarriello and unanimously carried.

2.Z. PROFESSIONAL SERVICES AGREEMENT WITH DESIGN TEAM FOR SANTA MONICA BOULEVARD FURNITURE PLACEMENT AND ADDITIONAL LANDSCAPING:

Councilmember Prang stated his concern regarding community input, especially for people with special needs.

Hassan Haghani, Acting Planning Manager, stated that two community meetings are scheduled to receive input while processing the designs.

Councilmember Prang suggested that the Disabilities Advisory Board and the Senior Advisory Board be included in the meetings.

Mayor Heilman commented that in previous years the members of the public have been invited to come out and try the furniture and vote on the different prototypes after sitting on it.

Councilmember Martin requested that bike racks be incorporated in the plans.

ACTION: 1) Approve the proposed amendment to the Professional Agreement with Zimmer Gunsul Frasca Partnership in an amount not to exceed \$69,790 for the development of additional landscape improvements for Santa Monica Boulevard, based on processes and procedures set forth in the proposed contract; and, 2) Authorize the City Manager to execute the contract. Motion Councilmember Martin, seconded by Mayor Pro Tem Guarriello and unanimously carried.

PUBLIC COMMENT: None.

6. LEGISLATIVE:

6.A. PROPOSED ORDINANCE AMENDING THE MUNICIPAL CODE RELATIVE TO PARKING ON GRADES:

Vit Vittatoe, Parking Manager, provided background information as outlined in the staff report dated May 7, 2001.

Councilmember Martin proposed raising the grade to 6%, reduce the fine to \$24.00 and change the signage.

Councilmember Prang recommended reducing the fine to even less than \$24.00.

Councilmember Duran recommended to keep the ordinance as it is.

Mayor Heilman recommended to stop enforcing the ordinance period. He further stated that the statistics do not reflect the City of West Hollywood but nationwide and the number of run away vehicles are minor. He stated that this is a misappropriation of funds that is of minor concern to the residents of the City.

Mayor Pro Tem Guarriello commented that the ordinance should remain in effect.

ACTION: 1) Introduce on first reading Ordinance No. 01-595, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD PROHIBITING VEHICLES TO PARK ON GRADES OF SIX PERCENT OR MORE WITHOUT TURNING THEIR WHEELS TO THE CURB AS POSTED AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE" and, 2) Adopt Resolution No. 01-2505, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING THE NEW PARKING SIGNS FOR PARKING ON GRADES, AUTHORIZING THE REPLACEMENT OF EXISTING PARKING ON GRADES SIGNS, AND AUTHORIZING THE INSTALLATION OF NEW SIGNAGE ON ALL STREETS WITH GRADES OF SIX PERCENT OR MORE;" 2) Direct staff to return on May 21, 2001 with a resolution reducing the fine to \$24.00. Motion Councilmember Martin, seconded by Mayor Pro Tem Guarriello and carried on a Roll Call vote:
