Councilmember Martin spoke about the permit being a temporary use permit for eleven (11) years. He stated that Cedars Sinai created a neighborhood eyesore. He recognize that Cedars Sinai has a legal right to Ellis out. He spoke about a need for appropriate zoning for this site.

Mayor Pro Tempore Heilman stated that he thought that there was a fear on what the future of this lot will be. He stated that Cedars Sinai is a great medical institution. He stated that developing a plan with Cedars Sinai and the residents and what would be the best use of this property. He spoke in opposition of placing a hotel at this location. He spoke in support of a complaint line for the residents. He expressed a need to work forward with a win-win situation.

Mayor Prang spoke about the need for a process that includes confidence. He stated that this is a neighborhood land use issue. He spoke in support of the recommendation of the Planning Commission.
