# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, FEBRUARY 5, 2001 WEST HOLLYWOOD PARK

**CALL TO ORDER:** Mayor Prang called the Meeting to order at 7:05 PM.

ACTION: 1) Approve an annual budget for the Human Rights Speakers Series; 2) Approve plans for future speaking events; and, 3) Direct staff to assist in organizing future speaking events. Motion Councilmember Guarriello, seconded by Councilmember Martin and unanimously carried.

#### 5. NEW BUSINESS:

### 5.A. RECOGNITION FOR SAME SEX COUPLES IN LONG TERM RELATIONSHIPS:

Howard Jacobs, Deputy to Mayor Prang, provided background information as outlined in the staff report dated February 5, 2000.

**ACTION:** 1) Direct the Recreation Division and Special Events staff to work with the Lesbian Gay Advisory Board in developing an annual ceremony recognizing same sex couples in long term relationships; 2) Direct the City Clerk's office to develop an application for Domestic Partners who shall be eligible for this recognition: 3) Direct the City Clerk's office to identify same sex couples on the City's Domestic Partnership registry who have been together for at least ten (10) years and mail notification for this recognition with an application to eligible persons; 4) Direct the Public Information Office to develop an appropriate commendation to be used in recognizing same sex couples in relationships of ten (10) to twenty-four (24) years and a larger scroll for same sex couples in relationships over twenty-five (25) years; and, 5) Direct the Public Information Office to develop a media campaign publicizing this annual recognition and ceremony of long term same sex couples. Motion Councilmember Martin, seconded by Councilmember Guarriello and unanimously carried.

#### **5.B. CREATION OF TRANSGENDER TASK FORCE:**

Howard Jacobs, Deputy to Mayor Prang, provided background information as outlined in the staff report dated February 5, 2001.

SHIRLEY BUSHNELL, WEST HOLLYWOOD, spoke in support of this Item.

IVY BOTTINI, WEST HOLLYWOOD, Member of the Gay and Lesbian Advisory Board.

CLINT TROUT, WEST HOLLYWOOD, spoke in support of this Item.

EMILIA LOMBARDI, WEST HOLLYWOOD, spoke in support of this Item.

SANDRA CROCKETT, HOLLYWOOD, spoke in support of this Item.

LORI NORMAN, LOS ANGELES, spoke in support of this Item.

JOEY LABARINTO, WEST HOLLYWOOD, spoke in support of this Item.

Mayor Pro Tempore Heilman spoke in support and asked for a Public Hearing to broaden the input from the Community.

ACTION: 1) Direct the City Manager to create a Transgender Task Force within sixty (60) days of passage of this item; and, 2) Direct the Task Force to report back with recommendations to the Lesbian and Gay Advisory Board on issues impacting the transgender community within six (6) months of it's first meeting. Motion Mayor Pro Tempore Heilman, seconded by Councilmember Guarriello and unanimously carried.

### 5.D. RECONSIDERATION OF RESOLUTION NO. 00-2421, SAFER SEX ACT:

No staff report was provided but Councilmember Martin spoke of the need for clarification.

HILLARY SELVIN, LOS ANGELES, Executive Director of the West Hollywood Chamber of Commerce, spoke in support of Proposition A.

IVY BOTTINI, WEST HOLLYWOOD, Member of the Gay and Lesbian Advisory Board, spoke in support of Proposition A.

CLINT TROUT, WEST HOLLYWOOD, spoke in support of Proposition A.

Mayor Pro Tempore Heilman spoke about campaign filings.

MORRIS KIGHT, WEST HOLLYWOOD, spoke about letting the public decide and advised the Council not to take any action.

GED KENSLEA, WEST HOLLYWOOD, AIDS Healthcare Foundation, spoke in support of Proposition A.

BOB HEYDT, WEST HOLLYWOOD, spoke in opposition of Proposition A.

JEFF BAILEY, LOS ANGELES, Director of Education of the Los Angeles Gay and Lesbian Center, spoke in opposition of

Proposition A.

MICHAEL NEIMEYER, WEST HOLLYWOOD, Co-Owner of Micky's, spoke in opposition of Proposition A.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of condom distribution but is opposed to Proposition A.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of condom distribution but is opposed to Proposition A.

Councilmember Martin spoke about what is practical and to avoid political games.

Mayor Pro Tempore Heilman spoke in opposition of the Condom Initiative. He spoke about the false conception being presented by the AIDS Healthcare Foundation. He also spoke about the current volunteer program and about extending the program to heterosexual and lesbian communities. He stated that he is supportive of condom distribution.

Councilmember Guarriello spoke about budget concerns and the increasing inflation rates. He stated that Proposition A is unnecessary and an unfair burden on the businesses.

ACTION: 1) Rescind Resolution No. 01-2451 to rescind Resolution No. 00-2421; 2) City of West Hollywood supports the Condom Distribution Program but is in opposition of Proposition A. Motion Mayor Pro Tempore Heilman, seconded by Councilmember Guarriello and carried noting the ABSENTION of Mayor Prang.

Councilmember Guarriello was excused at 10:55 PM

#### **5.E. CITY SPECIAL EVENTS CONCEPT UPDATE:**

Dan Laray, Special Events Coordinator, provided background information as outlined in the staff report dated February 5, 2001.

City Manager Arevalo provided additional information to what was presented in the staff report dated February 5, 2001.

Mayor Pro Tempore Heilman spoke in support of a Santa Monica Boulevard Opening Event such as a Street Festival. He spoke in opposition of a separate Russian Street Festival but, that it could be integrated into the larger Street Festival. He asked for sponsors to include but not be limited to just alcohol. He suggested others sponsors such as credit card companies. He supports a New

Year's Eve but, not what was presented in the report.

Councilmember Martin agreed with Mayor Pro Tempore Heilman's comments. He spoke of construction fatigue that the residents are suffering from after two (2) years of construction of Santa Monica Boulevard.

Mayor Prang spoke about the annual Halloween event. He expressed concerns over public safety. He spoke in opposition of the New Year's Event. He spoke in support of the Russian Street Festival.

KATHY WATT, LOS ANGELES, Van Nuys Recovery House, spoke about the non-alcoholic event that is held on New Year's Eve.

ACTION: 1) Approve the following events as outlined a) the Santa Monica Boulevard Opening: August 18-19, 2001; b) Halloween Carnaval (with additional elements) October 31, 2001; and, c) New Year's Eve Event: December 31, 2001; 2) Grant approval for the Convention and Visitors Bureau to seek funding including existing City event sponsors as well as procuring new major sponsors; and, 3) Approve the securing of alcohol sponsors relative to these three (3) events. By Consensus of the City Council.

### 5.F. CERTIFICATION OF MUNICIPAL ELECTION RESULTS AND COUNCIL REORGANIZATION EVENTS AND ACTIVITIES:

City Manager Arevalo, provided background information as outlined in the staff report dated February 5, 2000.

Assistant City Clerk Taylor provided clarification on the dates of the election and the certification of the election.

Mayor Pro Tempore Heilman spoke about the need to have those who are elected involved.

**ACTION:** 1) Approve Alternative No. 2 as outlined in the staff report with one modification that the Council reorganization Meeting to be held on Monday, April 23, 2001 as a Special Meeting. **By Consensus of the City Council.**
