MINUTES
MONDAY, SEPTEMBER 18, 2000
WEST HOLLYWOOD PARK**

CALL TO ORDER: Mayor Prang called the Meeting to order at 7:45 PM.

PLEDGE OF ALLEGIANCE: Steve Wayland led the Pledge.

ROLL CALL:

PRESENT: Councilmembers Guarriello, Heilman, Mayor Pro Tempore Koretz and Mayor Prang.

ABSENT: Councilmember Martin.

ALSO PRESENT: City Attorney Jenkins, City Manager Arevalo, Acting Assistant City Clerk Bell, Records Management Coordinator Nunley and Administrative Staff Assistant Bursztin.

APPROVAL OF AGENDA:

Staff requested to Table Items 5.A. and 6.A. Mayor Prang requested to leave Item 6.A. on the Agenda.

Mayor Prang requested to table Item 2.P. to the meeting of October 2, 2000 under Unfinished Business. He also requested that Item 2.J. be pulled for separate discussion under Excluded Consent Calendar.

Councilmember Heilman pulled Items 2.G, 2.H., and 2.M. for separate discussion under Excluded Consent Calendar.

Mayor Pro Tempore Koretz requested to add an Urgency Item to the Agenda titled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD IN SUPPORT OF AB 2522 (SHELLY), ASSISTING WITH THE COMMUTING NEEDS OF THE PUBLIC."

PRESENTATIONS:

Councilmember Heilman presented proclamations to the Los Angeles Alzheimer's Association 8th Annual "Memory Walk" and to the Los Angeles Valley Pride Festival coordinators.

Councilmember Martin's Council Deputy, Sarah Bradshaw presented a commendation to Estelle Milmar, who is celebrating her 99th Birthday.

The Lesbian and Gay Advisory Board presented the Rainbow Key Award to Steve Wayland of PAWS-LA.

PUBLIC COMMENT:

JAMES FUHRMAN, WEST HOLLYWOOD, spoke about the equipment in the Public Access Department being broken, the position of Public Access Coordinator not being filled, commented on a previous statement to a public speaker and Mayor Prang's recent travel.

JOYCE ROONEY AND TIM FOY, AFSCME Local 3339, spoke about an Impasse on contract negotiation and discussed the two key issues; working out of class and health care insurance and the flexible benefit plan.

MICHAEL YATES, LOS ANGELES, provided an update on Christopher Street West.

JANET WITLIN, WEST HOLLYWOOD, Executive Director of the Alternative Living for the Aging, spoke about affordable housing needs for seniors.

ESTHER SCHILLER, LOS ANGELES, Project Director of Smoke Free Apartment Housing Registry, spoke in support of the ordinance on smoke free apartments

CAROL RODRIGUEZ, WEST HOLLYWOOD, spoke about problems with the Summer Sounds Concerts.

JEROME CLEARY, WEST HOLLYWOOD, spoke about a recent shooting on Robertson Boulevard.

SHIRLEY BUSHNELL, WEST HOLLYWOOD, spoke about transgender victims of crime in the City of West Hollywood.

COUNCILMEMBER COMMENTS:

Councilmember Guarriello spoke about Lenny Krayzelburg's recent Olympic Victory. He also spoke about the Bill Clinton Street Sign still being up and about low fees for sanitation. He also spoke about families at Plummer Park not being able to set-up blankets for picnic due to gambling.

Councilmember Heilman announced the start of the new West Hollywood Orchestra season. He spoke about the report on smoke free apartments. He also spoke about transgender communities needs and recent crimes against them. He suggested a smaller working group to address these problems.

Mayor Pro Tempore Koretz also thanked Esther Schiller for her report and survey on smoke free apartments.

Mayor Prang spoke about adding the Urgency Item to the Consent Calendar on the murder reward and wanted to remind people that these acts of violence are not common and responses are very aggressive. He also spoke about the needs of Seniors regarding to affordable housing. He spoke about the federal subsidy for the Section 8 Program achieved by Senator Feinstein. He also spoke about Shelia Kuehl's recent visit from Sacramento.

CITY MANAGER'S REPORT: Acting City Manager Long reported on the ongoing MTA strike and how rides are being provided for rides for those who are disabled.

Councilmember Heilman spoke about extending the hours of the City Shuttle service.

West Hollywood Sheriff Captain Castro provided an update on the recent murder on Robertson Boulevard and spoke about the \$10,000 reward.

FISCAL IMPACT ON CONSENT CALENDAR: Acting Assistant City Clerk Bell stated that this fiscal impact on the Consent Calendar of September 18, 2000 as amended is \$63,786 in expenditures and \$27,956 in potential revenue.

MARK OLSON, LOS ANGELES, spoke in support of this Item.

SHARON O'ROAKE, LOS ANGELES, Public Affairs Manager for the Gas Company, asked the Council for acknowledgement of being the City's franchise and spoke in opposition of this Item.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke about the workers on the job not caring about the quality of the work they perform.

Councilmember Guarriello asked if the City has had a problem with the Gas Company and if not, could they be exempted.

Public Information and CATV Manager Goss stated that the City needs to keep the playing field even and fair to all providers.

City Engineer Perlstein stated that the City has had problems in the past with Southern California Edison.

Councilmember Heilman stated that these guidelines are designed to protect the public right-of-way and the public in general. He spoke about the hours of work being set from 8 AM to 5 PM but, nighttime might be better depending on the project.

Mayor Prang spoke about the roundabout on Harper Avenue and Delongpre Avenue.

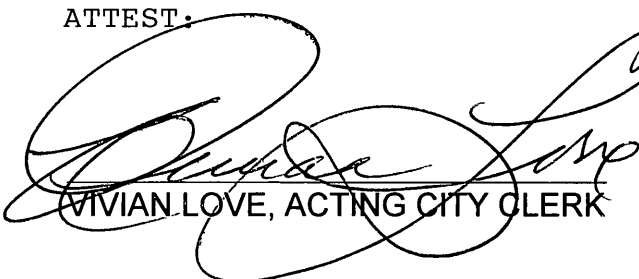
REPORT OF CLOSED SESSION AGENDA: City Attorney Jenkins stated that there were no reportable actions.
