CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES TUESDAY, SEPTEMBER 5, 2000 WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Prang called the meeting to order at 7:41 PM.

PLEDGE OF ALLEGIANCE: David Gregoire led the Pledge.

ROLL CALL:

REPORT OF CLOSED SESSION AGENDA: City Attorney Jenkins reported that three items were added to the agenda, all of which were threatened litigation, and no reportable actions were taken.

APPROVAL OF AGENDA:

Item 2.M. was pulled after the posting of the agenda. Councilmember Martin requested that Item 2.K. be pulled for further discussion. Councilmember Heilman requested that Item 2.J. be pulled for further discussion.

ACTION: Approve the September 5, 2000 Agenda as amended. Motion Councilmember Guarriello, seconded by Councilmember Heilman and carried noting the ABSENCE of Mayor Pro Tempore Koretz.

PUBLIC COMMENT:

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke in opposition of the Sunset Millennium Project and requested public support for his forth-coming candidacy.

JAMES FUHRMAN, WEST HOLLYWOOD, noted the absence of Mayor Pro Tem Koretz. He also spoke in support of Mayor Pro Tem Koretz's anti-smoking ordinance and made suggestions for further anti-smoking regulations. He spoke about City Employee cellular telephone bills.

BARBARA HAMAKER, WEST HOLLYWOOD, member of the Women's Advisory Board, spoke in support of the resolution for the March for Women 2000 event.

RICHARD W. EASTMAN, WEST HOLLYWOOD, spoke in support of the 'Get Out The Vote' rally, requested permission for rolling street closure on October 18, 2000.

TOM DEMILLE, WEST HOLLYWOOD, spoke in support of the City Council and West Hollywood in general. Requested higher attendance at City Council meetings.

DAVID NASH, WEST HOLLYWOOD, spoke in support of housing for persons living with AIDS. He thanked Mayor Prang and Council Deputy Jacobs for housing support. He also spoke about a lack of social work and coordination when people die.

ROGER TANSEY, LOS ANGELES, representing Aid for AIDS, thanked the City Council and the City of West Hollywood for their support.

STEVE LA ROCK, WEST HOLLYWOOD, thanked the City Council for the support of the Los Angeles Cannabis Resources Center.

CATHERINE HAHN, WEST HOLLYWOOD, announced that October 14, 2000 is Library Day and events will include a bake and book sale as well as a community meeting revealing the library survey results.

COUNCILMEMBER COMMENTS:

Councilmember Martin directed the City Manager to work with the new Sheriff's Cpatin on medical marijuana and the Cannabis Club. He also voiced his concern regarding the upcoming HUD relocation of residents on Palm and West Knoll, and noted a request for assistance by the County.

Councilmember Guarriello addressed people supporting people with AIDS, noting the City's past housing projects. He also noted receiving several letters and phone calls regarding the Santa Monica Boulevard Reconstruction Project.

Councilmember Heilman voiced his support of the Santa Monica Boulevard Reconstruction Project and the development team involved.

City Manager Arevalo, responding to Councilmember Guarriello's receipt of correspondence, noted the expected early completion date of the Santa Monica Boulevard Reconstruction Project. He stated that night work is being done, and the planting of trees has begun on the East Side.

Councilmember Heilman introduced David Gregoir as his new appointee for the Rent Stabilization Commission.

Mayor Prang requested that the meeting be adjourned in memory of Scott Jordanson. He expressed his thanks to former Intern Phil Olmstead and congratulated Council Deputy Jacobs for his re-appointment to the LA County County Commission on Health Services. Mayor Prang updated the City Council on the surgery of City Employee Jesse Lawson, and noted that the recovery is ahead of schedule.

CITY MANAGER'S REPORT: City Manager Arevalo reported that coordination with the Sheriff's office regarding the City's position on medical marijuana and the Cannabis

Club has already been established. He confirmed that staff is meeting with HUD representatives to discuss the City's assistance in the relocation. He reported that everyone is being relocated and no one will be left homeless. City Manager Arevalo then directed Interim Rent Stabilization Director Schroeder to prepare a report regarding the HUD relocations.

3. PUBLIC HEARINGS:

Acting Assistant City Clerk Bell stated that a Notice of Public Hearing was published on August 16, 2000 in the West Hollywood Independent.

Liz Bar-El, Associate Planner, provided background information as outlined in the staff report dated September 5, 2000.

Mayor Prang opened the Public Hearing and the following persons addressed the City Council:

JOHN PAUL DRAYER, WEST HOLLYWOOD, voiced questions regarding addition sizes, uses and effects on parking requirements.

JOE CAMPOLONA, CALABASAS, representing clients whose property construction was being disrupted, spoke in support of this item.

There being no further speakers, Mayor Prang closed the Public Hearing.

ACTION: Introduce for first reading Ordinance No. 00-583, "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ADOPTING ZONING TEXT AMENDMENT 2000-03 (ADDITIONS TO STRUCTURES NON-CONFORMING DUE TO HEIGHT AND/OR DENSITY)". Motion Councilmember Guarriello, seconded by

Councilmember Heilman and carried noting the ABSENCE of Mayor Pro Tempore Koretz.

4. UNFINISHED BUSINESS:

4.A. SOCIAL SERVICES FUNDING 2000-02:

Daphne Dennis, Social Services Administrator, provided background information as outlined in the staff report dated September 5, 2000.

MICHELLE PARDO, PASADENA, as an advocate for caregivers and the Alzheimer's Foundation, expressed interest in being funded.

Councilmember Heilman added an additional recommendation that any unallocated social service monies be returned to the general fund.

ACTION: 1) Approve grant awards for Social Services programs for 2000-02 as outlined in the attached chart; 2) Authorize the Director of Finance to increase the budget in the social Services Contracts line item by \$73,500 appropriated from the General Fund Unallocated Reserve; and, 3) Any unallocated funds that occur midyear should be returned to the General Fund.

Motion Councilmember Heilman, seconded by Councilmember Martin and carried noting the ABSENCE of Mayor Pro Tempore Koretz.

5. NEW BUSINESS:

5.A. RENT STABILIZATION COMMISSION APPOINTMENTS:

Acting Assistant City Clerk Bell provided background information as outlined in the staff report dated September 5, 2000.

Councilmember Heilman appointed David Gregoire to the Rent Stabilization Commission.

DAVID GREGOIRE, West Hollywood, introduced himself to the Councilmembers and the public and listed past experience as well as goals and duties for his new appointment.

ACTION: Councilmember Heilman to appoint David Gregoire to the Rent Stabilization Commission, as his direct appointment, for an un-expired term ending 05/31/2003. **By Consensus of the City Council.**

5.B. DISABILITIES ADVISORY BOARD APPOINTMENT:

ACTION: Tabled to October 2, 2000.

5.C. YOUTH ADVISORY BOARD:

Curtis Brown, Jr., Recreation Services Administrator, provided background information as outlined in the staff report dated September 5, 2000.

Councilmember Heilman spoke about a concern that only West Hollywood Residents apply for this program.

ACTION: Direct staff to recruit a group of 9 youths, ages 13-18 to act as a Youth Advisory Board for the City Council, Human Services Commission, and the Recreation Services Division staff. Membership should be limited to West Hollywood residents only. Motion Councilmember Heilman, seconded by Councilmember Guarriello and carried noting the ABSENCE of Mayor Pro Tempore Koretz.

5.D. CALENDAR OF NEW EVENTS:

Lloyd Long, Director of Human Services, provided background information as outlined in the staff Report dated September 5, 2000.

JAMES FIELDS, VALLEY VILLAGE, President of CSW, would like to meet with the City Council regarding their involvement with CSW.

DON BRUHNKE, WEST HOLLYWOOD, spoke in opposition to continued involvement with Christopher Street West.

Councilmember Heilman suggested that larger events be delegated to the West Hollywood Convention and Visitors Bureau, not the Special Events Division at City Hall. He also addressed concerns that CSW has declined in attendance in recent years.

Mayor Prang suggested that staff work in conjunction with CSW when organizing events. He stated that he has confidence in the CSW board members but, think they need the City's guidance.

City Manager Arevalo stated that a supplemental agreement would be brought before the Council during a meeting in October.

Councilmember Heilman suggested going out to bid for a new event organizer.

Councilmember Martin agreed with Mayor Prang that the City shouldn't rush into taking over the event.

City Manager Arevalo suggested this item return to Council on October 16, 2000.

ACTION: City Manager Arevalo to bring back a supplemental agreement with the West Hollywood Convention and Visitors Bureau for additional events on October 31, 2000. **By Consensus of the City Council.**

THE CITY COUNCIL TOOK A RECESS AT 9:20 PM.

THE CITY COUNCIL RETURNED FROM THE RECESS AT 9:31 PM.

5.E. 2000 HALLOWEEN CARNAVAL EVENT:

Dan Laray, Special Events Coordinator, provided background information as outlined in the staff Report dated September 5, 2000.

Councilmember Heilman questioned the necessity of the street closure. Special Events Coordinator Laray stated purpose, but noted the event may be able to be relocated to the sidewalk.

Councilmember Martin questioned liability of a specific event and was informed that it was being researched.

Councilmember Heilman questioned which radio stations will be present and was informed that Mega, Kiis and Star would be.

Mayor Prang voiced concerns regarding public safety liability issues such as the large crowd and was informed that staff have met with the Sheriff's Department to move the event border further east, allowing more room to move.

Councilmember Heilman noted concerns regarding unruly attendees.

Councilmember Martin suggested the event not be advertised so heavily and the event be more local oriented. He stated that a beer garden could exacerbate a problem with unruly guests.

Councilmember Heilman questioned the fixed fee of the Pacific Design Center's parking lot and was informed it will probably be the same as last year.

Mayor Prang questioned the necessity of a beer garden.

Councilmember Heilman stated some of the reasons for a beer garden included spreading the amenities along Santa Monica Boulevard, getting non-profit organizations involved and bringing the City some revenue from the event.

Mayor Prang suggest the Council vote on this item, but hold a separate vote for the beer garden.

ACTION: 1) Authorize the City Manager to execute contracts and waive contract limitations for this event; 2) Authorize the Finance Director to establish and increase revenue and expenditure line items for Halloween by the amount of any sponsorship, upon receipt of a signed contract from the sponsor; 3) Approve street closures as outlined in the staff report; 4) Direct staff to request that the Pacific Design Center parking structure remain open until 4:00 AM, Wednesday, November 1, 2000; 5) Waive permit parking between the hours of 5:00 PM, October 31, 2000 through 7:00 AM, November 1, 2000; 6) Waive all City fees associated with this City sponsored event; 7) Approve these pass-through fees as established by contractor for miscellaneous services as outlined in the staff report; and, 8) Award contracts to the vendors detailed in the staff report. Motion Councilmember Heilman, seconded by Councilmember Guarriello and carried noting the ABSENCE of Mayor Pro Tempore Koretz.

ADDITIONAL ACTION: Authorize a Beer Garden, adjacent to Santa Monica Boulevard, and purchase of additional insurance (not to exceed \$7,500) from unallocated reserves. **Motion Councilmember Heilman, failed due to lack of second.**

Motion Councilmember Martin, seconded by Councilmember Heilman and carried noting the ABSENCE of Mayor Pro Tempore Koretz.
