

CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, MAY 15, 2000 WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Prang called the Meeting to order at 7:14 P.M.

PLEDGE OF ALLEGIANCE: Neal Zaslavsky led the Pledge.

ROLL CALL:

PRESENT: Councilmembers Guarriello, Heilman, Martin, and Mayor Prang.

ABSENT: Mayor Pro Tempore Koretz.

ALSO PRESENT: City Attorney Jenkins, City Manager Arevalo, City Clerk Thompson

and Administrative Staff Assistant Bursztin.

REPORT OF CLOSED SESSION AGENDA: City Attorney Jenkins reported that no Items were added and no reportable actions were taken.

APPROVAL OF AGENDA:

Staff requested Item 2.H. be tabled to June 5, 2000.

Councilmember Heilman pulled Items 2.P. and 2.V. for discussion under Excluded Consent Calendar.

Staff requested Item 5.A. transmittal of the Budget be moved to the Consent Calendar as Item 2.Y.

Staff requested Item 4.A. Mid-year Review Social Service Contracts be moved to the Consent Calendar as Item 2.Z.

The applicant withdrew the appeal to the City Council for Item 4.B. regarding the Creative Billboard at 8225 Sunset Boulevard.

Councilmember Heilman noted his NO vote on Item No. 1 of Item 2.X.

Councilmember Guarriello noted his NO votes on Item 2.R.

Council requested Item 3.D. be heard out-of-order immediately following the Consent Calendar.

ACTION: Approve the May 15, 2000 Agenda as amended. Motion Councilmember Heilman, seconded by Councilmember Guarriello and unanimously carried.

PRESENTATIONS:

Councilmember Heilman presented a proclamation for Historic Preservation Month for the Month of May.

Mayor Prang presented a proclamation for Peace Officer Memorial Month for the Month of May. He asked Ivy Bottini and John Lazar from the Lesbian and Gay Advisory Board to present Rainbow Keys to Dr. Lo Sprague and Rev. Dr. Gwyne Guibord. He also presented a commendation to Herb Schultz, an advocate for those Living with HIV. He also presented a check for \$2,500 to California Alliance Pride and Equity (C.A.P.E.)

Councilmember Martin presented a proclamation for Bike to Work Week beginning May 18, 2000. He also presented a commendation to International Performance Artist Karen Finley.

PUBLIC COMMENT:

STAN LOTHRIDGE, WEST HOLLYWOOD, spoke in opposition of Item 2.R.

JAMES FUHRMAN, WEST HOLLYWOOD, spoke about attendance of Councilmembers and about the pool still being closed for public use. He also spoke of the City Manager Arevalo's use of cellular phones and money being spend on the recent reorganization.

JEFFREY ROSENBERG, LOS ANGELES, spoke in support on Item 3.C.

MICHAEL KING, WEST HOLLYWOOD, spoke about problems such as a water break during the reconstruction of Santa Monica Boulevard. He also spoke of problems obtaining a guest parking permit from City Hall and the Sheriff's Department. He also spoke about an ongoing homeless problem in his neighborhood.

MARK MONGOMERY, LOS ANGELES, spoke about an article in the Los Angeles Times concerning the Cruising Ordinance.

ROHAN GAVIN, WEST HOLLYWOOD, spoke about a dumping problem on Larrabee Street from the Viper Room.

GAVIN REILY, WEST HOLLYWOOD, spoke about the lack of law enforcement on Sunset Boulevard.

JENNY WORMAN, WEST HOLLYWOOD, spoke about a recent murder on Sunset Boulevard and the lack of law enforcement on Sunset Boulevard.

JEROME CLEARY, WEST HOLLYWOOD, spoke about the recent murder on Sunset Boulevard and ongoing robberies throughout the City.

ALAN WEBER, WEST HOLLYWOOD, spoke in opposition of Item 2.V.

LAWRENCE ZAKSON, WEST HOLLYWOOD, spoke in opposition of Item 5.C.

CAROL ELLIS, LOS ANGELES, spoke in support of Item 2.Y.

COLTON ROBERT KENNEDY DUNN, WEST HOLLYWOOD, spoke regarding seeing eye dogs.

BARBARA HANMAKER, WEST HOLLYWOOD, spoke in opposition of Item 5.C.

COUNCILMEMBER COMMENTS:

Councilmember Guarriello adjourn in memory of Elise Weisman a long-time West Hollywood resident who gifted the City property. He also spoke about upcoming Memorial Day Celebrations. He also mentioned that he saw several members of law enforcement on Sunset Boulevard on a recent Saturday night.

Councilmember Martin supported Councilmember Guarriello's adjournment in memory of Elise Weisman. He spoke about the recent problems on Sunset Boulevard and how the City Council is looking at long-term solutions. He also spoke of a man selling puppies and the traffic problems that prevented the Sheriff's from being able to respond within a reasonable period of time. He asked the City Manager to discuss the problems within the area of Viper Room.

Councilmember Heilman also spoke about the problems on Sunset Boulevard and law enforcement. He maintained his support of his recent NO vote on the Cruising Ordinance.

Mayor Prang thanked everyone who participated in the Victory in Europe Day event. He also spoke about de-commissioning the Hancock Fire Station. He also welcomed back Council Deputy Howard Jacobs. He also thanked everyone who inquired on the health of Interim Council Deputy Marcy Norton. He also spoke about the June 3 celebration on peace related toys. He spoke about complaints his office has received involving street sweeping. He expressed sympathy for the family of Elise Weisman.

CITY MANAGER'S REPORT: City Manager Arevalo reported on public safety activities that took place over the past weekend on Sunset Boulevard which involved a large number of police officers, 92 citations being issued and 12 arrests. He discussed increased public safety efforts over the next few months. He addressed public

speakers comments on a waterline break, which was not a result of the reconstruction of Santa Monica Boulevard. He responded to Councilmember Martin's request on the Viper Room and Larrabee Street and confirmed that efforts will be made to deal with the problems. He also responded to Mayor Prang's inquiry on street sweeping complaints received and how the street sweeper was damaged and being repaired. Director of Department of Transportation and Public Works Joan English confirmed that the pool would be open for public use at the end of May.

FISCAL IMPACT ON CONSENT CALENDAR: City Clerk Thompson stated the fiscal impact on the Consent Calendar of May 15, 2000 as amended, is \$53,100 in expenditures and \$39,520 in potential revenues.

City Clerk Thompson stated that the Demand Register Item 2.E. contained expenditures relating to Item 2.V. and that approval of those expenditures would be contingent upon the approval of Item 2.V.

Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated May 15, 2000.

Councilmember Heilman noted a difference in numbers being verbally presented and the numbers stated in the staff report.

Mayor Prang opened the Public Hearing and the following persons addressed the City Council:

JEANNE DOBRIN, WEST HOLLYWOOD, spoke about the recycling message not getting out to the residents. She also spoke in support of the work of John Jakupcak and Katie McCormack of the City's Environmental Services Division.

No further speakers coming forward, Mayor Prang closed the Public Hearing.

Councilmember Heilman supported Jeanne Dobrin's comments.

Mayor Prang commented on the current status of the sewer service charges.

No further speakers coming forward, Mayor Prang closed the Public Hearing.

Lisa Heep, Planning Manager and Ray Reynolds, Director of Community Development provided additional information.

Councilmember Heilman asked if an accusation was filed and Senior Planner Foy confirmed that it has not. He inquired on clarification on what is being presented in the staff report.

Councilmember Guarriello asked Captain Odenthal for additional information on the comparison of the various drinking establishments.

Captain Odenthal provided additional information on the ongoing problems with Hunters.

Mayor Prang opened the Public Hearing and the following persons addressed the City Council:

MARK LEHMAN, Representative for the Applicant, spoke in opposition of this Item and improvements made by the owner of the establishment.

Mayor Prang inquired on the corporate drug policy of the management of the establishment.

Councilmember Heilman asked if the representative would go to that establishment.

JEFFREY ROSENBERG, LOS ANGELES, spoke in opposition to Hunters Conditional Use Permit.

Councilmember Martin asked if he went to the establishment and how long did he know the owner of the establishment.

SUSAN COOPER, WEST HOLLYWOOD, spoke in opposition of this Item and in support of the outreach program.

Councilmember Heilman inquired on the speaker's street address, which was Fountain Avenue.

DAVID BROWN, LOS ANGELES, Owner of Hunters, spoke in opposition of this Item and efforts made to prevent the ongoing problems.

Councilmember Guarriello asked the speaker on what other businesses he owned and spoke of the number of citations issued at his establishment.

Councilmember Heilman asked the speaker for clarification on his testimony on calling the Sheriff's Department for assistance.

DICK ROOT, SAN DIEGO, spoke in opposition of this Item.

LEON MISMAS, WEST HOLLYWOOD, spoke in opposition of this Item.

RONALD KATSKY, WEST HOLLYWOOD, spoke in opposition of this Item.

FRED RUGGIERU, NORTH HOLLYWOOD, spoke in opposition of this Item.

Councilmember Heilman asked the speaker on clarification on prostitutes.

BARBARA HANMAKER, WEST HOLLYWOOD, spoke in support of this Item.

STEVE SMITH, WEST HOLLYWOOD, Planning Commissioner, spoke in support of this Item.

Councilmember Martin asked the Commissioner on the number of complaints received.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of this Item.

BENJAMIN AVERY, WEST HOLLYWOOD, spoke about his role as Manager in the establishment.

Councilmember Guarriello spoke about an incident that took place at this establishment.

Councilmember Martin spoke about an incident of a bartender being arrested. He asked the speaker if he ever called the Sheriff and if he was aware of undercover police work being conducted at this establishment.

IVY BOTTINI, WEST HOLLYWOOD, spoke in support of this Item.

SCOTT STONEBROOK, Investigator, Alcohol and Beverage Control (ABC), outlined the violations on file in and around this establishment.

Councilmember Martin asked the Investigator on clarification on the purchase of drugs, prostitution and various acts of lewd conduct.

ERIC HIRATA, Investigator, Alcohol and Beverage Control (ABC), outlined the violations on file in and around this establishment.

MARK LEHMAN, representative for the Applicant, spoke in opposition of this Item. He also stated that the ABC has never cited this establishment.

Councilmember Guarriello asked on clarification on the citations issued to this establishment.

Councilmember Martin asked for clarification on the terms "with prejudice" and "without prejudice." Senior Planner Foy provided the clarification.

No further speakers coming forward, Mayor Prang closed the Public Hearing.

Councilmember Guarriello expressed support of this Item.

Councilmember Heilman supported Councilmember Guarriello's support of this Item. He discussed his questioning of the speakers if they ever went to this bar. He discussed his questioning of the owner, David Brown, who stated that he calls the Sheriff's Department while not being aware of the ongoing problems. He spoke about the incidents listed in the staff report dated May 15, 2000 on Exhibit C.

Councilmember Martin expressed concerns on revoking the permit with prejudice. He stated that he wished he had testimony from neighbors who live in the immediate area. He spoke about the testimony of the ABC Officers.

Mayor Prang expressed his support of this Item and spoke of increased efforts on the part of the owner of the establishment.

Mayor Prang opened the Public Hearing and no persons addressed the City Council, the Public Hearing was closed.

ACTION: Approve the schedule as Monday, June 26, 2000; Monday July 31, 2000; Monday September 11, 2000; and Monday, October 23, 2000 and continue the public hearing to Monday, June 26, 2000. Motion Councilmember Martin, seconded by Councilmember Heilman and unanimously carried.

Mayor Prang opened the Public Hearing and no persons addressed the City Council, the Public Hearing was closed.

Vivian Love, Director of Administrative Services, provided background information as outlined in the staff report dated May 15, 2000. She introduced Steve Finnegan and Linda Demmers from Arroyo Associates, Inc. who provided additional information and statistics.

SANDRA JACOBY KLEIN, WEST HOLLYWOOD, Member of the West Hollywood Library Advisory Committee, spoke in support of this Item and to continue the work of the West Hollywood Library Advisory Committee.

NORMAN CHRAMOFF, WEST HOLLYWOOD, Member of the West Hollywood Library Advisory Committee, spoke in support of this Item and thanked Vivian Love, Kathryn Reynolds and Arroyo Associates, Inc. for their work.

ROSLYN KRAUSE, WEST HOLLYWOOD, spoke about keeping the Library in West Hollywood Park.

CATHERINE HAHN, WEST HOLLYWOOD, Member of the West Hollywood Library Advisory Committee, spoke in support of this Item and the square footage mentioned in the Committee's recommendation.

Councilmember Martin questioned the speaker about the Community Room.

STEVE ROSE, WEST HOLLYWOOD, Member of the West Hollywood Library Advisory Committee, thanked Vivian Love for her work on the project and spoke in support of this Item.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of this Item. She spoke of the reference requests that the Library receives. She spoke of a single performance event in the Library that she attended.

Councilmember Heilman asked about the visioning process of the project. He stressed that public input is necessary but feels that the Council has a good idea of what that is. He asked staff to provide clarification on the visioning part of the project. Consultant Linda Demmers provided the clarification. He confirmed that the City is doing the construction and not the County.

Director of Administrative Services Love provided additional clarification to Councilmember Heilman. She stated that public meetings would be involved and that the Task Force would continue to work on the project.

Councilmember Guarriello spoke about the 25,000 square feet. He also discussed the County's involvement in which Vivian Love provided additional information.

Mayor Prang spoke about relationships with the County and the possibility of being part of a district. He also asked to add an additional recommendation concerning funding.

Councilmember Martin stated his support of the visioning process of the project. He stated that huge numbers of taxpayers are not utilizing this Library. He spoke of the City's efforts to bring the residents into the process.

City Manager Arevalo provided additional information.

ACTION: 1) Receive and file the Feasibility Report noting the following findings: a) Space Needs -- the 5,170 square foot library is inadequate,

not ADA compliant, and significantly below industry standards. properly house the current collection and bring the building to code with no programmatic or space enhancements, the building needs to be in excess of 10,000 square feet; b) Financial Considerations -the Los Angeles County Library collects \$920,000 per year from West Hollywood residents to provide library services and expends approximately \$756,000. Through a special agreement between the County and the City, the remainder (\$164,000 per annum) goes into a special capital fund which, to date, has accumulated approximately \$707,000. Were we to leave the County, we would have strong legal arguments to take that fund with us, but there is no guarantee and it may be decided in the courts; c) County Affiliation – The decision to remain a part of the County system should depend upon the willingness and ability of the County to provide higher service levels at a larger facility. Based on services, financial and usage analysis, the decision to stay with the County is not clear-cut; 2) Receive and File Committee Square Footage Recommendation - The committee recommends a 25,000 to 32,000 square foot new Library; 3) Direct staff to begin negotiations with Los Angeles County for enhanced library service and building; 4) Amend Contract with Arroyo Associates -Amend the contract with Arroyo Associates to include a Community Visioning process including the preliminary space needs, in an amount not to exceed \$15,000, and authorize the City Manager to sign. This 90-day phase will include the discussion of potential collections, programs, and services in an expanded community process; 5) Establish a Design Review Sub-Committee - Direct Public Facilities Commission to form a Design Review Sub-Committee similar to the structure utilized for the Comprehensive Services Center; 6) Additional Staff Recommendation -Direct Community Development Department staff to evaluate and assess potential sites for the library based on compatibility with adjacent uses; accessibility and financial considerations with direction to staff to commence with a financing proposal. Motion Councilmember Heilman, seconded by Councilmember Guarriello and unanimously carried.

Helen Goss, Public Information and CATV Manager, provided background information as outlined in the staff report dated May 15, 2000. She introduced the project consultants, Thomas Marvaso and Wes Waltrip of Parson Infrastructure and Technology Group who provided additional information.

Councilmember Heilman asked for clarification on the technical terms such as the word "Sonic." Consultant Waltrip provided the clarification. He also asked for clarification on the City Hall telephone service. Public Information and CATV Manager Goss provided additional information. He presented the consultants various questions concerning the various phases of the telecommunications project. He stressed that the City's goal would be to offer this to all of the residents.

Councilmember Martin asked City Manager Arevalo to provide additional information. City Manager Arevalo stated all the information was presented in the staff report and he wanted to see the City take advantage of the high tech opportunities, especially since this type of industry is relocating to the City.

Mayor Prang stated his support of this Item.

Councilmember Guarriello discussed the above ground and under ground concepts.

ACTION: 1) Receive and file the Telecommunications Feasibility Study; 2) Authorize the City Manager to execute an agreement with Parsons Engineering to develop a Telecommunications Master Plan; and, 3) Authorize the Interim Finance Director to transfer \$151,455 from the undesignated reserve to an expenditure line in the PIO/CATV Division. Motion Councilmember Martin, seconded by Mayor Prang and carried unanimously.

NORMAN CHRAMOFF, WEST HOLLYWOOD, spoke in opposition of this Item.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of this Item.

DONALD DELUCCIO, WEST HOLLYWOOD, spoke in support of this Item.

Councilmember Martin provided additional information and clarification.

Councilmember Heilman expressed disappointment that the Task Force has not been finalized but, understood that the City Clerk's Division has been short staff for an extended period of time. He stated support to some of the ideas such as dollar amounts etc. He also stated his concern about the legal standpoint. He spoke about blackout periods.

City Attorney Jenkins provided information on the legal aspects of the proposal but mentioned that the moratorium could be potentially a liability. He also spoke about blackout periods.

Mayor Prang spoke of the time periods of fundraising at the County and the City of Los Angeles. He stressed some concerns about a moratorium and the timeline with the upcoming elections.

ACTION: 1) Direct the City Clerk to continue to work with the proposed Task Force on an immediate basis and return to the City Council with a report in August, 2000. **Motion Councilmember Heilman, seconded by Councilmember Guarriello and unanimously carried.**
