DEREK MEIK, WEST HOLLYWOOD, Business Owner, stated that the condoms should be everywhere and not just in the bars and restaurants.

Mayor Pro Tem Prang stated that he supports a voluntary distribution for twelve months to be reviewed with the social services staff to see if there is a level of compliance. He stated that he did not believe that the political arena is not the place for public health issues. He stated his support for recommendation no. 2 and recommendation no. 4, as in the staff report; rejected recommendation no. 1 and recommendation no. 5, as in the staff report, and stated his support to discuss recommendation no. 3, as in the staff report.

Councilmember Koretz stated that the push for the initiative drew added attention to the need for more condoms. He stated that the highest compliance will be generated by the voluntary condom distribution. He stated his support for recommendation no. 3, as in the staff report, and increasing the number of establishments which distribute condoms.

Councilmember Martin stated his support for a voluntary program and he commented that he thought that it was premature to talk about percentages, but there should be substantial compliance and the evaluate the program in December of 2000.

Councilmember Guarriello spoke about the importance of AIDS education.

Mayor Heilman stated that it would be the City's responsibility to supply the condoms whether the program was mandatory or voluntary. He commented that the issue is to change the behavior of people which is best done when there is a collaborative effort. He commented that mandatory distribution is not the way at this time since it appears that there is cooperation from the bars and establishments for voluntary condom distribution.

ACTION: 1) Accept the donation of 20,000 condoms and packets of lubricant; 2) endorse the continued voluntary program; 3) direct the Human Services staff to develop a compliance evaluation mechanism within 30 days; 4) Develop regular routine reporting on voluntary compliance with the Human Services Commission; 5) Informally brief the City Council on voluntary compliance every 90 days; 6) Return to the City Council in one-year with a comprehensive report on the voluntary program; 7) Purchase 50,000 additional condoms; and 8) Direct staff to contact public health agencies and educational institutions to develop a study which would report on the results of the voluntary program to the furtherance of Public Health. Motion Mayor Heilman, seconded by Councilmember Martin and unanimously carried.

JOHN PAUL DRAYER, WEST HOLLYWOOD, Neighborhood Watch Captain, spoke about the Sheriffs Department being notified of the events taking place.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke against high impact meetings and about Code Compliance policing the events.

No further speakers came forward, Mayor Heilman closed the Public Hearing.

ACTION: Grant the appeal in part and adopt Resolution 00-2222: "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING REHABILITATION INCENTIVE 98-01 TO LEGALIZE EXHIBITION AND EVENT ACTIVITIES AT THE SCHINDLER HOUSE AT THE PROPERTY LOCATED AT 835 KINGS ROAD, WEST HOLLYWOOD, CALIFORNIA." Motion Councilmember Guarriello, seconded by Councilmember Koretz and unanimously carried.

4.B. WEST HOLLYWOOD CONVENTION AND VISITORS BUREAU, FIRST QUARTER REPORT:

Allyne Winderman, Economic Development and Housing Manager, introduced Brad Burlingame, Executive Director of West Hollywood Visitors and Convention Bureau, provided background information as outlined in the staff report dated January 3, 2000.

ACTION: Receive and file the quarterly report for the West Hollywood Convention and Visitors Bureau for the quarter ending September, 1999. Motion Councilmember Guarriello, seconded by Councilmember Martin and unanimously carried.

5. NEW BUSINESS:

5.A. BUSINESS LICENSE TAX REBATE PROGRAM FOR BUSINESSES AFFECTED BY THE SANTA MONICA BOULEVARD CONSTRUCTION PROJECT:

Paul Arevalo, Interim City Manager, provided background information as outlined in the staff report dated January 3, 2000.

DON BRUHNKE, WEST HOLLYWOOD, commented that the City should look for new and innovative ways to help business, such as, joint mailers to enable them to get coupons out to the residents.

Councilmember Martin recommended to adopt Option C and continue to promote the businesses on Santa Monica Boulevard.

ACTION: 1) Approve the threshold as indicated in Option C of a Business License Tax Rebate Program; and, 2) Direct Staff to develop the rebate

program to be implemented as part of the 1999 Tax Year, and concluded at the end of the Boulevard Rehabilitation project. **Motion Councilmember Martin, seconded by Mayor Pro Tem Prang and unanimously carried.**

5.B. PROPOSED ORDINANCE IMPOSING VEHICULAR CRUISING CONTROL ON SUNSET BLVD.:

Councilmember Sal Guarriello provided background information as outlined in the staff report dated January 3, 2000.

Interim City Manager Arevalo stated that there has been an effort by the West Hollywood Chamber of Commerce to address some of the traffic issues impacting Sunset Boulevard especially on the weekends and on evenings. He further stated that Councilmember Guarriello has given the Public Safety Commission an ordinance from Pasadena on vehicular cruising and their plans to bring a report back to the City Council on recommendations.

Mayor Heilman stated his support to look at this ordinance in conjunction with other programs.

JEANNE DOBRIN, WEST HOLLYWOOD, stated the importance of this issue and the urgency.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke in support of this item.

ACTION: Direct the City Attorney, the Sheriffs Department and the Public Safety Manager to prepare and present to the City Council within 90 days a report with findings on the feasibility of drafting an ordinance controlling vehicular cruising on Sunset Boulevard. Motion Councilmember Guarriello, seconded by Councilmember Martin and unanimously carried.

He commented that Los Angeles Unified School Board Member, Caprice Young has recently assembled a Gay and Lesbian Advisory Committee to advise her in her capacity.

Mayor Heilman thanked the staff who worked over the New Year's Holiday weekend.
