He spoke regarding time limitations on the operation period of the current dispensaries in the City. He spoke regarding concerns surrounding dispensaries located in residential areas.

ACTION: Introduce on first reading Ordinance No. 07-743 "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING TITLE 19 (ZONING ORDINANCE) AND TITLE 7 (HEALTH) REGARDING MEDICAL MARIJUANA DISPENSARIES." (ATTACHMENT A) with the following amendments: a) Paragraph C would be amended to require a Conditional Use Permit in place of a Major Zone Clearance; and b) Paragraph F would be amended to provide the current dispensaries which do not meet the location requirements shall be allowed to continue operation until 12/31/09 at which time they shall cease all operations at the location, until then all locations will be required to meet all other regulations Imposed in Section 19.36.165. Motion by Councilmember Land, Seconded by Mayor Pro Tempore Guarriello and approved with Councilmember Duran being absent.
