# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, NOVEMBER 29, 1999 WEST HOLLYWOOD PARK

**CALL TO ORDER**: Mayor Heilman called the meeting to order at 7:04 P.M.

# APPROVAL OF AGENDA:

Mayor Heilman requested that the Public Hearing, Item 3.A., regarding the Sunset Millennium, be continued to December 6, 1999 and directed the City Clerk to continue to receive written public testimony until the start of the Public Hearing.

Mayor Heilman requested that the Public Hearing Item 3.B., Proposed Two (2) Hour Time Limit on Carol Drive, be continued to December 6, 1999.

Mayor Heilman requested that Item 6.A., First Reading of an Ordinance Mandating the Distribution of Condoms for Liquor Licensees, Adult Businesses, Coffee Houses and Local Non-Profit Organizations which Market to Highest Risk for HIV Infection, be continued to December 20, 1999.

JEANNE DOBRIN, WEST HOLLYWOOD, suggested that the City Council adjourn the meeting in memory of Douglas Routh's mother and she commented on the Sunset Specific Plan.

CAROL RODRIGUEZ, WEST HOLLYWOOD, commented on the drinking water.

GED KENSLEA, WEST HOLLYWOOD, spoke about parking tickets received for parking in the upper lot at the Post Office due to the construction on Santa Monica Boulevard.

TOM BRIGHT, WEST HOLLYWOOD, commented on paint dumped in front of his home on La Cienega Boulevard and his contact with Code Enforcement regarding this issue.

#### **COUNCILMEMBER COMMENTS:**

Councilmember Martin commented on the code violation of paint being dumped.

Mayor Pro Tem Prang directed Joan English, Director of Transportation and Public Works to look into parking at the Post Office.

Mayor Heilman also directed Interim City Manager Arevalo, Joan English, Director of Transportation and Public Works and staff to follow up on the progress of finding alternative parking during the Santa Monica Boulevard Construction.

CITY MANAGER'S REPORT: Interim City Manager Arevalo reported that the City is not going to be closing any streets during New Year's Eve for parties. He reported that the City's involvement will be to coordinate public safety activities and getting people safely in and out of the City. He also reported on the schedule for the City Council Retreat on December 8, 1999.

# 2.I. PROPOSED ORDINANCE RESTRICTING HOME BASED BUSINESSES KNOWN AS "THE NEIGHBORHOOD PROTECTION ACT OF 2000":

Councilmember Martin provided background information as outlined in the staff report dated November 29, 1999.

DON BRUNHKE, WEST HOLLYWOOD, spoke in support of this item.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of this item.

Mayor Pro Tem Prang commented that the code needs to be redefined and that there are a number of legal considerations that need to be made.

Councilmember Martin requested that the City Attorney draft an ordinance that would address preservation of residential units.

Mayor Heilman directed the City Attorney and Ray Reynolds, Community Development Director to come up with a solution to protect the residential zone and stock.

ACTION: 1) Direct the City Attorney to draft an ordinance amending the West Hollywood Municipal Code to specify that businesses shall not be allowed in residential areas unless the dwelling is the **primary place of residence** for the business owner. This shall also include uses of garages and any and all rental units; 2) Direct the staff and the City Attorney to investigate other aspects of this problem and return with recommendations, one of which may be an ordinance as outlined in the staff report.
