CITY MANAGER'S REPORT: Interim City Manager Arevalo reported on an episode in the Pavillions parking lot that resulted in a Sheriff's Deputy shooting. He Stated he did a walk through of the Aygyle Hotel regarding noise, code enforcement report and commented on Halloween and the Cityhood Celebration party to be held at the Pacific Design Center.

Mayor Heilman asked that Captain Odenthal of the West Hollywood Sheriff's Department give background information on the two shootings and how the City of West Hollywood can alleviate this type of problem in the future.

ACTION: Councilmember Martin appointed Don Bruhnke to the Rent Stabilization Commission, as his direct appointment, for an un-expired term ending 05/31/2003.

5. **NEW BUSINESS:**

5.A. TRANSFER OF RESPONSIBILITY FOR CODE ENFORCEMENT PROGRAM:

Hal Cronkite, Director of Rent Stabilization provided background information as outlined in the staff report dated November 1, 1999.

Interim City Manager Arevalo provided additional background information on the past Code Enforcement program.

Mayor Pro Tem Prang questioned the current structure of management defining the Code Enforcement Division.

Mayor Heilman questioned the reasoning on subsection No. 5.

DON BRUHNKE, WEST HOLLYWOOD commented on placement of code enforcement officers and improvement of the current Rent Stabilization laws.

ACTION: 1) Transfer responsibility and budget for commercial code enforcement from CDD to Public Safety effective November 8, 1999; 2) Transfer responsibility and budget for residential code enforcement to the

Rent Stabilization Department effective November 29, 1999; 3) Upgrade one existing Code Enforcement Officer position to a Lead Code Enforcement Officer effective November 29, 1999. The additional \$2,500 cost in FY 1999-2000 will be absorbed within the existing RSD budget; 4) Increase a halftime Code Compliance position to full time effective November 8, 1999. The additional \$14,000 cost in FY 1999-2000 will be absorbed within the existing CDD budget, 5) The above actions on a temporary basis/pilot period until the next budget year, with staff to report back on the progress at that time. Motion Mayor Heilman, seconded by Councilmember Guarriello and unanimously carried as amended.

5.B. ACTION FOR "ILLEGAL UNITS" AMNESTY PROGRAM:

Mayor Heilman provided background information as outlined in the staff report dated November 1, 1999.

STEVE ROSE, WEST HOLLYWOOD questioned how many of these units we need to bring into the City of West Hollywood

ACTION: 1) Direct planning staff to comprise a report on the expired Unit's "amnesty program"; and, 2) Direct planning staff to bring recommendations for dealing with remaining illegal units through an amnesty program, or by some other permit program. Motion Councilmember Martin, seconded by Councilmember Guarriello and unanimously carried.

5.C. ADDENDUM TO CONTRACT WITH SERCO MANAGEMENT SERVICES TO PROVIDE TRAFFIC CONTROL SERVICES.

MUNICIPAL CODE REGARDING RELOCATION BENEFITS." Motion Councilmember Martin, seconded by Councilmember Guarriello and unanimously carried.

Councilmember Koretz commented on the no dumping signs in alleys.

Councimember Martin congratulated the Gay Men's Chorus on their recent trip to Russia.

Mayor John Heilman introduced David Reed with AIDS Watch 1999.
