# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, MARCH 15, 1999 WEST HOLLYWOOD PARK

**CALL TO ORDER:** Mayor Martin called the meeting to order at 7:15 P.M.

## 3.C. PROFESSIONAL SERVICES AGREEMENT WITH LOCKHEED MARTIN FOR PHOTO SAFETY PROGRAM:

Councilmember Koretz abstained from discussion due to a conflict of interest.

Joyce Rooney, Associate Transportation Planner provided background information as outlined in the staff report dated March 15, 1999.

Mayor Martin opened the Public Hearing and the following speakers addressed the City Council.

NEAL ZASLAVSKY, WEST HOLLYWOOD, spoke about the traffic problems we will have due to the takeover of Santa Monica Boulevard and he spoke against implementing this program.

J.W. MOORE IV, WEST HOLLYWOOD, spoke in support of putting in these units.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke in support of the program but against full implementation, it should go slowly.

JEANNE DOBRIN, WEST HOLLYWOOD, stated that Carol Drive Sunset Boulevard and Doheny Drive should be sited as an intersection that should implement this program and she spoke in support of this program.

No further speakers coming forward, Mayor Martin closed the Public Hearing.

Mayor Pro Tem Heilman requested a thirty day warning period before the system goes into effect.

ACTION: 1) Approve a two (2) year agreement with an one (1) year extension option with Lockheed Martin, based on their proposal submitted January 20, 1999 in a format approved by the City Attorney, and authorize the City Manager to sign. Information Division to develop a campaign to inform residents and motorists about the automated signal enforcement program; and institute a full thirty-day warning period before ticketing motorists. 5) Amend the Fiscal Year 2000 revenue projections for traffic fines to reflect an increase of \$1,626,000, based on issuing a minimum of one hundred (100) citations per month at five (5) intersections; and, 6) Appropriate expenses of \$260,000 for Fiscal Year 1999 to pay for the start up of the program, and appropriate \$1,180,000 for Fiscal Year 2000.

Motion Mayor Pro Tem Heilman, seconded by Councilmember Guarriello and carried noting the ABSTENTION of Councilmember Koretz.

THE CITY COUNCIL RECESSED AT 9:00 P.M. AS THE WEST HOLLYWOOD COMMUNITY DEVELOPMENT COMMISSION.

#### 4.1. UNFINISHED BUSINESS - SANTA MONICA BOULEVARD:

4.A. SUPPLEMENTAL PROFESSIONAL SERVICES AGREEMENT WITH WILDAN ASSOCIATES FOR ADDITIONAL ENGINEERING SERVICES ON THE SANTA MONICA BOULEVARD REHABILITATION PROJECT: Sharon Perlstein, City Engineer provided background information as outlined in the staff report dated March 15, 1999.

ACTION: 1) Approve a supplemental professional services agreement with Wildan Associates in an amount not to exceed \$250,000 to provide additional engineering services on the Santa Monica Boulevard Rehabilitation Project; 2) Authorize the City Manager to execute the supplemental agreement; and, 3) Authorize the Director of Finance to establish an operating/capital budget in the Santa Monica Improvement Fund, and to appropriate \$210,000 from the fund's reserve (which is comprised of the State Contribution) to cover the contract costs.

Councilmember Koretz commented that the signs should stay but not enforce the violation with fines.

Mr. Vittatoe stated that this is a safety issue to prevent severe accidents.

Mayor Martin commented on complaints regarding lack of due process and towing enforcement.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of Vit Vittatoe, Parking Manager. She spoke about parking in the City.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke in regards to the possibility of permit parking in his neighborhood.

4.E. SUPPLEMENTAL AGREEMENT WITH M.C.E. CORPORATION AT ADD STREET MAINTENANCE SERVICES ON SANTA MONICA BOULEVARD TO THE STREET MAINTENANCE WORK PROGRAM:

Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated March 15, 1999.

ACTION: 1) Approve a supplemental agreement with M.C.E. Corporation in an amount not to exceed \$250,000 for street maintenance services on Santa Monica Boulevard for Fiscal Year 1998-99; 2) Authorize the City Manager to execute the supplemental agreement; and, 3) Authorize the Director of Finance to establish an operating/capital budget in the Santa Monica Boulevard Improvement Fund, and to appropriate \$200,000 in Fiscal Year 1998-99 reserve funds to cover the contract costs.

5.B. PROPOSED PILOT PROJECT FOR CITY HALL LOS ANGELES COUNTY SHERIFF'S DEPARTMENT SECURITY OFFICER:

City Manager Makinney provided background information as outlined in the staff report dated March 15, 1999.

Councilmember Prang abstained from discussion due to a conflict of interest.

JOYCE ROONEY, representing West Hollywood Municipal Employees Union, spoke in support of the item.

Mayor Pro Tem Heilman spoke about the alarm at City Hall and the lack of response by the alarm company or the Sheriffs Department. He directed the City Manager to investigate the problem whether it needs fixing or if there is a need for a new one.

**ACTION:** 1) Approve the implementation of a three-month Pilot Project for City Hall security services to be provided by an L.A. County Sheriff's Security Officer; 2) Direct staff to report back to City Council in July; and, 3) Authorize the allocation of undesignated reserves in the amount of \$16,300 for the remainder of Fiscal Year 1998-99.
