- A dog or other animal is deemed to be dangerous when it shall have
  - Attacked, bitten or caused personal injury without reasonable provocation;
- Prior to a hearing that the animal control authority (Los Angeles County Department of Animal Care and Control) can designate, after investigation a dangerous dog;
- Owner of a designated dangerous dog would be required to register the dog with the animal authority;
- Owner of a designated dangerous dog would be required to post liability insurance or bond with the City;
- A designated dangerous dog would be required to wear a bright fluorescent colored collar;
- Violation of the ordinance would be a misdemeanor offense.

#### 4.1. UNFINISHED BUSINESS – SANTA MONICA BOULEVARD:

## 4.A. APPROVAL OF THE CONSTRUCTION MITIGATION PLAN FOR THE SANTA MONICA BOULEVARD REHABILITATION PROJECT:

Ray Reynolds, Director of Community Development and Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated February 16, 1999.

Councilmember Guarriello

Mayor Pro Tem Heilman asked if the Holly Hills Storm Project to resolve drainage issues.

Modified parking will you come back with recommendations.

Relocating street lights while the street is being widened.

All work take place between 8 am. And 4pm. Are there any phases that can be done during the night to speed up the project.

Sharon stated that there will be nightime work that might expedite and cause less disruption. Some sidewalk work it is necessary to do in the day due to the high quality of work.

He asked if an early completion bonus is being considered.

She stated that there are some specific work items that are being considered.

Ground breaking ceremony and completion ceremony is fine but the cost is unrealistic.

Mayor Martin stated that his concern is that the construction begins at 8 a.m. and look at construction beginning at 7 a.m. instead.

Mayor Pro Tem Heilman stated that he is in favor of the fastest way.

Councilmember Prang asked if there are any other ideas to help the businesses through the construction period.

Informational signage is part of the project.

Finance department

Councilmember Prang asked it MTA had

Councilmember Koretz asked how long of a disruption in front of a typical business.

Sharon stated that approximately 2 months of disruption of the sidewalk. The disruption varies depending on the eastside or the westside due to the added right-of-way on the westside.

Ray Reynolds, Director of Community Development

JOHN ALTSHUL, WEST HOLLYWOOD, Chair of West Hollywood Chamber of Commerce, stated that construction on the eastside and westside will definitely impact the businesses negatively.

DONALD BRUHNKE, WEST HOLLYWOOD, stated that the disruption will cause 30% of the businesses to close. Spoke in regards to the City aiding the businesses financially.

BARBARA HAMAKER, WEST HOLLYWOOD, suggested that each month there be an open house to include the businesses most effected. Partner

the businesses on the eastside and westside and work with the boards and commissions.

DAN KOVATCH, WEST HOLLYWOOD, spoke of his concerns of closing off the eastside and westside at the same time. The developer should do a survey and he should pay for it not the City.

EFFIE REUVENI, WEST HOLLYWOOD, spoke about replacing the greenspace

City Manager Makinney stated that there will be two lanes at all times and that the City is the developer. The City does not think that there will be a 30% lost of businesses. He also stated that Barbara Hamaker had some great ideas which have already been incorporated in the mitigation plan.

SEMA ASSOCIATES, spoke about the strategy to minimize the disruption to the businesses and the residents with directional signage and informational signage.

Ray Reynolds stated that there will always be traffic movement on Santa Monica Blvd. On the eastside there will be one lane for a period of four months.

City Engineer Perlstein stated that there will be message boards placed in advance of the City to inform people of construction ahead and alternative routes available.

Mayor Martin requested a meeting with Events Coordinator to move special events to other streets if necessary.

Councilmember Prang stated that the staff should inform the businesses as soon as possible about the schedule of construction.

ACTION: 1) Approve the Construction Mitigation Plan for the Santa Monica Boulevard Rehabilitation Project; and, 2) Direct staff to proceed with the recommended Implementation Measures. Motion Mayor Pro Tem Heilman, seconded by Councilmember Guarriello and unanimously carried.

Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated February 16, 1999.

ACTION: 1) Approve a professional services agreement with SEMA Associates, LLC. In an amount not to exceed \$345,000 to provide community relations services for the construction of the Santa Monica Boulevard Rehabilitation Project; and, 2) Authorize the City Manager to execute the agreement. Motion Councilmember Guarriello, seconded by Councilmember Prang and unanimously carried.

4.C. BUSINESS LICENSE TAX RELIEF FOR BUSINESSES AFFECTED BY THE SANTA MONICA BOULEVARD REFURBISHMENT PROJECT:
Rich Ryan, Deputy to Mayor Martin and Jim Sweeney, Deputy to Councilmember Guarriello, provided background information as outlined in the staff report dated February 16, 1999.

DONALD BRUHNKE, WEST HOLLYWOOD, spoke in regards to the businesses which will be disrupted during construction of the boulevard.

ACTION: 1) Direct the Department of Finance and the Department of Community Development along with the offices of Mayor Steve Martin and Councilmember Sal Guarriello to work together on a suitable program that defines eligibility, fiscal impact, and implementation; and, 2) Direct these same parties to report back to the City Council within ninety (90) days with the proposed program for City Council approval. Motion Councilmember Guarriello, seconded by Councilmember Prang and unanimously carried.

4.D. 1999 CITY OF WEST HOLLYWOOD RENTERS PROTECTION ACT:
Hal Cronkite, Director of Rent Stabilization, provided background information as outlined in the staff report dated February 16, 1999.

ACTION: 1) Direct staff to strictly enforce existing antidiscrimination laws; 2) Direct the City Attorney to prepare an amendment to Section 6410(b) (2) which extends the provisions of Section 6410 (a) (4) (d) to tenancies which begin after January 1, 1999; 3) Direct the Rent Stabilization staff to vigorously enforce Section 6410 (b) (2) (a) of the Rent Stabilization Ordinance which denies rent increases upon vacancies to landlords who terminate Section 8 contracts; and, 4) Direct staff to regularly monitor for one (1) year units from which tenants have been evicted or tenancies terminated for the purpose of an owner or relative occupancy, in order to determine full compliance with the requirements for such a termination of tenancy under the Rent Stabilization Ordinance of West Hollywood. Motion Mayor Pro Tem Heilman, seconded by Councilmember and unanimously carried.

#### 5. NEW BUSINESS:

## 5.A. CELEBRATE WEST HOLLYWOOD AND PROMOTE OUR GREAT CITY WITH A FLOAT IN THE 2001 ROSE PARADE:

Scott J. Svonkin, Deputy to Councilmember Koretz, provided background information as outlined in the staff report dated February 16, 1999.

BARBARA HAMAKER, WEST HOLLYWOOD, stated that this is extremely expensive and it would require an enormous amount of work.

ACTION: 1) Direct the City Manager to form a blue ribbon committee made up of no more than nine (9) members including two (2) Council Offices, one (1) Convention and Visitors Bureau, one (1) Chamber of Commerce, one (1) City Staff Member, one (1) Arts or the Design Community Representative and the remaining at the discretion of the City Manager; and, 2) Report back to Council with a draft timeline/work plan within thirty (30) days. Motion Councilmember Prang, seconded by Councilmember Guarriello and unanimously carried.

#### 5.B. CREATION OF THE "APRIL APRICOT PET FOOD FOUNDATION":

Jim Sweeney, Deputy to Councilmember Guarriello, provided background information as outlined in the staff report dated February 16, 1999.

Mayor Pro Tem Heilman stated there there is no city funding anticipated. Create a system with the existing businesses

ANGIE BECKETT, WEST HOLLYWOOD, spoke in support of this item and thanked the City Council for bringing the item.

EFFIE REUVENI, WEST HOLLYWOOD, stated that there are a number of pet food manufacturers that would donate food.

CAROL RODRIGUEZ, WEST HOLLYWOOD, suggested a storage place for the pet food and a dog park.

DAN KOVATCH, WEST HOLLYWOOD, spoke in support of this foundation.

NORMAN CHAMROFF, WEST HOLLYWOOD, stated that man animals could be saved through this foundation.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of the creation of this foundation.

ACTION: 1) Direct staff to work with Councilmember Guarriello's office and interested community members to determine feasibility of a pet food relief program in the City of West Hollywood; and, 2) Direct staff to report back to the City Council on its findings and, if appropriate, a proposed program along with any fiscal impacts to the City. Motion Councilmember Mayor Pro Tem Heilman, seconded by Councilmember Guarriello and unanimously carried.

5.C. DIRECTION TO STAFF TO DEVELOP A PARKING POLICY FOR THE HOLIDAY SEASON THAT DOES NOT PENALIZE THOSE WHO MISTAKENLY PARK IN RESTRICTED RESIDENTIAL PARKING ZONES ON CHRISTMAS DAY.

Councilmember requested that this item include Rashashon and \_\_\_\_\_-

Mayor Pro Tem Heilman stated that after consultation with Attorney Jenkins this law can only be applied to secular holidays not religious ones, which is in line with the constitution.

DONALD BRUHNKE, WEST HOLLYWOOD, spoke in support of the City declaring certain days "City Parking Free" days.

Mayor Pro Tem Heilman stated that people will challenge an unconstitutional law.

Councilmember Prang stated his disappointment of having to bring this item to Council and that staff

Scott Svonkin stated there is current pending legislature to change the law.

Attorney Jenkins stated that no legislature will change the intent of the constitution.

Motion Mayor Pro Tem Heilman, seconded by Mayor Martin and unanimously carried.

#### MONTHLY ANIMAL ADOPTION PROGRAM:

ACTION: 1) Promote pet adoption on the City's Cable Channel; 2) Direct staff of the Human Services Department to coordinate with SPCA-LA to provide the animals for this program; and, 3) Direct the Public Information Division to design and implement a public awareness campaign around the new program including featuring an additional adoption once a month. Direct staff to expand the program to include other members of the community.

Motion Mayor Pro Tem Heilman, seconded by Councilmember Prang.

2.O. PROPOSED RESOLUTION CALLING FOR A REGIONAL AIRPORT PLAN FOR SOUTHERN CALIFORNIA AND OPPOSING THE CITY OF LOS ANGELES DEPARTMENT OF AIRPORTS MASTER PLAN FRAMEWORK FOR LOS ANGELES INTERNATIONAL AIRPORT:

Councilmember Prang and Denny Zane, provided background information as outlined in the staff report dated February 16, 1999.

Mayor Pro Tem Heilman stated that he does not support this item.

Mayor Martin stated that the real issue is air cargo.

Oppose the expansion only if not done in a regional solution and join with neighboring cities.

ACTION: 1) Adopt Resolution No. 99-2026, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD OPPOSING THE MASTER PLAN PROPOSED BY THE CITY OF LOS ANGELES DEPARTMENT OF AIRPORTS AND CALLING FOR THE DEVELOPMENT OF A LONG TERM REGIONA!.. STRATEGIC PLAN FOR OUR AIR TRAFFIC NEEDS;" and, 2) Direct staff to forward copies of this resolution to the City of Los Angeles Departments of Airports and Airports Commission, the Mayor and City Council of Los Angeles, and neighboring Cities.

Motion Mayor Martin, seconded by Councilmember Koretz and carried noting the NO vote of Mayor Pro Tem Heilman.

#### **PUBLIC COMMENT**

CAROL RODRIGUEZ, WEST HOLLYWOOD, spoke in regards to her stolen checks and she asked the City Council to reappoint Brad Sullivan to the Public Safety Commission.

DONALD BRUHNKE, WEST HOLLYWOOD, spoke about Item 2 N. Dangerous Animal (Dog) Ordinance Revision and the need to be careful in the wording of the ordinance and the way that it is enforced.

BARBARA HAMAKER, WEST HOLLYWOOD, spoke about next month being Women's History Month. She also thanked the City Council on their decision of the Gateway Labrea Project. She also spoke about Century Cable and some problems with audio without satisfaction from their Customer Service department.
