CALL TO ORDER: Mayor Martin called the meeting to order at 6:22 p.m.

APPROVAL OF AGENDA:

Councilmember Koretz requested that the City Council add an Urgency Item 2.AA, RESOLUTION IN SUPPORT OF OUR TROOPS IN KOSOVO AND PRESIDENT CLINTON'S LEADERSHIP.

ACTION: Motion to add Urgency Item 2.AA. Councilmember Prang, seconded by Councilmember Guarriello and unanimously carried.

Staff requested to clarify the Action for Item 2.Y. Recommendation should read: 1) Approve a supplemental agreement with Psomas in an amount not to exceed \$50,000 to provide GIS programming and development services for completing and maintaining the City's Parking Supply-Demand Model; and, 2) Authorize the City Manager to execute the supplemental agreement.

ACTON: Approve the April 5, 1999 Agenda as presented. Motion Councilmember Guarriello, seconded by Councilmember Prang and unanimously carried.

Mayor Martin opened nomination for Mayor of the City of West Hollywood. Mayor Pro Tem Heilman was nominated. By consensus the City Council closed the nominations.

Mayor Heilman opened nominations for Mayor Pro Tempore of the City of West Hollywood. Councilman Prang was nominated. By consensus the City Council closed the nominations.

ACTION: Elect Jeffrey Prang as Mayor Pro Tempore of the City of West Hollywood for a one-year term. Motion Councilmember Koretz, seconded by Councilmember Guarriello and unanimously carried.

ADMINISTER THE OATH OF OFFICE TO THE NEWLY ELECTED MAYOR AND MAYOR PRO TEMPORE:

The Honorable Stephen Lachs, Judge Superior Court of the State of California administered the Oath of Office to the newly elected Mayor Heilman and Mayor Pro Tempore Prang.

City Clerk Thompson read a Proclamation by the Governor of the State of California, Grey Davis, proclaiming April 5, 1999 as "John Heilman Day."

COUNCILMEMBER COMMENTS:

Councilmember Martin requested to adjourn the City Council meeting in memory of Jeanne Dobrin's cat, Little Person.

Councilmember Martin thanked Bill Weinberger, Abbe Land, and Morris Kight for coming. He also thanked Judge Lach for administering the oath. He spoke about the changes of the City and Mayor Heilman's leadership and his fight to protect the Cannabis Clubs for medical marijuana. He spoke about the take over of Santa Monica Blvd., the Teen Center at Plummer Park and the opening of the Gateway Project. He emphasized the assistance from staff. He thanked his Deputy Rich Ryan and Administrative Assistant, Larissa Fooks. Councilmember Martin gave Mayor Heilman an autographed book, <u>Trailblazers</u>, <u>Profiles of America's Gay and Lesbian Elected Officials</u> of by Ken Yeager.

Mayor Heilman presented Councilmember Martin with the ceremonial gavel with appreciation for his contribution to the City.

Councilmember Guarriello thanked his deputy, Jim Sweeney along with many of his supporters and workers for his re-election.

He talked about the new changes for the City of West Hollywood and asked for the support and patience of the business owners during the reconstruction of Santa Monica Boulevard.
