MONDAY, MAY 5, 1997  
WEST HOLLYWOOD PARK**

**CALL TO ORDER:** Mayor Guarriello called the meeting to order at 7:08 p.m.

**PLEDGE OF ALLEGIANCE:** Bruce Traub led the Pledge.

**ROLL CALL:**

PRESENT: Councilmembers - Heilman, Koretz, Prang, Martin and Mayor Guarriello.

ABSENT: Councilmembers - None.

ALSO PRESENT: City Manager Makinney, City Attorney Jenkins, Assistant City Clerk Thompson and Acting Deputy Clerk Schroeder.

**REPORT OF CLOSED SESSION AGENDA:** City Attorney Jenkins stated that at 6:00 p.m. the City Council called the meeting to discuss items contained on the Closed Session Agenda. The City Council unanimously voted to add an item under Existing Litigation entitled Apartment Association of Greater Los Angeles v. City of West Hollywood due to a recent development that occurred since the agenda was posted, and then adjourned into Closed Session. City Attorney Jenkins reported on the following claims: City of West Hollywood v. Buckley, Toy Food v. City of West Hollywood and Apartment Association of Greater Los Angeles -- the City was victorious and all three claims were defeated. City Attorney Jenkins announced that the City Council appointed Charlie Makinney as City Manager, subject to contract negotiation. The Closed Session adjourned at 6:55 p.m. a written report is on file with the City Clerk.

**APPROVAL OF AGENDA:**

Councilmember Koretz asked the City Council to add an urgency item to the agenda: APPROVAL OF THE CALIFORNIA AIDS RIDE 4 AS A CITY EVENT, as Consent Calendar Item 2.II.

Councilmember Martin asked that item 4.G. be tabled.

Councilmember Heilman requested that item 4.G. not be tabled to allow speakers to address the Council regarding the item.

Councilmember Heilman noted his opposition to Item 2.I.

Assistant City Clerk Thompson moved Item 5.C. to the Consent Calendar as Item 2.JJ.

Councilmember Prang pulled Item 2.DD. for separate discussion.

Mayor Guarriello stated the City Council will adjourn tonight's meeting in memory of Kenny House, brother to Terry House in CATV.

**Motion to approve the agenda as amended Councilmember Heilman, seconded by Councilmember Prang and unanimously carried.**

**PRESENTATIONS:**

Councilmember Prang presented a proclamation to Donald DeLuccio to recognize his service to the City.

Councilmember Heilman presented a Commendation to the Social Action Committee of Congregation Kol Ami for being awarded the Irving J. Fain Award in Social Action by the Union of American Hebrew Congregations.

Councilmember Heilman and Mayor Guarriello proclaimed the week of May 5 through May 9, 1997 as Public Service Recognition Week and presented the proclamation to the Bargaining Unit's Presidents.

Councilmember Martin and Mayor Guarriello proclaimed the Month of May as Seniors Month.

Mayor Guarriello Proclaimed the week of May 5 though May 9, 1997 as City Clerk Recognition Week and presented the proclamation to the staff of the City Clerk's Office. Mayor Guarriello presented a commendation to all those persons who assisted in the Municipal Election on March 4, 1997 and presented a plaque to the City Clerk's Division staff.

**1. CITIZEN COMMENTS**

RUTH WILLIAMS, WEST HOLLYWOOD, spoke regarding her son's accident at Spaulding and Lexington and her concern regarding four way stops that can prevent such accidents. She also spoke in support of the selection of City Manager Makinney.

JOHN UNDERWOOD, WEST HOLLYWOOD, spoke in support of the appointment of the new City Manager and urged Council to conduct an independent study concerning cost analysis especially in the area of public safety.

DR. BILL GRIFFIN, WEST HOLLYWOOD, spoke on behalf of the Gay and Lesbian Advisory Council expressing his support of Coors Brewing Co. for their efforts towards gays and lesbians.

CRAIG RITCHIE, WEST HOLLYWOOD, spoke on item 4.G. and believes that the money is better spent on a public safety study. Also spoke regarding Santa Monica Boulevard and Eastside Redevelopment.

BRIAN QUINTANA, WEST HOLLYWOOD, spoke on behalf of The Pedro Zamora Society regarding educating youth on HIV issues and announced the new national headquarters location in West Hollywood at the Pacific Design Center.

DONALD DE LUCCIO, WEST HOLLYWOOD, spoke regarding the search for City Manager and complimented the new City Manager on his professionalism.

JOHN ALTSCHUL, WEST HOLLYWOOD, spoke against the manner in which the City Manager was appointed and in favor of a more expansive recruitment search.

TIM PERRY, WEST HOLLYWOOD, expressed gratitude to Council for their support of California Aids Ride 4.

ROSALYN KRAUSE, WEST HOLLYWOOD, spoke against a national search for the City Manager and in support of City Manager Charlie Makinney.

MICHAEL JOHN HORNE, spoke in support of Charlie Makinney as City Manager.

BATALLION CHIEF PAUL HACKER, of the Los Angeles County Fire Department in support of the Council's support of Proposition E.

EDWARD J. ANDRYCZYK, LOS ANGELES, stated that Plummer Park is not utilized properly as a park because the City and the City's contractors drive through the park and endanger citizens.

ALMA ICHINOSE, LOS ANGELES, congratulated Charlie Makinney on his appointment and stated that she would like to see more women as leaders in the City. Also spoke regarding the City's support of the Alcohol and Drug Center and the physical improvement of the Center. She also asked that the Council increase its support of the Center.

MICHAEL KRAUT, WEST HOLLYWOOD, spoke against the manner in which Charlie Makinney was appointed and that without a larger search certain groups are prejudiced and excluded.

JOYCE HUNDAL, WEST HOLLYWOOD, thanked the Council and Director Reynolds for the meeting with Kass-Bah. She also congratulated City Manager Makinney.

KITTY COLE, WEST HOLLYWOOD, spoke regarding problems with Olive Drive and that he cannot get home due to the Mondrian and the House of Blues. Also, offered his services with the development of Santa Monica Boulevard.

## **COUNCILMEMBER COMMENTS:**

Councilmember Prang introduced his new Council Deputy Daniel Dusterberg.

Councilmember Heilman responded to Mr. Andryczyk's problem at Plummer Park and asked Sam Baxter to look into this problem and report to Council.

Councilmember Koretz commented on machinery being used at West Hollywood Park at 11:00 a.m. Sunday morning with numerous children in its presence.

Mayor Pro Tem Martin responded to the Olive Drive access issue and stated that the City should address this issue. Congratulated newly appointed City Manager Makinney on his appointment and discussed the manner in which he was appointed.

Mayor Guarriello spoke regarding the lack of participation in a seminar concerning fraud and Senior Citizens. He also addressed the appointment of the City Manager and discussed the manner in which he was appointed.

**CITY MANAGER'S REPORT:** City Manager Makinney thanked speakers for their remarks. He also announced that the Cuervo Art was removed and thanked Fran Solomon, Deputy to Councilmember Heilman, for her efforts.

**FISCAL IMPACT ON CONSENT CALENDAR:** Assistant City Clerk Thompson stated that the Fiscal Impact on the Consent Calendar as amended for May, 5, 1997 is \$253,464. in expenditures and \$21,519. in potential revenues.

THE WEST HOLLYWOOD CITY COUNCIL RECESSED AT 8:05 P.M. AS THE WEST HOLLYWOOD COMMUNITY DEVELOPMENT COMMISSION. The minutes of the Commission are set forth in full in the records of the West Hollywood Community Development Commission.

THE WEST HOLLYWOOD CITY COUNCIL RECONVENED AT 8:08 P.M. FOR THE FOLLOWING JOINT PUBLIC HEARING.

**ROLL CALL OF COMMISSION:**

**PRESENT:** Commissioners - Heilman, Koretz, Prang, Martin and Guarriello.

**ABSENT:** Commissioners - None.

**B. JOINT PUBLIC HEARING OF THE WEST HOLLYWOOD CITY COUNCIL AND THE WEST HOLLYWOOD COMMUNITY DEVELOPMENT COMMISSION ON THE PROPOSED REDEVELOPMENT PLAN FOR THE EAST SIDE PROJECT AREA AND THE FINAL ENVIRONMENTAL IMPACT REPORT FOR THE PROPOSED REDEVELOPMENT PLAN FOR THE EAST SIDE PROJECT AREA:**

Assistant City Clerk Thompson stated that a Notice of Joint Meeting and Public Hearing along with maps and legal descriptions were published in the West Hollywood Independent on April 9, April 16, April 23 and April 30, 1997. The City Clerk's Office has received no letters of objection.

ANN EARENTHAL, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

TAI GLENN, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

PAUL ZIMMERMAN, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

MARK LEHMAN, WEST HOLLYWOOD, spoke for himself and on behalf of the Chamber of Commerce and Don Savoie, in support of the Plan.

AMY ANDERSON, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan. She also addressed the eminent domain issue.

FRED VANACORE, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

CHAD BLOUIN, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

MARK GALLO, WEST HOLLYWOOD, spoke in support of the Plan.

EDWARD GARREN, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

INNIS BRUNER, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

RUSSELL HAMMERL, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

NADIA SUTTON, EXECUTIVE DIRECTOR OF PAWS LA, spoke in favor of the Plan.

HOWARD WATTS, LOS ANGELES, complained about maps in the West Hollywood Independent and spoke regarding several court cases.

ANSON SNYDER, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan. He also stated that changes will be made in the plan and he hopes that the Council supports those changes.

THOMAS JONES, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

JOSEPHINE VALIULIS, WEST HOLLYWOOD, spoke on behalf of her in-laws and expressed her concern regarding eminent domain and seniors that will be negatively impacted

DONNY CACY, WEST HOLLYWOOD, spoke as a member of the Project Area Committee and in support of the Plan.

Councilmember Heilman asked staff to return with the written resolutions at a future meeting. Councilmember Heilman directed staff to meet with residents that expressed reservations regarding the Plan. He also thanked all who worked on and supported the Plan.

Councilmember Koretz spoke in support of the Project Area Committee's work and the Plan.

Mayor Pro Tem Martin also spoke in support of the hard work of the Project Area Committee and thanked the members. He stated that eminent domain is a necessary tool in commercial areas and that he cannot see eminent domain being used in residential areas.

Mayor Guarriello spoke in support of the Project Area Committee's work.

Mayor Guarriello closed the public hearing.

**B. PUBLIC FACILITIES COMMISSION APPOINTMENTS:**

Assistant City Clerk Thompson provided background information as outlined in the staff report dated May 5, 1997.

Kathryn Hahn, Barry Greenfield, David Gold, Bud Siegel, and John Disquah were nominated.

**ACTION:** Appoint Kathryn Hahn and Bud Siegel to the Public Facilities Commission, as "at-large" appointments for terms ending May 31, 1999. **By consensus of the City Council.**

**C. RECOMMENDATIONS FROM THE AD-HOC FERAL CAT COMMITTEE:**

Sam Baxter, Landscape and Building Maintenance Manager provided background information as outlined in the staff report dated May 5, 1997.

DR. BILL GRIFFIN, WEST HOLLYWOOD, stated that a problem exists near his residence with feral cats and spoke against the proposed ordinance.

DONALD DE LUCCIO, WEST HOLLYWOOD, reiterated the previous speaker's comments and read a letter from West Hollywood West Residents Association which stated opposition to the proposed ordinance.



MICHAEL GOTTFRIED, WEST HOLLYWOOD, spoke against the proposed ordinance and commented on health risks associated with feral cats. Asked Council to reject the ordinance and develop a program to eradicate the cats.

WAYNE BLANKENSHIP, WEST HOLLYWOOD, spoke as a member of the ad hoc committee against the proposed ordinance and reiterated the previous speaker's comments.

MARTIN STARR, WEST HOLLYWOOD, spoke against the proposed ordinance because of the health risk to those living with HIV like himself.

CRAIG RITCHIE, WEST HOLLYWOOD, stated that he does not believe that a health hazard exists. Also, he spoke in favor of the proposed ordinance and feels that it is an appropriate compromise.

EDWARD ZAVORA, WEST HOLLYWOOD, spoke against the proposed ordinance and in favor of removing the feral cat colonies.

EFFIE REUVENI, WEST HOLLYWOOD, spoke in favor of the feral cat ad hoc committee's decision.

JOYCE HUNDAL, WEST HOLLYWOOD, spoke against the proposed ordinance and reiterated concerns of previous speakers.

ROSALYN KRAUSE, WEST HOLLYWOOD, as a member of the ad hoc committee spoke in favor of the ordinance. She stated that the ordinance regulates feral cats and does not support feral cat colonies.

SAUNDRA MAY, WEST HOLLYWOOD, as a former member of the Animal Task Force spoke in support of the ad hoc committee's decision in favor of the proposed ordinance.

FRANK SANELLO, WEST HOLLYWOOD, spoke in support of the proposed ordinance.

DORIS ROMEO, WEST HOLLYWOOD, member of the ad hoc committee spoke in favor of the proposed ordinance.

DEBORAH FAMIGLIETTI, WEST HOLLYWOOD, spoke in favor of the proposed ordinance.

ANITA GOSWAMI, WEST HOLLYWOOD, spoke against the proposed ordinance.

STEPHEN ROSE, WEST HOLLYWOOD, spoke against the proposed ordinance.

ROCKY MIKE MANSDORF, WEST HOLLYWOOD, spoke in favor of passing the proposed ordinance.

STAN LOTHDRIDGE, WEST HOLLYWOOD, discussed the ad hoc committee's proceedings and spoke in favor of passing the proposed ordinance.

NORMA SANDLER, WEST HOLLYWOOD, former member of the Animal Welfare Task Force, spoke in favor of the proposed ordinance and commented on the concerns of speakers who spoke against the ordinance.

Councilmember Koretz stated that individual disputes may be the real concern of some speakers; he spoke in support of the proposed ordinance.

Councilmember Heilman spoke against the proposed ordinance because of West Hollywood's high density population. Councilmember Heilman stated that he does not agree with destroying the animals but that feral cat colonies should not be supported.

Councilmember Prang addressed speakers' comments regarding their support of the proposed ordinance. Councilmember Prang stated that this ordinance was an unusual way of addressing this problem.

Mayor Pro Tem Martin stated his concern that this ordinance was to be a compromise and that it does not set up any procedures.

Councilmember Heilman expressed his concern that the Council was not in consensus and that the ad hoc committee should meet again and address the issues raised by Councilmembers.

Sam Baxter stated that the ad hoc committee should have clear direction from Council.

Mayor Pro Tem Martin stated that the ordinance does not create the ability to license feral cat colonies.

Councilmember Prang stated that this City-wide ordinance is being created to address the issue in one neighborhood.

Mayor Guarriello stated that this must be feasible to the entire community not just to a special group.

Councilmember Prang stated that staff should come back with additional information and that he would support this ordinance.

Councilmember Koretz stated that an individual nuisance should be limited to that individual neighborhood and treated as an individual nuisance and should not be applied City-wide via an ordinance.

Mayor Pro Tem Martin suggested defining the feral cat colony as a nuisance and address it as such.

Mayor Guarriello asked about the county's opinion on feral cats.

**ACTION:** Direct staff to return with three different versions of the ordinance; one that would be similar to that outlined by the ad hoc committee; the second ordinance that would generally prohibit feral cat colonies in the City of West Hollywood; a third ordinance that would require a nuisance to be declared which would trigger a hearing to require a license of a specific colony. Cost impacts of all ordinances should also be included.

**Motion Councilmember Heilman, seconded by Mayor Pro Tem Martin and unanimously carried.**

**D. MELROSE AVENUE CURB EXTENSIONS AND BOLLARDS:**

**ACTION:** Continue to May 19, 1997.

**Motion Councilmember Prang, seconded by Councilmember Koretz and carried noting the NO votes of Councilmember Heilman and Mayor Guarriello.**

**E. CONDITIONS OF APPROVAL FOR PARKING USE PERMIT 95-09 AND FOR OFF-SITE PARKING AND REQUEST FOR REDUCTION OF PARKING REQUIREMENTS FOR THE WEST HOLLYWOOD DRUG AND ALCOHOL CENTER 8206 - 8208 SANTA MONICA BOULEVARD:**

Tim Foy, Associate Planner, provided background information as outlined in the staff report dated May 5, 1997.

MARK LEHMAN, WEST HOLLYWOOD, spoke on behalf of the West Hollywood Drug and Alcohol Center and in favor of the efforts that the Center has made in obtaining the required parking. He requested that the Council accept the current proposal.

The City Council asked questions regarding the current leases the Center has obtained.

LARRY GILL, LAGUNA BEACH, spoke as a member of the board in support of adoption of this item.

CHARLES H. JONES, President of the Center, thanked Councilmember Koretz for his efforts and said he will meet with Tim Foy to discuss parking plan.

KENNETH SEELEY, spoke in support of this item.

ROBERTA-JOY DESIMONE, WEST HOLLYWOOD, asked Council for their support.

GORDON SCHROEDER, thanked Council.

NORMA KEMPER, WEST HOLLYWOOD, stated her concern regarding the amount of parking that is currently impacting the surrounding neighborhood.

TONY BROCCOLI, WEST HOLLYWOOD, spoke in support of the Center.

STEVE FINELY, WEST HOLLYWOOD, spoke in support of the Center.

MEGAN YEWS, WEST HOLLYWOOD, spoke in support of the Center.

MINA NEUGASS, is a volunteer at the Center who spoke in support of the Center.

CHRIS PATROUCH, WEST HOLLYWOOD, business owner near the Center, stated that there may not be as serious parking problem as stated. Discussed the night time shuttle and other alternatives to reduce the parking problems.

Councilmember Heilman stated that the public hearing does not need to be reopened. Councilmember Heilman suggested that the Center obtain a lease of a certain number of parking spaces from the City and asked staff to come back with a resolution so stated.

Councilmember Prang reiterated Councilmember Heilman's suggestion regarding the City's parking structure and stated his support for utilizing the City's parking structure.

Councilmember Koretz stated that people need to keep out of the neighborhoods in order to keep the Center open.

**ACTION:** Direct staff to prepare a Resolution granting Parking User Permit 95-09 as directed at the January 6, 1997 City Council meeting, but allowing the West Hollywood Drug and Alcohol Center to meet some of the parking lease requirements, by leasing spaces from the City at its parking structure located at 8383 Santa Monica Boulevard.

**Motion Councilmember Heilman, seconded by Councilmember Koretz and unanimously carried.**

**F. REMOVAL OF PUBLIC SAFETY COMMISSIONER:**

Councilmember Prang provided background information as outlined in the staff report dated May 5, 1997 and stated his intent to remove Commissioner Norma Kemper from the Public Safety Commission.

NORMA KEMPER, WEST HOLLYWOOD, stated that she enjoyed serving on the Commission and the Commission as a whole is to be commended. She concluded her comments by declaring her resignation from the Commission.

MICHAEL KRAUT, WEST HOLLYWOOD, spoke in support of Norma Kemper's service. He also addressed Councilmember Prang's decision to remove Norma Kemper.

**G. CITY MANAGER RECRUITMENT:**

Councilmember Heilman provided background information as outlined in the staff report dated May 5, 1997. Councilmember Heilman stated that he does not support the decision to appoint the Interim City Manager and that a professional recruitment should have been done.

Councilmember Koretz stated that the selection of Charlie Makinney was a good one, however a national search allowing for public comment would have been even better.

Mayor Pro Tem Martin responded to Councilmember Heilman's proposed agenda item and that this decision was the most appropriate.

Councilmember Prang stated that he voted for the new City Manager because he is the appropriate candidate and that Charlie Makinney has proven his ability.

Mayor Guarriello stated that he was always open about his decision on this issue.

DR. BILL GRIFFIN, WEST HOLLYWOOD, stated that he respects the Council's decision and respects the new City Manager but that the community

should have been more involved in the selection process and that there should have been options presented other than the new City Manager.

MICHAEL KRAUT, WEST HOLLYWOOD, discussed Councilmember Prang's campaign literature and that a national search should have been conducted.

ROBERTA-JOY DESIMONE, WEST HOLLYWOOD, spoke against the process of selecting the City Manager and in support of a national recruitment.

SIMON HARVEY, WEST HOLLYWOOD, addressed Councilmember Prang's campaign issues. He also addressed Mayor Guarriello's comments.

CHRIS PATROUCH, WEST HOLLYWOOD, addressed Mayor Guarriello's comments regarding the previous speaker. He also spoke against the decision of the Council not to include the community in the decision-making process.

JACQUELINE BALOGH, WEST HOLLYWOOD, spoke in support of the appointment of the new City Manager. Addressed Councilmember Koretz's and Councilmember Prang's campaign comments.

DOUG ROUTH, WEST HOLLYWOOD, spoke against the process of the appointment of the new City Manager and expressed concern that no public hearing was held.

BRUCE TRAUB, WEST HOLLYWOOD, spoke in support of the process of the appointment of the new City Manager.

TAI GLENN, WEST HOLLYWOOD, spoke regarding the diversity in City staffing and that the City is failing to achieve inclusion and diversity.

JEANNE DOBRIN, WEST HOLLYWOOD, addressed the previous speaker's comments. Spoke regarding the selection of Gay Forbes and responded to Michael Kraut's comments. Spoke in support of the appointment of the newly appointed City Manager.

Councilmember Heilman stated that Council should now support the new City Manager but should, in the future, expand the way searches are conducted.

Mayor Pro Tem Martin stated that newly appointed City Manager Makinney has opened up the process to citizens.

Councilmember Prang stated that during his campaign and after his election he has spoken to the public and based his decisions on that basis.

Councilmember Koretz congratulated newly appointed City Manager Makinney. He also stated that the process probably should have been more open.

**ACTION:** Action was taken in Closed Session to appoint the Charlie Makinney as City Manager of the City of West Hollywood subject to contract negotiations.

**Motion Mayor Pro Tem Martin, seconded by Councilmember Prang and carried noting the NO vote of Councilmember Heilman.**

**C. APPROVAL OF OPTICAL IMAGING AND ELECTRONIC DOCUMENT MANAGEMENT ELEMENTS OF THE INFORMATION RESOURCE MASTER PLAN:**

This item was moved to the Consent Calendar as Item 2.JJ.

**D. TECHNOLOGY PARTNERSHIP:**

Councilmember Heilman provided background information as outlined in the staff report dated May 5, 1997.

ANITA GOSWAMI, spoke in support of this item.

Councilmember Prang queried whether this is normally handled by business associations.

**ACTION:** Direct the staff of the Finance Department and the Economic Development Division to develop a pilot program that assists West Hollywood businesses in establishing Internet presence designed to promote commerce in West Hollywood.

**Motion Councilmember Heilman, seconded by Councilmember Koretz and unanimously carried.**

**EXCLUDED CONSENT CALENDAR:**

**2.DD. CREATION OF BUDGET MANAGER POSITION:**

Finance Director Arevalo provided background information as outlined in the staff report.

Councilmember Prang stated that he is not comfortable reclassifying a position when the City is entering into a new budget period and he does not feel that this position should be created.

Councilmember Heilman stated that the increased responsibility to staff necessitates this increase.

**ACTION:** Adopt the new classification specification for the Budget Manager position

**Motion Councilmember Heilman seconded by Mayor Guarriello and approved noting the NO vote of Councilmember Prang.**

**CITIZEN COMMENTS:**

HYLAND KUNERTH, WEST HOLLYWOOD, spoke regarding traffic congestion and public safety issues for bicyclists. Also stated that the Sheriff does not allow him to ride safely.

HOWARD ARMISTEAD, WEST HOLLYWOOD, spoke in support of aspirin's positive effect on those with AIDS and he requested that Council adopt a resolution supporting the use of aspirin in combating HIV.

JEANNE DOBRIN, WEST HOLLYWOOD, stated that when she arrived at midnight she could not find parking. She also stated that the City of Baltimore passed an ordinance banning advertisements regarding tobacco and alcohol. She requested the City to adopt a similar ordinance.

**6. LEGISLATIVE:**


