MONDAY, APRIL 7, 1997  
WEST HOLLYWOOD PARK**

**CALL TO ORDER:** Mayor Guarriello called the meeting to order at 7:00 p.m.

**PLEDGE OF ALLEGIANCE:** Carol Rodridguz led the Pledge.

**ROLL CALL:**

PRESENT: Councilmembers - Heilman, Koretz, Prang, Martin and Mayor Guarriello.

ABSENT: Councilmembers - None.

ALSO PRESENT: City Attorney Jenkins, City Clerk Love and Assistant City Clerk Thompson.

**REPORT OF CLOSED SESSION AGENDA:** City Attorney Jenkins stated that at 6:00 p.m. the City Council called the meeting to order and adjourned into a Closed Session to discuss items contained on the Closed Session Agenda. The Closed Session adjourned at 6:55 p.m. and no reportable actions were taken.

**APPROVAL OF AGENDA:**

Councilmember Prang pulled Items 2.G and 2.U and continue to the next meeting. Councilmember Prang removed Item 2.T from the Consent Calendar for separate discussion.

**Motion to approve the agenda as amended by Councilmember Prang, seconded by Councilmember Heilman and unanimously carried.**

**PRESENTATIONS:**

Mayor Pro Tem Martin introduced John Jakupcak who explained the draught tolerant garden signs and the City Council presented a commendation to Takeo Uesugi and the sophomore students of the Basic Landscape Design class of the College of Environmental Design at California State Polytechnic University Pomona.

Professor Takeo Uesugi thanked the City Council for their recognition.

Councilmember Heilman presented a commendation to Dan Bergmann of the Wyndam Bel Age Hotel for being 1996 Best Hotel of the Year by Wyndam.

Councilmember Heilman thanked David Cooley owner of the Abby for providing coffee at the meeting.

Councilmember Heilman introduced and thanked Linda Choy, Intern in the City Council Offices, for staffing the public information table.

Councilmember Heilman presented the City Council Proclamation and proclaimed the month of April as Cancer Detection Month. Marvin Feldman, PR Director of Cancer Detection Center, accepted the Proclamation.

Mr. Feldman thanked the City Council for Proclaiming the month of April as Cancer Detection Month and provided statistics regarding cancer.

**1. CITIZEN COMMENTS:**

STEVEN DAVIS, WEST HOLLYWOOD, spoke in support of Item 5.C AIDS Programming. Informed the Council of the upcoming activities of the Human Services Commission.

ROBERT ANTHONY, LOS ANGELES, representing Project YES, which empowers gay and lesbian youth to take responsibility for their future. He spoke in support of Item 2.T Dignity For All Students Act.

MICHAEL MALLORY, LOS ANGELES, representing Project YES, spoke in support of Item 2.T Dignity For All Students Act. Informed the Council of his personal experiences.

LISA MANATU, LOS ANGELES, representing Project YES, spoke in support of 2.T proposed resolution of support of AB 101 and her personal experiences.

DR. VIRGINIA URIBE, WEST HOLLYWOOD, Founder and Coordinator of Project 10 at Fairfax Avenue, spoke in support of Item 2.T Dignity For All Students Act. Thanked the City Council for their assistance.

GARY COPELAND, WEST HOLLYWOOD, complained about the House of Blues and the problems of destruction of property, urination, trash and parking.

MARK PENN, WHITTIER, representing the Los Angeles Frontrunners Track Club, thanked the City Council for support of Item 2.L.

MICHAELJOHN HORNE, WEST HOLLYWOOD, member of Human Services Commission, spoke in support of Item 5.C AIDS Programming asked the City Council for direction with AIDS care.

KATHERINE THULIOU, WEST HOLLYWOOD, spoke regarding a notice she received from Lucy Dyke regarding the meeting at the Hyatt and the problems at the House of Blues.

JERRY GITMED, LOS ANGELES, representing Hughes Market, spoke in support of Item 3.B change in parking regulations on Wetherly Drive.

ANDREA WAGNER, Director of West Hollywood Employment Services, spoke in support of Item 5.C. Announced the program on June 3rd, Employment Services for Persons with AIDS.

JONATHAN SIEGEL, WEST HOLLYWOOD, stated he made a formal protest against House of Blues and complained regarding the Noticing. Would like a hearing if the license should be revoked.

EDWIN GRAHAM, WEST HOLLYWOOD, stated his noise problems with House of Blues and complained that the Notice he received for the neighborhood meeting was received the day before the meeting.

ANSON SNYDER, WEST HOLLYWOOD, stated his support of Item 5.B and a Nationwide recruitment. Spoke in support of Item 5.C AIDS Programming.

HOWARD ARMISTEAD, WEST HOLLYWOOD, stated he ran for City Council due to the City's lack of parks. He proposed two new parks. He would like the Council to dedicate one City employee for four years to seek funding for new parks.

MARIANGELA MALESPIN, WEST HOLLYWOOD, thanked all of the candidates that ran for office. She pleaded with the City Council to not forget the women in the Community and society.

#### **COUNCILMEMBER COMMENTS:**

Councilmember Heilman directed staff to schedule another meeting and give advance warning regarding the meetings for House of Blues. He also requested a report on the noticing problem. He recognized recent problems with House of Blues.

Councilmember Koretz announced April 24 as take our Daughters to Work Day. He requested the City Manager for a status report at the next Council meeting the progress of Payment of Living Wages of City Contractors and benefits for Domestic Partners of City Contractors.

Councilmember Prang would like a report on allegations of selective enforcement of ABC in Silver Lake Bars.

Councilmember Koretz also stated that another West Hollywood Bar alleged selective enforcement of the ABC.

Mayor Pro Tem Martin stated that five years ago Ed Rainey passed away from AIDS. Directed continued problems with House of Blues to the Public Safety Department and perhaps the SPU.

Mayor Guarriello directed Ray Reynolds, Director of Community Development and Joan English, Director of Transportation to keep on top of House of Blues.

**CITY MANAGER'S REPORT:** Lloyd Long, Director of Human Services, stated Interim City Manager Makinney was ill this evening and had no report.

**FISCAL IMPACT ON CONSENT CALENDAR:** City Clerk Love stated the Fiscal Impact on the Consent Calendar as amended for April 7, 1997 is \$ 481,420. in expenditures and \$368,435. in potential revenue.

Donald Korotsky, Associate Transportation Planner, provided background information as outlined in your staff report dated April 7, 1997.

Mayor Guarriello opened the public hearing and no speakers coming forward the public hearing was closed.

**Motion Councilmember Heilman, seconded by Mayor Guarriello and unanimously carried.**

**4. UNFINISHED BUSINESS:**

**A. DIRECT APPOINTMENTS FOR THE BUSINESS LICENSE, HUMAN SERVICES, PLANNING, PUBLIC SAFETY, RENT STABILIZATION AND TRANSPORTATION COMMISSIONS:**

Councilmember Prang and Councilmember Koretz asked this Item to be continued to May 5, 1997.

**B. PUBLIC FACILITIES COMMISSION APPOINTMENTS:**

Councilmember Heilman appointed Sibyl Zaden to the Public Facilities Commission as his direct appointment for term ending May 31, 1999.

Councilmember Koretz appointed Ben Clavin to the Public Facilities Commission as his direct appointment for term ending May 31, 2001.

Councilmember Prang appointed Michael Sausser to the Public Facilities Commission as his direct appointment for term ending May 31, 2001.

Mayor Pro Tem Martin appointed Susan Pinkus to the Public Facilities Commission as his direct appointment for term ending May 31, 1999.

Mayor Guarriello appointed Mark Montgomery to the Public Facilities Commission as his direct appointment for term ending May 31, 1999.

By consensus the City Council continued "at large" appointments to May 5, 1997.

**5. NEW BUSINESS:**

**A. AUTHORIZATION TO CREATE A CITY ELECTION TASK FORCE:**

Councilmember Heilman provided background information as outlined in the staff report dated April 7, 1997.

RALPH FEELEY, WEST HOLLYWOOD, commented on voter confusion at the current election. Stated his support for consolidation with County. Commented on lower voter turn out. Stated he is opposed to numbered seats.

BRUCE TRAUB, WEST HOLLYWOOD, spoke in support of the Item, and would like the Council to consider the size of the group, to publicize the Task Force, and to take the politics out of this Task Force.

JIM MANGIA, stated he was from the Reform Party, spoke in support of creation of the Task Force.

JOHN DURAN, WEST HOLLYWOOD, spoke in support of the Item. Commented on voter turn out. Suggested voting on-line or by mail. Wanted all of the issues investigated and urged the Council to make this non-political.

SIBYL ZADEN, WEST HOLLYWOOD, spoke in support of the City Election Task Force. Her list of critical issues that she would like addressed: voter registration, polling places, voter turnout, voter parking.

Councilmember Heilman stated City Clerk Love will be handling and selecting the Task Force. The City Council is staying out of the process.

Councilmember Prang stated Tuesday, April 8, is the Los Angeles Consolidated election and the voters may be confused over the two elections. He received complaints regarding polling places. He complimented the City Clerk's staff. He would like to consider numbered seats or a combination of "at large."

Councilmember Koretz stated his support of the Item, and stated he thinks the upcoming election will be a record low turn out. He focused on Polling Locations and complimented the City Clerk's staff with the Election package.

Mayor Pro Tem Martin thanked the City Clerk's staff for the election. He stated support for numbered seats in lieu of "at large."

**ACTION:** (1) Direct the City Clerk to create a City Election Task Force to evaluate the election process as it relates to: campaign finance reform, increased voter participation and education, and election administration; and (2) Direct the Task Force to submit its recommendations to the City Manager prior to December 31, 1997.

**Motion Mayor Pro Tem Martin, seconded by Councilmember Heilman and unanimously carried.**

**B. CITY MANAGER RECRUITMENT:**

Councilmember Heilman provided background information as outlined in the staff report dated April 7, 1997.

JOHN ALTSCHUL, WEST HOLLYWOOD, stated that he was sorry that the City Council was not going to vote on this item this evening. He stated his support of a nationwide search.

JOHN DURAN, WEST HOLLYWOOD, stated it is the City Council's fiduciary duty to have a nationwide search. Stated his support of a nationwide search.

HOWARD ARMISTEAD, WEST HOLLYWOOD, stated his support to conduct a nationwide search. Stated we have outstanding candidates locally.

**ACTION:** By consensus the City Council table this Item to May 5, 1997.

**C. AIDS TRENDS AND PROGRAMMING:**

Councilmember Heilman and Tom West, Lead Program Specialist, provided background information as outlined in the staff report dated April 7, 1997.

SUE CRUMPTON, spoke in support of Item. She stated quotes of recent study of perceptions and attitudes. Briefed the Council of the LIFE Project.

JOHN DURAN, WEST HOLLYWOOD, stated Chris Brown Hospice closed down, APLA had layoffs. Stated his support for this item, as we have to start at ground zero to re-allocate and re-direct City funds. He requested the Council not to look at the Agencies for direction.

HOWARD ARMISTEAD, WEST HOLLYWOOD, stated this is a whole new day for the 10% of the people who can afford the drugs. Briefed the City Council on how Aspirin affects HIV.

MICHAEL MALLORY, WEST HOLLYWOOD, stated his support of this item. He stated he will now be able to live with HIV.

**ACTION:** (1) Direct staff to develop a series of programs and services that support the developing needs of persons living with HIV/AIDS who are benefiting from new medical treatments; and (2) Direct staff to develop programming to respond to persons living with HIV/AIDS who are not benefiting from new medical treatments.

**Motion Mayor Guarriello, seconded by Councilmember Prang and unanimously carried.**

**D. PROPOSED RESOLUTION REGULATING CABLE TELEVISION RATES FOR EQUIPMENT AND INSTALLATION PROVIDED BY CENTURY SOUTHWEST CABLE TELEVISION:**

Helen Goss, Public Information Officer/CATV Manager provided background information as outlined in the staff report dated April 7, 1997.

Mayor Guarriello asked that Century Cable be required in the future to have a performance bond.

Ms. Goss asked Century Cable to delay the rate increase until the dispute was resolved, but the Legal Council of Century Cable was unwilling to delay the rate increase.

**ACTION:** (1) Adopt Resolution No. 97-1724, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD REGULATING CABLE TELEVISION RATES FOR EQUIPMENT AND INSTALLATION PROVIDED BY CENTURY SOUTHWEST CABLE TELEVISION."

**Motion Councilmember Heilman, seconded by Mayor Guarriello and unanimously carried.**

**E. DESIGNATION OF VOTING ALTERNATE FOR THE LOS ANGELES COUNTY CITY SELECTION COMMITTEE:**

Mayor Guarriello appointed Councilmember Prang as the standing Alternate for the City Selection Committee to represent West Hollywood in the event the Mayor cannot attend.

**ACTION:** By Consensus the City Council directed the voting delegate to nominate and vote for Robert Pinsler from Redondo Beach, at the meeting of April 10, 1997.

**2.T PROPOSED RESOLUTION OF SUPPORT OF AB 101 THE DIGNITY FOR ALL STUDENTS ACT:**

Councilmember Prang stress the importance of this legislation and the City's support of the legislation.

**ACTION:** (1) Adopt Resolution No. 97-1720, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD IN SUPPORT OF ASSEMBLY BILL 101 (KUEHL) THE DIGNITY FOR ALL STUDENTS ACT;" and (2) Authorize staff to distribute copies of this Resolution to Members of the State Senate, State Assembly, and other civic and governmental organizations as appropriate.

**6. LEGISLATIVE:**

**A. BAN ON SALE OF AMMUNITION MAGAZINES:**

Councilmember Koretz provided background information as outlined in the staff report dated April 7, 1997.

Mayor Pro Tem Martin expressed his concern over the legal costs and asked that the Council consider asking the State to adopt this type of legislation.

Councilmember Prang stated that Senator Hayden urged Cities to adopt this type of legislation. He asked for clarification regarding potential litigation.

Councilmember Heilman also asked that we direct the City Attorney to report if this type of Ordinance would raise the same legal controversy as the Ban on Saturday Night Specials. He suggested we solicit a number of cities to adopt the same ordinance and the same time.

**ACTION:** Direct the City Attorney to draft an amendment to the West Hollywood Municipal Code to forbid the sale of multiple round ammunition clips in West Hollywood. Report on legal issues associated with this ordinance, direct staff to enlist support of other Cities by adopting the same type of ordinance at the same time.

**Motion Councilmember Heilman, seconded by Councilmember Koretz and unanimously carried.**

**COUNCILMEMBER COMMENTS:**

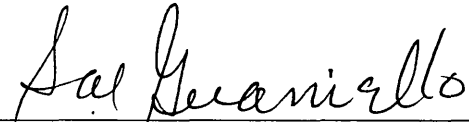
Councilmember Koretz reminded people to vote.

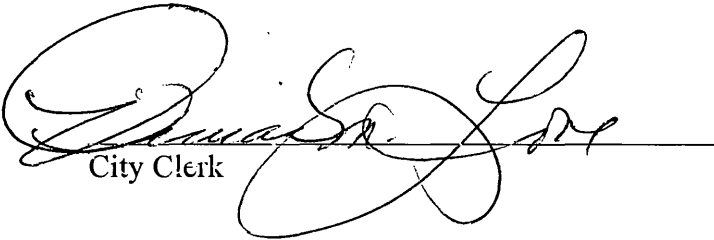
Councilmember Prang thanked City staff for their help and guidance for his first few weeks in office.
