3.C. RESOLUTION AUTHORIZING THE USE OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS TO ACQUIRE LAND LOCATED AT 7530 SANTA MONICA BOULEVARD: [A. WINDERMAN/J. SKORNECK/R. BURNLEY] The City Council will solicit comments on a resolution authorizing the use of Community Development Block Grant (CDBG) funds to acquire land located at 7530 Santa Monica Boulevard in order to facilitate the development of an affordable housing project. Following the public hearing, the City Council will consider adopting the proposed resolution.

Mayor Duran stated that the Item was noticed as required by law.

Roderick Burnley, Project Development Administrator, provided background information as outlined in the staff report dated December 3, 2007.

Mayor Duran opened the public hearing and the following speakers came forward:

ACTION: Adopt Resolution No. 07-3624, "A RESOULTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, AUTHORIZING THE USE OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO ACQUIRE LAND LOCATED AT 7530 SANTA MONICA BOULEVARD TO FACILITATE THE DEVELOPMENT OF AN AFFORDABLE HOUSING PROJECT." **Motion by Councilmember Guarriello, Seconded by Councilmember Land and approved.**

3.D. REQUEST TO DEMOLISH ALL BUILDINGS ON SITE, AND CONSTRUCT A NEW 80,730 SQUARE FOOT FIVE-STORY MIXED-USE PROJECT OVER TWO LEVELS OF SUBTERRANEAN PARKING AT 9001 SANTA MONICA BOULEVARD: [S. HEALY KEENE/ J. KEHO/ J. NOEL] The applicant is requesting to enter into a Development Agreement with the City of West Hollywood to allow for additional height and density on the site, and for altered private open space requirements. The applicant is requesting to demolish all buildings on the site and construct a new mixed use project. The proposed building consists of 9,800 square feet of ground floor restaurant, 9,850 square feet of ground floor retail use and four stories of residential above. The residential portion of the development is proposed to contain thirty-four (34) market rate condominium units and eight (8) affordable condominium units.

Mayor Duran stated that the Item was noticed as required by law.

He spoke in support of the preservation of the Palm restaurant in the project. He spoke in support of the removal of the car repair business currently located at the site. He spoke in support of the Development Agreement. He expressed concerns regarding the traffic study in the project. He expressed concerns regarding the height of the project. He spoke in support of dedicating the City's income from the project to improvements in the surrounding area. He spoke regarding parking concerns surrounding the stacked parking. He spoke regarding public comment surrounding the previously proposed Mixed-use Ordinance in the City and the decision to allow mixed-use projects that were already in development.

Mayor Pro Tempore Prang thanked staff, the consultants, the residents and the applicants for their input on the project. He spoke in support of the design. He spoke in support of preserving the Palm restaurant in the project. He spoke in opposition to the height of the project. He spoke in opposition to the Development Agreement and the proposed General Plan Amendments and the potential impacts on surrounding properties in the area. He expressed concerns regarding the valet parking and the compact parking spaces in the project. He expressed concerns surrounding environmental impacts in the neighborhood, and concerns surrounding the Environmental Impact Report in the project.

Councilmember Guarriello spoke in support of the project. He spoke in support of the proposed height of the project. He spoke in support of creating new housing on Santa Monica Boulevard.

Councilmember Land thanked staff, residents, consultants, and the applicants for their input on the project. She spoke in support of the design. She spoke in support of preserving the Palm restaurant in the project. She spoke in support of creating new

housing on Santa Monica Boulevard. She spoke in support of lowering the height of the project. She spoke in support of using the City's income from the project for improvements in the surrounding area. She spoke regarding concerns surrounding repairs of the mechanical parking lifts and the need to ensure that they are repaired in a timely manner. She expressed concerns regarding ensuring the development of the second phase of the project and protecting the affordable housing units in the project. She spoke regarding the public process and public participation during the approval process.

Mayor Duran spoke regarding the recent West Hollywood Community Survey and the identification of affordable housing and traffic and parking as the primary concerns of residents. He spoke in support of the project creating new housing units on Santa Monica Boulevard, and clarified that the proposed project would not destroy any existing units. He spoke in support of Alternative 3 in the proposed General Plan Amendment, which impacts the least amount of other properties in the City. He spoke in support of the size of the project in this particular area of Santa Monica Boulevard. He spoke in support of the proposed height in the project. He spoke regarding errors in the traffic study and clarified that they are typographical and not substantive. He spoke in support of using only a portion of the City's income from the project for improvements in the surrounding area.

Mayor Duran re-opened the public hearing for discussion with the architect regarding impacts from lowering the height of the project.

Mayor Duran re-closed the public hearing.

ACTION: 1) Introduce for first reading Ordinance No. 07-780, "AN ORDINANCE CITY OF WEST HOLLYWOOD ADOPTING A NEGATIVE DECLARATION, APPROVING GENERAL PLAN AMENDMENT 2006-004. ZONING TEXT AMENDMENT 2006-003. AND ZONING MAP AMENDMENT 2007-003"; with the following amendment (staff Alternative 2) to the General Plan Amendment which reads as follows: "Policy 1.19.23 - With the adoption of a Development Agreement, permit an increase in floor area ratio not to exceed a total building FAR of 3.0 and permit an increase in building height not to exceed total building height of 65 feet in the Community Commercial Zoning District for properties located on Santa Monica Boulevard and west of La Cienega Boulevard and which are separated from any adjacent residentially zoned property by an alley or other public right-of-way." And with the following amendment to the Zoning Text Amendment which reads as follows: "Section 19.10.050.E - CC District - Santa Monica Boulevard Development Agreements. With the adoption of a Development Agreement, on parcels that are separated from any adjacent residentially zoned property by an alley or other public right-of-way and which are located west of La Cienega Boulevard permit an increase in floor area not to exceed a total building FAR of 3.0 and permit an increase in building height not to exceed a total building height of 65 feet. 2) Adopt Resolution No. 07-3625, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD CONDITIONALLY APPROVING DEMOLITION PERMIT 2006-011, DEVELOPMENT PERMIT 2006-015, MINOR CONDITIONAL USE PERMIT 2006-004, AND ADMINISTRATIVE

PERMIT 2006-021; subject to the following changes and new conditions a.) reduction in height of the project to an average building height of 62 feet; b) provide disclosure to all prospective purchasers and tenants of the building that they would be living on a busy street; c) direct staff to add a condition requiring the mechanical parking lifts be routinely maintained; d) provide dedicated self-park parking spaces and free valet service to the occupants of all affordable housing units. 3) Adopt Resolution No. 07-3626, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING TENTATIVE TRACT MAP 2006-008 FOR THE DEVELOPMENT OF FORTY-TWO (42) CONDOMINIUM UNITS AT 9001 SANTA MONICA BOULEVARD, WEST HOLLYWOOD, CALIFORNIA." 4) Direct staff to place the \$700,000.00 extraordinary benefits fee funds received from the project into a West Side Improvement Fund to be later appropriated by City Council for neighborhood improvements.

Motion by Councilmember Heilman, Seconded by Councilmember Guarriello and passed with Mayor Pro Tempore Prang voting no.
