CITY COUNCIL MEETING  
November 7, 1994  
WEST HOLLYWOOD PARK  
647 N. SAN VICENTE BOULEVARD**

**CALL TO ORDER:** Mayor Land called the meeting to order at 7:07 p.m.

**PLEDGE OF ALLEGIANCE:** The Pledge was led by Mickey Jackson.

**APPROVAL OF AGENDA:** Mayor Land asked that Item 4.A. be moved to the Consent Calendar as Item 2.C.C.; Councilmember Guarriello pulled Item 2.S. and noted his 'no' vote on Item 2.T.

Motion to approve as amended, Guarriello, seconded Heilman and unanimously carried.

**PRESENTATIONS:**

Mayor Land proclaimed November 8, 1994, as Morris Kight day in the City of West Hollywood in recognition of his work as a community organizer, pacifist and lesbian/gay liberationist.

Councilmember Martin presented a commendation to Zohar Wertheim of the Framing Gallery, Cher and Huanan Wang of Wok Deli, Patrick Rous of Cafe D'Etoile and Michael and Rita Davidson of Tbilisi and Yerevan Bakery.

**1. CITIZEN COMMENTS:**

**A. CITIZEN COMMENTS ON CONSENT CALENDAR ITEMS WHICH HAVE NOT BEEN PULLED:**

RAY RILEY, WEST HOLLYWOOD, representing General Employees spoke regarding Item 2.Y. and thanked Assistant City Manager Makinney for all his work during negotiations.

WALT HANNA, WEST HOLLYWOOD, thanked the Council for their help with the contract dispute with Aid for Aids.

**B. CITIZEN COMMENTS - GENERAL:**

RANDY MOSES, WEST HOLLYWOOD, commented about not getting his calls returned.

RUTH WILLIAMS, WEST HOLLYWOOD, spoke against Prop 187.

GERDA SPIEGLER, WEST HOLLYWOOD, spoke against Prop 187.

DONNY CACY, WEST HOLLYWOOD, urged people to vote yes on Prop 188.

JULIE SUMMERS, WEST HOLLYWOOD, thanked the Council for their stand on Prop 186 and urged voters to vote yes.

HALEY POWERS, W. H. CONVENTION & VISITORS BUREAU, reported that her recent visit to New York was very profitable and mentioned a few of the upcoming trips on behalf of various hotels in West Hollywood.

SIBYL ZADEN, WEST HOLLYWOOD, spoke on Item 2.N. which is the holiday lighting and she stated her support for Item 5.B, Holiday Parking Pilot Program.

MARK MARKLINE, WEST HOLLYWOOD, spoke on behalf of the Chamber and stated their support on the holiday parking item and the Avenues of Design, Item 2.S. He asked that Council support this item.

CHRISTOPHER PATROUCH, WEST HOLLYWOOD, spoke against the proposed parking structure.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in response to a comment which Donny Cacy made.

IVY BOTTINI, WEST HOLLYWOOD, thanked the City Council for recognizing Morris Kight. She also supported the pilot parking program during the holidays.

PHILLIP PARKS, WEST HOLLYWOOD, thanked the Council for considering the Holiday Parking Pilot program.

**CITY MANAGER'S REPORT:**

City Manager Brotzman reported that revenue from restaurants is the highest ever. He stated there is no indication that the smoking ordinance has had any impact at all.

He responded to comments about the parking structure at Kings Road which is currently going through an environmental impact report. He stated that the funds for the parking structure would come from the parking trust fund and although there is no reason to believe the project will cost more, if it did the monies would be taken from this trust fund and not impact the general fund.

**COUNCILMEMBER COMMENTS:**

Councilmember Guarriello announced a meeting of the Public Safety Commission on November 13th at 6:30 p.m. A proposed site for the new fire station will be discussed.

Councilmember Martin thanked Julie Summers for reiterating the Council's position in favor of Proposition 186 and thanked Ruth Williams and Gerda Spiegler for emphasizing the City's

opposition to Proposition 187. He also announced that the giant thank you card was presented to Senator Feinstein in recognition of her support for the Federal Crime legislation.

Mayor Pro Tem Heilman commended City Staff and the Committee Members who worked on the Halloween Event.

Mayor Land commended the Parks and Recreation staff on the event at Plummer Park.

**4. UNFINISHED BUSINESS:**

**A. 1994-95 SOCIAL SERVICES FUNDING - AID FOR AIDS:**

This item was placed on the Consent Calendar. See Item 2.C.C.

**B. AWARD OF CONTRACT TO GRUEN ASSOCIATES FOR PROFESSIONAL SERVICES RELATED TO THE ENVIRONMENTAL IMPACT REPORT OF THE SUNSET SPECIFIC PLAN:**

Gay Forbes, Director of Community Development provided background information as outlined in the staff report dated November 7, 1994.

**RECOMMENDATION:** Authorize the City Manager to execute an agreement, not to exceed \$21,000, between the City of West Hollywood and Gruen Associates for services necessary to prepare responses to comments and to compile the final volume of the Environmental Impact Report.

Motion Heilman, seconded Martin and unanimously carried.

**C. CAREER CRIMINAL APPREHENSION PROGRAM FUNDING:**

Mayor Land provided background information as outlined in the staff report dated November 7, 1994.

**RECOMMENDATION:** 1) Accept awarding of \$336,000 from the State Office of Criminal Justice over a three year period. 2) Amend the 1994-95 budget to include grant revenues of \$108,000 and expenditures of \$108,000.

Motion Heilman, seconded Guarriello and unanimously carried.

**5. NEW BUSINESS:**

**A. NONVIOLENT CITY PROGRAM:**

Mayor Land provided background information as outlined in the staff report dated November 7, 1994.

Mayor Pro Tem Heilman asked if they could look into creating a policy that whenever there is a domestic violence call there is an mandatory arrest.

Mayor Land stated they would be discussing that also.



Councilmember Martin stated he would hope they would work with the Russian Community.

KIM SCHNEIDER, WEST HOLLYWOOD, spoke regarding domestic violence.

RECOMMENDATION: 1) Direct staff to work with the Mayor's office and the Women's Advisory Council on the WAC's Nonviolence Program. 2) Direct the WAC to present a report on its nonviolence initiatives to the Council at a regularly scheduled meeting in February of 1995.

Motion Heilman, seconded Martin and unanimously carried.

**B. FREE HOLIDAY PARKING PILOT PROGRAM:**

Mayor Land provided background information as outlined in the staff report dated November 7, 1994.

RECOMMENDATION: 1) Direct staff to complete research on and to initiate a four-day free parking pilot program in the city to encompass the following dates: December 23, 24, 25, 26. 2) Direct the Public Information staff to work with business organizations, such as the Santa Monica Boulevard Association, the Avenues of Design and the general public about the program.

Motion Heilman, seconded Guarriello and unanimously carried.

**EXCLUDED CONSENT CALENDAR:**

**2.S. AMENDMENT OF PROFESSIONAL SERVICES CONTRACT WITH MARCO LIMANDRI TO PROVIDE BUSINESS DEVELOPMENT SERVICES TO THE AVENUES OF DESIGN BUSINESS ASSOCIATION:**

Gay Forbes, Community Development Director provided background information as outlined in the staff report dated November 7, 1994.

Motion to approve the contract in an amount not to exceed \$5,000 and authorize the City Manager to sign with the understanding that if the BID is formed this amount will be charged to the BID; direct staff to talk to Chamber to get a clearer understanding of what they were doing with previous monies allocated; ask Mr. Limandri to identify leadership; complete signature gathering by January 15 and completion by January 30, 1995.

Motion Heilman, seconded Martin and unanimously carried.

**6. LEGISLATIVE:**

**A. GENERAL MUNICIPAL ELECTIONS - CONSIDERATION OF ALTERNATIVE DATES:**

Vivian Love, City Clerk, provided background information as provided in the staff report dated November 7, 1994.

RECOMMENDATION: 1) Introduce Ordinance No. 94-424, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA MOVING THE DATE OF ITS GENERAL MUNICIPAL ELECTION FROM THE SECOND TUESDAY IN APRIL OF EVEN NUMBERED YEARS TO THE FIRST TUESDAY AFTER THE FIRST MONDAY OF MARCH OF ODD-NUMBERED YEARS PURSUANT TO ELECTIONS CODE SECTION 2601(b)." 2) Approve supplemental budget appropriation of \$6,500 from the general fund; 3) direct staff to draft a resolution to go to Secretary of State and Board of Supervisors to actively pursue local elections being consolidated with general elections and Presidential Primary elections in L.A. County.

Motion Heilman, seconded Martin and unanimously carried.

**COUNCILMEMBER COMMENTS:**

Mayor Land urged people to go out and vote as election turnout is crucial.

**RECESS TO CLOSED SESSION:**

City Attorney Jenkins asked for a 4/5 vote to add two items to the closed session agenda: 1) Under existing litigation, Community Taxi v. City of West Hollywood; and 2) An item of threatened litigation to be included under anticipated litigation.

Motion Land, seconded Guarriello and unanimously carried.

The City Council recessed to the closed session at 8:20 p.m.

**RECONVENE:** The Council reconvened at 8:40 p.m.
