# MINUTES CITY OF WEST HOLLYWOOD CITY COUNCIL REORGANIZATION TUESDAY, APRIL 19, 1994

CALL TO ORDER: Mayor Guarriello called the meeting to order at 7:20 p.m.

PLEDGE OF ALLEGIANCE: The Pledge was led by Morris Kite.

1. CANVASS OF THE GENERAL MUNICIPAL ELECTION HELD APRIL 12, 1994: ACTION: Adopt Resolution No. 94-1294, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 1994, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW."

Motion Guarriello, seconded Heilman and carried unanimously.

- Outgoing Councilmember Babette Lang commented on the dedication and achievements of the current City Council and the preceding City Councilmembers. She expressed appreciation for the support given by businesses, residents, the other Councilmembers, the City Manager, City Attorney, staff, and her Deputy, Dottie Gibbons-White.
- 3. ADMINISTRATION OF OATH OF OFFICE TO NEWLY-ELECTED COUNCILMEMBERS:

Los Angeles Municipal Court Judge Stephanie Sautner administered the oath of office to the three Councilmembers who were elected on April 12, 1994: Steve Martin, John Heilman, and Sal Guarriello.

4. ELECTION OF MAYOR:
Mayor Guarriello called for nominations for Mayor.

Councilmember Martin nominated Mayor Pro Tem Abbe Land. There being no other nominations, nominations were closed.

ACTION: Elect Mayor Pro Tem Land as Mayor. Motion Martin seconded by Heilman and unanimously carried.

## 5. ELECTION OF MAYOR PRO TEMPORE:

Mayor Land called for nominations for Mayor Pro Tempore.

Councilmember Guarriello nominated Councilmember John Heilman. There being no other nominations, nominations were closed.

ACTION: Elect Councilmember Heilman as Mayor Pro Tempore. Motion Guarriello, seconded by Martin and unanimously carried.

#### 6. PRESENTATIONS:

Mayor Land presented a plaque to outgoing Mayor Sal Guarriello, and flowers to Mrs. Rita Guarriello.

Councilmember Guarriello commented on accomplishments during his past four years as Councilmember.

Councilmember Martin gave comments on the election and thanked the community, his campaign manager, his treasurer, and his partner, John Mulcrone.

Mayor Pro Tem Heilman thanked everyone who had worked on his campaign and the people in the community. He thanked Babette Lang for her four years of service on the Council and her many years of service to the community.

Councilmember Koretz expressed appreciation for working with Babette Lang the last four years and thanked Councilmember Guarriello for his service as Mayor.

Councilmember Guarriello thanked Babette Lang for her help during the past year.

Mayor Land expressed her appreciation for working with Babette Lang and commented on the challenges facing Council in the coming year.

# 7. APPOINTMENT OF SANITATION DISTRICT ALTERNATE:

Mayor Land explained that the new mayor automatically becomes a Sanitation District Director; however, the Council must appoint an Alternate.

Councilmember Koretz nominated Councilmember Guarriello.

ACTION: Appoint Councilmember Guarriello as Alternate Member of the Board of Directors of Sanitation District 4, and adopt Resolution No. 94-1295, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPOINTING AN ALTERNATE MEMBER OF THE BOARD OF DIRECTORS OF LOS ANGELES COUNTY SANITATION DISTRICT NO. 4."

Motion Koretz, seconded Heilman and unanimously carried.

# 8. CITIZEN COMMENTS:

JEANNE DOBRIN, WEST HOLLYWOOD, indicated she was happy with the new City Council, and commented that the top four candidates for Council supported retention of the Sheriff's Department. She gave comments on the Brown Act.

WENDY KRUEGER, WEST HOLLYWOOD, presented flowers to Mayor Land on behalf of the Women's Advisory Council.

Mayor Land acknowledged the Council candidates who were present and thanked them for a clean campaign.

The meeting was adjourned at 7:50 p.m. to the next regular meeting, Monday, May 2, 1994, at West Hollywood Park, for a closed session at 6:00 p.m. and a regular meeting at 7:00 p.m.
