CALL TO ORDER:

REPORT OF CLOSED SESSION: City Attorney Jenkins reported that the City Council had called the meeting to order at 6:30 p.m. and adjourned into closed session for the purpose of discussing several claims against the city. The City Council approved the claims of Agami and Dewitt and on September 7th approved the claim of Gina Chioccariello. They declined the claims of Breckenridge and Bowden and discussed Dromy vs City of West Hollywood and gave direction relative to labor relations negotiation. The Closed Session adjourned at approximately 7:00 p.m.

REPORT ON DOLLAR AMOUNTS ON CONSENT CALENDAR: City Clerk Love reported that the total fiscal impact of the items on the Consent Calendar is \$20,892.29 in revenue and \$131,277.15 in expenditures. All items were budgeted with the exception of item 2.J. which resulted in \$11,631.59 of potential new revenues and item 2.T. which resulted in a \$10,500.00 expenditure.

APPROVAL OF AGENDA: ACTION: Approve agenda as presented. Motion Land, second Heilman and unanimously carried.

PROCLAMATIONS AND COMMENDATIONS:

Councilmember Lang had five commendations for the Holiday Design Contest Jury. The commendations were for Lynn Strickman, Clay Doyle, Donna Ravitz, Jim Rogers and Sharon Schiffman. She indicated that the commendations will be mailed to the individuals.

CITY MANAGER'S REPORT: This time has been set aside for the City Manager to update the Council on important items initiated by staff or previously requested by the City Council.

Assistant City Manager Edgerly reported that Paul Brotzman is out of town until Thursday at the International City Manager's Meeting and Joan English is also out of town at a Public Works Conference.

1. CITIZEN COMMENTS: This time has been set aside for members of the public to address the City Council on Consent Calendar items, other agenda items if the member of the public cannot be present later in the meeting at the time the item is heard by the Council, and items of general interest. Although the City Council values your comments pursuant to the Brown Act they cannot respond nor take any action on items not listed on the posted agenda. This period shall be limited to 20 minutes, with no more than two minutes for each speaker. Testimony for public hearings will only be taken at the time of the hearing.

The following persons addressed the City Council:

JOSEPH GLADSTONE, NEIGHBORHOOD WATCH EAST WEST HOLLYWOOD ASSOCIATION, stated he felt more effort needs to be taken to reduce the crime problems. Suggested alternate City Council meetings at Plummer Park. Commented on Business Improvement District and feels it is more a tax than an assessment. He requested the City Council to make sure citizens have time to comment on the Oki Dog which is going in.

KATHY GLADSTONE, WEST HOLLYWOOD, said the incidence of crime has gone up. Requested additional lighting and more patrols.

IAN ABERCROMBIE, WEST HOLLYWOOD, stated his concern about residents getting along with each other.

CRAIG RITCHIE, WEST HOLLYWOOD, stated ACES will be a permanent voice for residents and will be involved with business retention, increased bike and foot patrols and other neighborhood problems.

DONNY CACY, BUSINESS OWNER - WEST HOLLYWOOD, presented Council with petitions about the ficus trees in the downtown area.

WILLIAM SENIGRAM, WEST HOLLYWOOD, talked about the problems on the east side. He stated he will continue to attend the meetings.

MIKE RADCLIFFE, LOS ANGELES, discussed credibility. He

stated that the studio district on the east end did not have anyone involved.

PETER DUDAR, WEST HOLLYWOOD, was opposed to the closing of the libraries and the impact on residents.

NANCY MATOON, LOS ANGELES, LIBRARIAN, thanked the City for all their support of the Shipton Center. Supports the adding of circulation hours and requested assistance with County regarding her not being allowed to work on City funded days.

Councilmember Koretz suggested directing staff to work with the County to remedy this situation.

SALLY MARR, WEST HOLLYWOOD, stated her disapproval of cutting library hours and suggested Council, Commissions and staff take a 5% cut in salary to keep the doors of the library open.

STAN LOTHRIDGE, WEST HOLLYWOOD, talked about condo project which Council approved several years ago. He indicated it was a health hazard, weeds, rats trash, etc. Mosquito abatement had to be called.

SANDY SHIRE, WEST HOLLYWOOD BUSINESS OWNER, was forced to close his doors last winter. Felt that BID is unreasonable. Requested that Council abort the plan.

ROSEMARY SCHUBERT, WEST HOLLYWOOD, stated she does not see as many Sheriff's deputies as she had in the past. Asked to have streets made safe again and have the east side as well taken care of as the West side.

BOB GREENE, WEST HOLLYWOOD, was opposed to the assessment program that the Chamber and the City are trying to implement. Feels this is not going to help businesses.

BABETTA LANZILLI, BUSINESS OWNER WEST HOLLYWOOD, was opposed to the Business Improvement District.

CRAIG REUSS, WEST HOLLYWOOD, was concerned about what is happening on the east side. There is a meeting set up with the owners of the proposed Fat Burger and thanked Mayor Pro Tem Land. Requested that the City Council listen to the people and not just to staff.

# 3. PUBLIC HEARINGS:

A. AMENDMENTS TO THE ANIMAL ORDINANCE REGARDING DOG AND CAT LICENSING AND DOG AND CAT BREEDING, AND ADOPTION BY REFERENCE OF TITLE 10, ANIMALS, OF THE L.A. COUNTY CODE:

Leah Archibald provided background information as outlined in the staff report dated September 20, 1993.

Ms. Archibald suggested Council provide some direction as to the 50% discount for low-income and disabled residents.

Mayor Guarriello requested a noticing report.

City Clerk Love stated that the notice of public hearing was published in the West Hollywood Independent on September 8, 1993 and was posted in the required locations.

Mayor Guarriello opened the public hearing and the following persons addressed the Council:

SONNDRA MAY, WEST HOLLYWOOD, was in support of ordinance.

PATRICIA TITO, WEST HOLLYWOOD, in support of ordinance.

JAMIE PINN, was in support of ordinance. Stated dog licensing should not carry the full responsibility of animal control services.

CAROLE ELLIS, CHAIR OF ANIMAL WELFARE TASK FORCE, in support of ordinance. Have been working on this ordinance for a year and 1/2.

GAIL CHRISTIANSEN, WEST HOLLYWOOD, has done public relations for animal shelters. One enforcement of a so-called unenforceable law does educate people. Supports ordinance.

DORIS ROMEO, WEST HOLLYWOOD ANIMAL WELFARE TASK FORCE, spends a great deal of time trying to educate the public and is in support of the ordinance.

NORMA SANDLER, TASK FORCE AND WILDLIFE PROTECTION LEAGUE, was in support of the ordinance. Issue which has not been addressed is the disappearance of song birds due to hungry animals.

KAREN CAESAR, WEST HOLLYWOOD, expressed enthusiastic support of the ordinance.

CHRISTINA BABST, MEMBER OF TASK FORCE, urged the support of the ordinance.

MIKE RADCLIFFE, LOS ANGELES, strongly disagrees with this issue. Inquired how the City intends to enforce this law.

ROSLYN KRAUSE, WEST HOLLYWOOD, indicated that a member of the task force went onto private property and stole her cat.

STAN LOTHRIDGE, WEST HOLLYWOOD, stated that this ordinance will cost everyone and most of the money will go to the County. Opposes this ordinance.

AL WEISSMAN, WEST HOLLYWOOD, opposes the ordinance because feels it is a ploy to get money for the City.

BOB BALLENGER, L.A. COUNTY ANIMAL CONTROL, praised the Task Force. Stated that the County will enforce the ordinance. He indicated that if the Council's desire is to license more animals then the ordinance will be effective. However, if the goal is to raise revenues to subsidize the program he feels it will not since the section of the ordinance which allows a discount will cost the City.

MARJORIE LESERMAN, strongly supports the ordinance. Supports the task force and the work that they do.

Mayor Guarriello closed the public hearing.

Councilmember Koretz stated that the present method of animal control is ridiculous. As far as the licensing of cats it will be the way of the future. L.A. County is currently doing this. Cat licensing is the only way to encourage spaying and neutering. He felt that this also provides a type of tracking system for these animals. He stated that it works largely on the honor system similar to the dog licensing. One thing which wasn't included in the ordinance was the incentive for spaying and neutering.

Councilmember Lang stated that she does not see this ordinance as enforceable. She has a long list of cities in which this type of ordinance does not work. She stated she felt this ordinance was invasive. If there is some type of educational program she is in favor of the spaying and neutering program. Stated she is a little cynical of the honor system. Not in favor.

Mayor Pro Tem Land stated that she is not a pet owner and feels that people who own pets have a great deal of love for their animals. Does not really see the reason why cats should be treated differently than dogs. Stated she imagines we will have just as much difficulty in enforcing cat licenses as we do in enforcing dog licenses. She said she would like to see

a review in six months and see how it is working. She asked if there could be a stud instead of a collar. She also felt a fee honor system would work. She asked about breeders and how to implement the test and suggested looking at different ways to implement it.

Councilmember Heilman stated that the task force has done a very good job in explaining why this is necessary. Feels it is important that the task force stays together to help with the education portion of this. In response to the issue of the altered pet permit, he suggested changing the fee differential between the altered and the non-altered. Will need to look at this in a year.

Mayor Guarriello stated he concurred with Councilmember Lang and felt the review in six months will never happen.

Councilmember Koretz stated that it is working in some cities such as San Mateo. Would encourage the Council to support the ordinance as recommended and feels it would be effective,

ACTION: Introduce for first reading Ordinance No. 383, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD ADOPTING BY REFERENCE TITLE 10, ANIMALS, OF THE LOS ANGELES COUNTY CODE AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion by Koretz, seconded by Land and carried on a roll call vote:

NOES: Lang, Guarriello

**COUNCILMEMBER COMMENTS:** This portion of the meeting shall be set aside for general comments, announcements, requests of staff, and/or other issues of concern from members of the City Council.

Mayor Guarriello indicated that a resolution which was presented in July supporting the death penalty for drive by shootings was not supported by Council but has been passed by the Senate.

Mayor Pro Tem Land stated that she recently received a copy of an article regarding cable rates. The FCC has threatened to impose a mandatory 10% reduction across the board at their next hearing in October. The City will be holding public hearings in October to receive comments on the cable franchise.

Councilmember Lang stated that she wanted to make a comment regarding the Alliance for Citizens on the East Side. She commended Ruth and stated she is willing to work with this organization. She also indicated that as far as the Sheriff's is concerned, there was a comment that there are less cars on the street, and it is simply not true. Although there was a budget cut, it did not affect the number of deputies on the street.

Mayor Guarriello requested staff look into the Westmount property mentioned earlier tonight.

Councilmember Heilman stated that the property owner keeps indicating that the property is for sale. Staff has been directed to criminally prosecute.

Councilmember Heilman stated that William Scott Field has been appointed to the Cultural Heritage Advisory Board. He extended his congratulations and welcomed him to the Board.

He indicated that he concurred with Councilmember Lang regarding the new group on the east side and is looking forward to working with them.

Mayor Pro Tem Land concurred with fellow Councilmembers relative to the group on the east side. In addition, she wanted to report that Councilmember Heilman was invited to the White House for a special briefing relative to health insurance.

Councilmember Koretz announced a meeting in the Community Conference Room at City Hall for the "No on 174" committee. Everyone is welcome. Stated he is excited about the formation of the new east side group. Lastly, he commented on the death penalty and indicated that he felt it is not the answer as crime is up.

The City Council wished Mayor Pro Tem Land a happy birthday.

The City Council recessed at 8:40 p.m. Reconvened at 9:00 p.m.

Mayor Pro Tem Land provided background information as outlined in the staff report dated September 20, 1993.

Councilmember Lang commended Mayor Pro Tem Land on her efforts.

DONNY CACY, BUSINESS OWNER, supported this program.

ACTION: 1) Direct staff to carry out the educational and public outreach initiatives; 2) direct staff to draft changes to the current Graffiti Prevention and Removal ordinance and to work with the City Attorney's office to produce the final document; and 3) approve the City's involvement in the Los Angeles/West Hollywood Beautiful Clean Sweep. Motion Lang, seconded Koretz and unanimously carried.

Mayor Pro Tem Land encouraged anyone who wanted additional information to contact her office.

# B. CONTRACT FOR CHILD DEVELOPMENT AND CHILD CARE SERVICES

#### AT PLUMMER PARK:

Staff provided background information as outlined in the staff report and supplemental information dated September 20, 1993.

Councilmember Heilman stated that this problem arose at the last minute and he complemented staff.

ACTION: Direct staff to negotiate a contract for Council approval with Child and Family Services to offer pre-school services.

Motion Koretz, seconded by Guarriello and unanimously carried.

# C. RESOLUTION IN SUPPORT OF SB 1128, LIMIT ROUNDS IN AMMUNITION CLIPS:

Councilmember Koretz provided background information as outlined in the staff report dated September 20, 1993.

Councilmember Lang felt it is a poor substitute for qun control but is in favor of the resolution.

ACTION: Adopt Resolution No. 1200, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD IN SUPPORT OF SB 1128, A BILL TO LIMIT THE NUMBER OF ROUNDS IN AMMUNITION CLIPS." Motion Land, seconded by Guarriello and unanimously carried.

#### D. THIS ITEM HAS BEEN PULLED:

**EXCLUDED CONSENT CALENDAR:** Items removed from the Consent Calendar for separate discussion shall be considered at this time.

CITIZEN COMMENTS: This time has been set aside for the public to address the Council on any item of interest that could not be heard under Item 1 at the beginning of the meeting.

CLAIRE BRADLEY, WEST HOLLYWOOD, concerned about the sheriff's patrol, lighting and cleaning up crime in the east end. Suggested Council spend part of their time on the east side.
