# MINUTES CITY COUNCIL MEETING FEBRUARY 1, 1993 WEST HOLLYWOOD PARK 647 N. SAN VICENTE BOULEVARD

**6:00 P.M. - CLOSED SESSION:** This time has been set aside for the City Council to meet in closed session to discuss matters pertaining to litigation (pursuant to Government Code Section 54956.9(a), potential litigation (pursuant to Government Code Section 54956.9(b), and (c)), personnel, and/or claims. The City Attorney gave an additional oral report of the closed session at the commencement of the public portion of the meeting.

## 7:00 P.M. - REGULAR MEETING

CALL TO ORDER: Mayor Lang called the meeting to order at 7:13 p.m.

REPORT OF CLOSED SESSION: City Attorney Jenkins reported that the City Council convened at 6:00 p.m. and adjourned to a closed session during which they discussed several matters of pending litigation: Tohl vs City of West Hollywood, Rein and Lichtenstein vs City of West Hollywood, and Ozeran vs City of West Hollywood; Authorized amicus participation in Freedom Newspapers litigation and the Oden vs. Public Retirement System litigation and discussed matters of negotiations with the City's negotiator and two matters of potential litigation. ACTION: Approve claim of Cornelius Duncan. Motion Heilman second Guarriello. Hearing no objection it was so ordered.

APPROVAL OF AGENDA: Items 6 and 7 are tabled. Correct the resolution in item 2g to read "7:00 p.m. to 7:00 a.m every day". Motion Heilman second Land. Hearing no objection it was so ordered.

Approved as part of the Consent Calendar.

#### PUBLIC HEARINGS

APPEAL OF TRANSPORTATION COMMISSION'S DECISION TO AMEND BIJAN ENTERPRISES INC. (CELEBRITY CAB CO.) TAXICAB OPERATOR'S LICENSE (HEARING ON THE RECORD): The staff report was given by Lucy Dyke and the procedure for this item was reviewed. Burton Cutler, applicant: Requested that he be allowed to submit additional evidence he was not prepared to produce Transportation Commission hearings. the ACTION: Not to admit new information. Doesn't add anything new to the record. Motion Heilman second Land. Hearing no objection it was so ordered. Appellant will have ten minutes:

Burton Cutler: Bijan owns no cabs. All are independent operators that use the trade name. Bijan represented itself as sole owner. In June was owned by Century Transit Inc. Bijan should be investigated. Owner/operators had no contract with Bijan. Not knowing true owners of company endangers the public health and safety. Asked Council and City Attorney to launch an investigation and disallow this company to operate.

Applicant--John Gantus, Glendale: Truly don't know how to respond. No evidence was brought forward; personal vendetta against the company. Mr. Cutler did not oppose them at the hearing before the Transportation Commission.

ACTION: Deny the appeal of the Transportation Commission's decision to amend Bijan Enterprise Inc.'s taxicab operator's license and uphold the findings of Transportation Commission Resolution No. TC 92-011. Motion Heilman second Land.

AYES: Guarriello, Land, Koretz, Heilman, Lang

NOES: None. Motion carried.

- GREENACRE AVENUE PARKING STUDY: RECOMMENDED Approve and adopt the following Summary of Recommendations from the Executive Summary of the Greenacre Avenue Parking Study:
- 1) Do not implement preferential parking within the boundaries of the study area at this time. 2) Reevaluate the conditions on Greenacre Avenue in the future at the direction of the Transportation Commission and/or the City Council following the participation of residents, businesses and staff in the Dispute Resolution Process. Should the City Council decide mediation has proven unsuccessful in addressing resident concerns, the Council may, at their discretion, impose preferential parking on any of the streets in the study area.
- 3) Investigate the feasibility of utilizing vacant residential lots for interim surface parking for residents only to improve

parking conditions on Detroit Street and Formosa Avenue where occupancy levels are highest.

4) Reevaluate the process for establishing preferential parking districts. Establish specific criteria for review of petitions to determine if an initial assessment of parking is warranted. Perform initial assessment only if petition criteria are met. Establish evaluation criteria to determine the scope before performing a full scale parking study of the area.

The Deputy City Clerk reported that this item was noticed in the L. A. Independent Newspaper and posted at Plummer Park, the San Vicente Library, the Sheriff's Station and City Hall.

The staff report was given by by Don Korotsky. At this time preferential parking is not recommended by staff as on-street parking is widely available. Also, a dispute resolution service meeting is scheduled for February 8, 1993.

Mayor Lang opened the public hearing and the following persons came forward to address the Council:

Mary Belle Breitmeir, West Hollywood: supports permit parking and would also like speed bumps.

Max Weitman, West Hollywood: supports permit parking.

David Einsiedler, West Hollywood: supports permit parking.

Mayor Lang closed the public hearing and returned the item to the City Council for discussion.

ACTION: Direction was given to staff to let the mediation process proceed and continue this item to the first meeting in March. Motion Land - approved by consensus of the Council.

APPEAL OF PLANNING COMMISSION DECISION APPROVING DEVELOP-MENT PERMIT 92-02, MINOR CONDITIONAL USE 92-17, PERMIT AND VARIANCE 92-01 ON AN APPLICATION OF TOWER RECORDS FOR THE CONSTRUCTION OF A PARKING STRUCTURE AT 8801 SUNSET BOULEVARD: RECOMMENDED ACTION: Uphold Planning Commission approval of Development Permit 92-02 and adopt Resolution No. RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST APPROVING DEVELOPMENT PERMIT 92-02, MINOR CONDITIONAL USE PERMIT 92-17, VARIANCE 92-01 AND A NEGATIVE DECLARATION MITIGATION MONITORING PLAN ON AN APPLICATION OF TOWER RECORDS FOR THE CONSTRUCTION OF A PARKING STRUCTURE AT 8801 SUNSET BOULEVARD, WEST HOLLYWOOD." The proposed resolution has been revised to include the recommended change outlined on the last page of the staff report (regarding disaster recovery center).

The Deputy City Clerk reported that this item was noticed in the L. A. Independent Newspaper and posted at Plummer Park, the San Vicente Library, the Sheriff's Station and City Hall. The staff was given by report by Jennifer Davis. Mayor Lang opened the public hearing and the following persons came forward to address the Council:

David Jeffries, West Hollywood - Appellant: More crime, more cars, lower property values, greater traffic.

Benjamin Clavan, applicant: Tower has gone through three major plans. Tower is under pressure to maintain their business. This will be a much safer building now, with rolldown gates at night and attendants during the day. The complaints are with development in general.

John Altschul, West Hollywood: support for the project. Gary Pierson, West Hollywood, Book Soup: in favor; recommend Council approve.

Paula Raymond, West Hollywood: opposed to the project. Richard Maggio, West Hollywood: support the project.

Bob Leeds, West Hollywood: Opposed. Invasion of neighborhood rights.

Sybil Zaden, West Hollywood: The neighbors on Horn voted unanimously to support the structure.

David Weissfeld, West Hollywood: Support the structure. Kyle Bradshaw, West Hollywood: Support the structure.

Mr. Jeffries, appellant, gave his rebuttal and stated that his concerns are greatly answered if they do what they say they will do, such as internal cameras. Would like them to also look into the possibility of rounding the building to protect the next door neighbor.

Bruce Monahan: rebuttal for applicant, architect for Tower. There has been no stronger critic than City staff. Made sure we addressed the problems of neighborhood. Garage internally ramped. Tower has been a responsive client. Strongly support.

No one else coming forward to speak, Mayor Lang closed the public hearing and returned this item to the Council for discussion.

Councilmember Heilman stated, for the record, that he had visited and inspected the site. He asked staff to work with the applicant to deal with the set-back area security issue. Also, put the requirement for security cameras in writing. Would like to allow them to use the front of the structure for posters, art, etc., on approval of staff. Discuss bathrooms on the site with developer, but not make a condition of approval may not be feasible. Would like to see access to the structure on Horn. Staff directed to look at the question of making it rounded, with the applicant, in the interim.

Lucy Dyke stated that it's possible to approve the structure as it is and see how it goes; and could then change later.

ACTION: Close the public testimony period and continue the matter over to the first meeting in March for the adoption of the Resolution. Motion Heilman second Land. Hearing no objection it was so ordered.

6. RESOLUTION ESTABLISHING FEES FOR THE TOWING OF TAXICABS: REMOVED FROM THE AGENDA AT REQUEST OF STAFF; NO FURTHER CONTINUANCE.
