PUBLIC HEARINGS

3. COMMUNITY FACILITIES DISTRICT: Report on noticing by City Clerk. No written protests were filed when called for by the Mayor. Staff report by Debbie Potter. Mayor Koretz opened the public hearing and the following person came forward to address the Council:

Mike Radcliffe, West Hollywood - problems with Mello-Roos

No one else coming forward to speak, Mayor Koretz closed the public hearing and returned this item to the Council for discussion.

Councilmember Heilman clarified that this is only an assessment on buildings needing seismic retrofitting who have chosen to join the district and participate in the program.

Adopt Resolution No. 975, "A RESOLUTION CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD FOR FORMATION COMMUNITY FACILITIES DISTRICT, AUTHORIZING THE LEVY OF A PRELIMINARILY ESTABLISHING SPECIAL TAX THEREIN, AN APPROPRIATIONS LIMIT AND SUBMITTING LEVY OF THE SPECIAL TAX AND THE ESTABLISHMENT OF THE APPROPRIATIONS LIMIT TO QUALIFIED ELECTORS THEREOF; and 2) adopt Resolution No. 976, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLYWOOD DETERMINING NECESSITY TO INCUR BONDED INDEBTEDNESS WITHIN COMMUNITY **FACILITIES** DISTRICT AND SUBMITTING PROPOSITION TO THE QUALIFIED ELECTORS THEREOF; and, 3) adopt Resolution No. 977, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD CALLING A SPECIAL ELECTION WITHIN COMMUNITY FACILITIES DISTRICT NO. 92-1; and 4) adopt Resolution No. 978, "A RESOLUTION OF THE CITY COUNCIL OF CITY OF WEST HOLLYWOOD APPROVING THE NEGATIVE DECLARATION FOR THE COMMUNITY FACILITIES DISTRICT NO. 92-1 (SEISMIC UPGRADE PROJECT)." Motion Heilman second Lang. Hearing no objection it was so ordered.

4. APPEAL OF CONDITIONAL USE PERMIT 91-23, ALLOWING THE OFF-SITE SALE OF ALCOHOL AT THE 7/11 CONVENIENCE STORE AT 7609 SANTA MONICA BOULEVARD: The staff report was given by Anne Browning. City Clerk reported on noticing. Mayor Koretz opened the public hearing and called on the appellant to speak. No one came forward. Mayor Koretz then called on the applicant, Donny Cacy, 7/11, who spoke in favor of his application and against the appeal.

Carol McKay, West Hollywood - in favor of 7/11 - against appeal.

Carole Cooper, West Hollywood - question about conditions. Andy Harland, West Hollywood - in favor of 7/11 - against appeal.

Sylvia Feldman, West Hollywood - against appeal.

Thomas Crail, West Hollywood Chamber - against appeal.

Rick Zamarripa, West Hollywood - against proliferation of alcohol outlets in this area.

Mark Heinemann, West Hollywood - East End Community Action Committee has opposed liquor licenses but support this for their friend.

Donna Saur, West Hollywood - support Dony Casey, 7/11.

Arthur Colten, West Hollywood - support 7/11 but against more liquor licenses.

Angela Martines, West Holywood - support appeal.

Raynard Davis, West Hollywood - not allowed in store since he spoke against the license.

Jeanne Dobrin, West Hollywood - oppose proliferation of liquor licenses.

Rachelle Sommers-Smith, West Hollywood - against appeal.

Michael Williams, West Hollywood - against appeal.

Robert Davis, West Hollywood - oppose appeal.

Peter Gaeser, Los Angeles - oppose appeal.

Mary Erickson, West Hollywood - oppose appeal. Fred Mashian, West Hollywood - (Golden Rule) falsifying of evidence - do not sell to minors. Issue regarding the area not Donny Cacy.

Farnoush Ranibari, West Hollywood - 7/11 good store but not in favor of the license.

No one else coming forward to speak, Mayor Koretz closed the public hearing and returned this item to the Council for discussion. Staff reviewed the conditions approved by the Planning Commission.

The City Attorney stated that a conditional use permit with the land, it is not issued to the individual. control is by a time limit on the CUP and a review process.

ACTION: Uphold the Planning Commission approval the permit and adopt Resolution No. 979, "A RESOLUTION THE CITY OF WEST HOLLYWOOD COUNCIL OF THE APPROVING CONDITIONAL USE PERMIT 91-23, ON APPLICATION OF THE SOUTHLAND CORPORATION, DBA 7-11 STORE, FOR APPROVAL FOR THE SALE ALCOHOLIC BEVERAGES FOR OFF-SITE CONSUMPTION ON PROPERTY LOCATED AT 7609 SANTA MONICA BOULEVARD, WEST HOLLYWOOD, CALIFORNIA." Motion Land second Lang. Hearing no objection it was so ordered.

Mayor Koretz called a recess at 9:40 p.m. The meeting was reconvened at 9:50 p.m.

COUNCILMEMBER COMMENTS: This portion of the meeting was set aside for general comments, announcements, requests of staff, and/or other issues of concern from members of the City Council.

Councilmember Guarriello stated that the homeless were moving back into the park with their bedrolls. Direction was given

to enforce our no-camping law.
Councilmember Land stated that many City employees work with the Red Cross and wants the City Manager to work with them to ensure their training can be used in this trying time.

Mayor Koretz stated that there should have been people answering the phones at City Hall on Friday. He also commented on the peaceful protest march on Thursday night.

The East End Revitalization Task Force should include Mike Radcliffe. Councilmember Heilman objected as he felt that staff had come up with a very balanced group that have been working in the process and this balance should not be upset. The City Attorney stated that this item would have to be agendized for a vote if the Council wants a change.

UNFINISHED BUSINESS

MANAGEMENT/SHARED PARKING PARKING PILOT PROGRAM: Councilmember Land and Joan English gave the staff report and answered questions. Councilmember Heilman asked why this was not considered during budget time. Councilmember Guarriello asked why the Transportation Commission bypassed. Councilmember Lang felt it could be a worthwhile pilot program. The following persons came forward to address the Council:

Mike Radcliffe, West Hollywood Community Alliance -\$31,000, Hoffman and Associates contracted to do a larger job and they are experts. Opposed to this item.

Gloria Vassy, West Hollywood - objection to staff and others

talking at side of room. Opposed to this item. Thomas Crail, Chamber of Commerce - fund set up to parking needs.

Jeanne Dobrin, West Hollywood - Wants to see copy of Opposed to item.

April Franklin, West Hollywood - good short term solution. Gene Tolegian, Tango Grill - we need parking spaces in the City.

Barbara Kowalski, Stella's Cafe - in favor of this item. Michele LeChasseur, West Hollywood, Manager of Rage favor of this item.

Christopher Welch, 6 Gallery Coffeehouse - support.

Councilmember Heilman stated that this looked like the proposal, no reduction in cost, not in budget, fund was set aside for creation of new parking. How justify use of that Joan English stated that all increased parking meter money was directed to creation of parking spaces, but there was other money in that fund that was not constrained. The question was also asked why some of this work being done by present Transportation Department staff. Councilmember Land stated that with the high cost and scarcity of land, it may take a combination of many endeavors to achieve more parking. Some Councilmembers stated that much of this proposal could and should be done by staff.

RECOMMENDED ACTION: Approve the West Hollywood Chamber of Commerce low-cost Parking Management Program and direct staff to prepare a contract conforming to the Chamber's proposal and authorize the City Manager to sign the contract. Motion Land second Lang.

AMENDMENT TO RENT STABILIZATION ORDINANCE REGARDING DEPARTMENT INITIATED HEARINGS: RECOMMENDED ACTION: Introduce on first reading, Ordinance No. ___, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE REGARDING ADMINISTRATIVE HEARINGS INITIATED BY THE RENT STABILIZATION DEPARTMENT."
