PUBLIC HEARINGS

DESIGNATION OF THE HARPER AVENUE DISTRICT AS AN HISTORIC DISTRICT AND CONSIDERATION OF TWO APPEALS REGARDING 1320 AND 1338-52 HARPER AVENUE: Mayor Koretz opened the Public Hearing and John Jakupcak and Amy Anderson gave the staff report. Councilmember Heilman asked about why staff is not having one-on-one meetings with the property owners. Anne Browning stated that because of the large number of properties, conducted community meetings. The following persons came forward to testify:

Boyd Willat, appellant - does not show a progress development. Opposed to the designation. Walter Johnson, appellant - 1320 Associates - CHAB and the

Planning Commission stated prior to this that this building had no historical value. Opposed to designation as contributing buildings.

Michael Szymanski, West Hollywood - consider an EIR.

David Cameron, Santa Monica - investigated and found that N. Harper was the original building.

Luther Davis, West Hollywood - brought pictures taken from windows of the apartments showing all the trees and vegetation. Jenifer Bassey, West Hollywood - original house of L-shaped courtyard. Important building.

Phil Curtis, West Hollywood - need historical context -

support.

Thomas Jones, West Hollywood - support approval.

Jamie Wolf, West Hollywood Conservation League - support approval of the district.

Kevin Lucas, Los Angeles - support designation the districts. (people in audience stood to show support). Greg Spenser, owner of 1320 N. Harper - structure not meant to stand forever. Incentives not enough.

Paul Hanchett, West Hollywood - support for district.

Stephen Wielage - waive speaking - support.
Karvn Isaacs - waive speaking Robert John Pierson, West Hollywood - people on the walking tours ask about 1320 Harper. support for designation and district.

Sabin Gray, West Hollywood - Board member speaking in support as a resident.

Walter Johnson and Boyd Willat, developers, spoke in rebuttal and explained the mistake in the document, and spoke about the inadequacy of the incentives. They spoke about the proposed development on 1320 N. Harper.

Mayor Koretz returned this item to the Council for discussion.

ACTION: Deny the appeal of Sophie Friedman (1338-52). Motion Heilman second Land.

AYES: Guarriello, Heilman, Land, Mayor Koretz

NOES: Lang Motion carried.

PROPOSED ACTION: Deny the appeal of 1320. Motion Guarriello. Died for lack of a second.

PROPOSED ACTION: Grant the appeal of 1320 and approve the remainder of the district. Motion Heilman. Died for lack of a second.

FURTHER ACTION: Approve the designation with the exception of 1320 and grant the appeal of Boyd Willat/Walter Johnson. Motion Heilman second Mayor Koretz.

AYES: Heilman, Lang, Mayor Koretz NOES: Guarriello, Land

Motion carried.

Mayor Koretz called an intermission at 9:05 p.m. The meeting was reconvened at 9:20 p.m.

DESIGNATION OF THE COURTYARD THEMATIC DISTRICT AS AN HISTORIC DISTRICT AND APPEAL OF DESIGNATION RECOMMENDATIONS FOR PROPERTIES LOCATED AT 1275 HAYWORTH, 1414 1/2-1418 HAYWORTH, 819-25 1/2 SWEETZER AND 1233-39 SWEETZER:

John Jacupcak gave the staff report. Mayor Koretz opened the public hearing and the following persons came forward to testify:

Mark Lehman, representing owners of 1414 1/2 - 1418 Hayworth -

criteria does not apply to these buildings. This is courtyard housing but is not a unique building and lacks any architectural merit or detailing.

Israel Eisenberg, 1238-1248 N. Havenhurst -opposed - son David spoke for him and voiced his objections. There has been no communication between the City and the property owners of the designated properties. Wants to know what this will mean to his income.

Paul Leonard, Los Angeles - 1275 Hayworth - opposed. Property owners and City should develop Cultural Heritage list.

Edna Rodriguez, representing Kent Investment - Mrs. Crown - owner opposed. 84 years old and feels rights are being violated.

Sue Patton, spoke in support of Mrs. Crown, 1233-39 Sweetzer. Jeanne Dobrin, West Hollywood - improper for Board members to address the Council on how they made their decision.

Janice Martinez, works for owner of 1414 1/2 - 1418 Hayworth - opposed, buildings have deteriorated, garages are collapsing Robert John Pierson, West Hollywood - need to look at whole thematic grouping - courtyard housing and years built.

Mayor Koretz returned this item to the Council for discussion.

Robert Eilbacher, owner of 819-825 1/2 Sweetzer - opposed. Old structures, maintenance is killing him. Taking property without due compensation.

ACTION: Continue public hearing open and defer action on those with objection to first meeting in February. Approve those not objected to this evening. Includes direction to staff to meet with individual owners, brainstorm on senior citizen or disabled problems and added incentives. Motion Heilman second Land.

AYES: Heilman, Land, Lang, Mayor Koretz

NOES: Guarriello

UNFINISHED BUSINESS

5. APPEAL OF DENIAL OF CREATIVE SIGN PERMIT 91-02 FOR A CREATIVE SIGN IN THE PARKING LOT AREA OF TOWER RECORDS, 8801 SUNSET BLVD., BY SOLBROOK DISPLAY CORP.: The staff report was given by Anne Browning. The following persons came forward to address the Council:

Berta Pat Solomon - Solbrook Display Corp - N. Hollywood - appellant. There was a lack of communication at Planning Commission. This is an artistic, creative sign and turns every five to ten minutes, not every three, and is not visible from Sunset.

Jeanne Dobrin, West Hollywood - What document was handed to the City Council? Sign does not meet the criteria. Uphold the Planning Commission.

Ms. Solomon stated the signs would be on tempered masonite, designed for outdoors.

ACTION: Grant the appeal. Motion Mayor Koretz second Heilman.

AYES: Heilman, Land, Lang, Mayor Koretz

NOES: Guarriello Motion carried.

PROTECTION AND BUSINESS REGULATIONS: Anne Browning gave the staff report asking that catering trucks and peddlers be treated differently. Jeanne Dobrin, West Hollywood addressed the Council on the conditions outlined in the staff report and the use of horns. ACTION: Direct the City Attorney to prepare an Ordinance containing the necessary code amendments to permit vending on the public highway under certain limited conditions. Motion Heilman second Land. Hearing no objection it was so ordered.

NEW BUSINESS

7. PROPOSALS FOR STREAMLINING THE PLANNING AND PERMITTING PROCESSES: The staff report was given by Mayor Koretz.

The following persons came forward to address the Council: Thomas Crail, Chamber of Commerce - support and will work with staff. Expand this idea to all Departments in the City.

Lester Hirsch, West Hollywood - certain businesses discourage other businesses - signage is important.

ACTION: Direct the Department of Community development to review the current planning and permitting processes, in conjunction with an ad hoc committee made up of members of the business community, to determine where the City can implement simplified and more expedient procedures. This review should include an examination of effective processes used in other cities. Recommendations should be brought to Council within 60 days. Motion Heilman second Lang. Hearing no objection it was so ordered.

8. PROPOSAL TO CREATE A SPECIAL REWARD ACCOUNT FOR INFORMATION LEADING TO THE APPREHENSION OF PERSONS ENGAGING IN HATE CRIMES AND OTHER TYPES OF WILLFUL MISCONDUCT: Mayor Koretz gave the staff report. The following persons came forward to address the Council:

Morris Kight, Los Angeles - pull back and take a longer harder look at acts of violence. In favor of looking at all methods. Stan Lothridge, West Hollywood - too narrow and focused. John Ferry, Los Angeles - officers' sensitivity training instructor. Reward system can make short term sense. Work in concert with other groups and agencies.

Mayor Koretz read a letter in support from the West Hollywood Sheriff's Department, Captain Chapman.

ACTION: Direct staff to develop and return to Council with a package, including education, reporting, and the following:

- 1) Approve the establishment of a special reward account to be funded during the 1992-93 fiscal year at a level of \$15,000 with a maximum allotment of \$5000 per individual per case. Subject to a particular event or series of events and upon adoption of an appropriate Resolution, the Council can draw upon the fund to offer a reward in exchange for information. 2) Direct staff to analyze the best manner of implementation and to make recommendations governing the maintenance of the trust fund. 3) Direct the Sheriff's Department to compile and maintain current statistics on gaybashing incidents both solved and unsolved and to make such information readily available to the City Council. Motion Heilman second Lang. Hearing no objection it was so ordered.
- 9. RESOLUTION SUPPORTING NATIONAL LEGISLATION CALLING FOR REREGULATION OF THE CABLE INDUSTRY: Ian Tanza gave the staff report and the following persons addressed the Council: Rick Zamarripa Experiences with the cable company not good. Jeanne Dobrin, West Hollywood: Encourage letter writing campaign.

ACTION: Adopt Resolution No. 919, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD SUPPORTING NATIONAL LEGISLATION CALLING FOR REREGULATION OF THE CABLE INDUSTRY"; Initiate a public awareness campaign to inform the community of current cable television legislation pending in Congress; encourage cable consumers to contact their federal representatives to express their experiences and opinions. Direct the City Clerk to send copies of this resolution to other Cities and urge them to join in. Motion Heilman second Land. Hearing no objection it was so ordered.

CITIZEN COMMENTS: This time has been set aside for the public to address the Council on any item of interest that could not be heard under Item 1 at the beginning of the meeting. Stan Lothridge - Resent Heilman's distortion of what I said about prostitution. Waste Management Corp. Rick Zamarripa - Enough people are not given credit for the jobs that they do. I am a very happy gay man in the City of West Hollywood. What constitutes a prostitute or a loiterer? I want to go on record commending John Heilman for working for the gay members of the City.

COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or the public on any and all matters of interest.

Mayor Koretz corrected Stan Lothridge's statement under Citizen Comments regarding Councilmember Heilman and Waste Management Corporation.

 ACTION: To adopt as an urgency ordinance, Ordinance No. 319U,

 Motion Heilman second Lang. Hearing no objection it was so ordered.
