## CITY COUNCIL MINUTES STUDY SESSION ON THE BUDGET

## TUESDAY, MAY 28, 1991 WERLE BUILDING 626 N. ROBERTSON BLVD.

6:00 P.M. - CITY COUNCIL DISCUSSION REGARDING THE PROPOSED BUDGET AND WORK PLAN - FISCAL YEAR '91-92.

Mayor Heilman called the meeting to order at 6:08 p.m.

The Pledge of Allegiance was led by Councilmember Land.

PRESENT: Guarriello, Lang, Land, Koretz, (Councilmember Koretz arrived at 6:15 p.m.) Mayor Heilman

ALSO PRESENT: City Manager Brotzman

City Manager Brotzman reported that the budget in front of the Council was almost in balance and he outlined suggested cuts and revenue increases to the Council as follows:

Mr. Brotzman further reported that after these adjustments,

it was discovered that a further \$250,000 in cuts needed to be made and a list of further proposed cuts and revenue enhancements was distributed to the Council.

The following persons gave the Department reports: Bob Edgerly, Assistant City Manager; Kay Jimno, Department of Administrative Services; Gay Forbes and Anne Browning, Community Development; Lloyd Long, Human Services; Pat Jordan and Nancy Greenstein, Sheriff's Department; Marney Hull, Rent Stabilization Department; Joan English, Transportation Department.

Discussion was held on a policy on conferences for Commissioners, a fee increase on trash collection, an increase for the Sacramento lobbyist, a year-round aquatics program, the costs of Simonson litigation, and money for information mailings.

In response to questions, the City Manager reported that there is \$1,656,000 in new Capital Projects and \$2,878,000 in existing projects for a total of \$4,534,000. The Firehouse and City Hall funding are not included in this budget - if needed, would be handled through debt financing.

A public hearing on the budget will be held on June 10, 1991, at 7:30 p.m.
