## MINUTES CITY COUNCIL MEETING MARCH 18, 1991 WEST HOLLYWOOD PARK 647 N. SAN VICENTE BOULEVARD

**6:00 P.M. - CLOSED SESSION:** Mayor Heilman announced that the City Council met in closed session to discuss matters pertaining to litigation, potential litigation and personnel and direction was given to staff.

6:30 P.M. - STUDY SESSION: This time has been set aside for staff to answer questions from Council about Consent Calendar items on the agenda. There was no study session held at this meeting.

7:00 P.M. - REGULAR MEETING

CALL TO ORDER: Mayor Heilman called the meeting to order at 7:20 p.m.

PLEDGE OF ALLEGIANCE: The Pledge was led by Andy Haenfler.

APPROVAL OF AGENDA: Item 2n was tabled; items 2i, o and r were removed for separate discussion. By consensus of the Council.

PROCLAMATIONS AND COMMENDATIONS: Tonight's meeting will be adjourned in memory of Bill Gazzarri. Congratulations to Paul Koretz on the birth of his daughter.

TREASURER'S REPORT: Jonathon Ahearn gave the treasurer's report for the month of February.

CITY MANAGER'S REPORT: This time has been set aside for the City Manager to report to the City Council on any or all matters of importance. Mr. Brotzman reported on the delinquent Transient Occupancy Tax, on which the City has collected at least 60% of the total owing. He reported on code enforcement and on the proposal of Beverly Hills to tap the ground water and put in their own treatment plant. He further reported on the computerized service request system in West Hollywood.

- g. Approval of Position Specifications: Intern; Lifeguard; Pool Manager; Recreation Aide; Swimming Pool Locker Room Attendant: ACTION: Approve specifications for the temporary positions of Intern, Recreation Aide, Pool Manager, Lifeguard and Swimming Pool Locker Room Attendant.

- h. JFS Contract Extension: ACTION: Authorize the City Manager to execute an amendment to Contract No. C-0066 to continue the Jewish Family Services Transportation Program from April 1, 1991 through September 30, 1991, at a maximum payment of \$75,735. Approved as part of the Consent Calendar.
- i. Proposed Fixed-Route Shuttle Service: REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. Lucy Dyke gave the staff report and replied to the concerns of Mayor Heilman as to the proposed route and the nighttime discontinuation to the parking lots. ACTION: Table this item for 2 weeks for more work on the demand response system, the route, and nighttime service. Motion Mayor Heilman second Lang. Noting the objection of Guarriello it was so ordered.
- j. Request to Solicit Bids for Shuttle Vehicles:
  ACTION: Authorize staff to issue vehicle bids for potential citywide shuttle service. Vehicle type should be a ten passenger,
  gasoline operated, light duty van with a low step and wheelchair
  accessibility. The City may lease the vehicles from a municipal
  leasing firm and sub-lease them to the contractor.

- k. Award of Contract for Business Registration Computer Program: ACTION: Authorize the City Manager to enter into a contract with Tom Rettig Associates for a business registration computer program in an amount not to exceed \$8,000. Approved as part of the Consent Calendar.
- 1. Awarding of Contract for Audit Services: ACTION: Award the contract for audit services to Lance, Soll and Lunghard, CPA's, for contract price of \$28,570. Approved as part of the Consent Calendar.
- m. The Annual Audit: ACTION: Accept the audited financial statements for year end June 30, 1990, and receive and file.

  Approved as part of the Consent Calendar.
- n. Hearing Examiner Job Description and Reclassification: RECOMMENDED ACTION: Approve the description for the position of Hearing Examiner and the reclassification of that position from GE-15 to GE-16, retroactive to July 1, 1990. THIS ITEM WAS TABLED ON APPROVAL OF AGENDA.

- o. Harris and Associates Task Order for Pavement Management System Update: REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. Joan English, Director of Transportation gave the staff report and stated this project could be brought in-house but it will be at least 4-6 months after the hiring of the City Engineer. Jeanne Dobrin, West Hollywood, addressed the Council on this item. ACTION: Authorize the City Manager to execute a task order with Harris and Associates for \$11,500 for the update of the Pavement Management System. Motion Guarriello second Lang. Noting the objection of Land it was so ordered.
- p. Award of Informal Bid for Purchase of a New Vehicle: ACTION: Award the purchase of one (1) Ford Tempo in the amount of \$9,010.03 to Folsom Lake Ford of Folsom Lake, CA. Appropriate \$9,010.03 from the undesignated general fund balance for this purchase.

  Approved as part of the Consent Calendar.
- q. Award of Contract for Hart Park Improvements Project CIP #162: ACTION: Accept the bid dated March 14, 1991, submitted by Jonathan Development Co., Inc. in the amount of \$622,500, in response to contract plans and specifications for the Hart Park Improvements project CIP #162; reject all other bids; and authorize the City Manager to sign the contract. Approved as part of the Consent Calendar.
- r. Adult Day Health Care Center (CIP #972): REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. The staff report was given by Alan Pyeatt. Jeanne Dobrin spoke to the Council on this item. ACTION: Authorize the City Manager to amend the contract with B.G. Kim Construction, Inc., to increase it by \$13,112.97 and extend the completion date to provide for the change orders. Further, authorize the City Manager to approve incidental change orders not to exceed \$10,000 total, if needed for completion of this renovation. Motion Land second Koretz. Hearing no objection it was so ordered.
- s. Temporary Use Permit for Oscar Party at Mondrian Hotel, 8440 Sunset Blvd.: ACTION: Approve the temporary use of the patio for entertainment purposes subject to the following conditions which will be added to the temporary use permit for the event:
- 1) The volume of the entertainment be lowered at 10:00 p.m. to a level which is acceptable under the Noise Ordinance; 2) Any complaints regarding noise generated by outdoor entertainment after 10:00 p.m. shall be addressed immediately; 3) The sound engineer shall be available to code enforcement prior to, on the day of, and during the event to discuss acceptable sound buffering techniques and location of any speakers and noise concerns; and 4) All entertainment in the patio area shall cease at midnight. Approved as part of the Consent Calendar.

3. ADJUSTMENT TO MELROSE/ALMONT NEIGHBORHOOD TRAFFIC PROJECT:
The City Clerk reported that this item was published in the Post
Newspaper and posted at the three required places plus at City
Hall. Joan English and Mr. Williams gave the staff report and
requested that the Council take public testimony and continue this
item open to the meeting of April 15, 1991. Mayor Heilman opened

Mayor Heilman asked if a review had been done on the cul-de-sac. Director of Transportation replied that it had not and they would like the closure of the alley done prior to the evaluation. Mayor Heilman asked how the closure of the alley would affect the businesses located there. Mr. Williams stated that there was access from the alley and Melrose. ACTION: Continue this hearing open to the meeting of April 15. Direction was given to staff to meet with the business people in the area. By consensus of the Council.

City Attorney Jenkins stated that it was his opinion in the staff report, not that of any of the Councilmembers or staff. It is not a black and white issue with lots of case law. It is a balanced opinion and is up to the Council to make a decision based on all of the evidence. What is disappointing is just how low people will go in challenging an issue.

Councilmember Koretz stated that he had watched all of the testimony on TV while he was home checking on his family. He is in favor of Head Start and it being located at the park but he feels it violates the law.

Councilmember Land and Mayor Heilman feel this is not in violation of the law and is consistent with the intent of Prop B.

ACTION: Deny the appeal and uphold the Planning Commission's approval of the request subject to the findings and conditions of the proposed resolution, and to adopt Resolution No. RESOLUTION OF THE CITY COUNCIL OF THE CITY WEST OF HOLLYWOOD DENYING THE APPEAL OF AND UPHOLDING THE PLANNING COMISSION'S APPROVAL OF DEVELOPMENT PERMIT 90-49 AND A NEGATIVE DECLARATION ON AN APPLICATION OF THE CITY OF WEST HOLLYWOOD HUMAN SERVICES DEPARTMENT TO PERMIT THE CONSTRUCTION OF A TEMPORARY CLASSROOM BUILDING FOR THE HEAD START PROGRAM IN PLUMMER PARK, 7377 MONICA BOULEVARD, WEST HOLLYWOOD".
